Thanksgiving for a Bountiful Harvest by Mary Williams

A story begins when we're stretched beyond our comfort level. That year, 2015, offered me just that. It was a year of pain, minor back surgery and a slow path to healing and recovery. I've always had good health and experienced very little pain. Now I have more of an insight into others' who bear up under far worse, persevering and pushing themselves to get up every day and put one foot in front of the other, continuing to get past the pain and to live their lives to the fullest. Looking back I was fortunate and I am grateful for all those who encouraged me during my recovery. After the Dr. said it was ok to do so, and that it would be good for my back, they pushed me to start practicing with my bow, start shoot tournaments, and preparing for the 2016, hunting season.

As I look back over 2016, I am so grateful to God for my complete recovery that allowed me to continue hunting with my husband, EW (Earl Williams) and to accompany him on our annual hunts with friends and family in Arizona for Javelina, in California for turkey and deer near Julian, then for Elk and Mule Deer in Utah. Our first hunt this last February was to the San Carlos



Apache Reservation for the Javelina Archery Season. This hunt is something that my accomplished bowhunting husband has been doing for over 40 years. However, it was just my 13th year to chase javelina. We met up with our friends Bob and Patti King and our dear friend Mark Houston, all from Chino Hills, CA.

For those who do not know, The Apache Reservation is huge!! We drove many miles every day of the hunt. One of those days we were heading into the backcountry, passing rocky hillsides with cactus where Javelina are likely to bed and feed. One of the habits I've learned while keeping an eye out for wild game is to look back at the areas we had just passed through as I often spot animals moving and this is exactly what happened as we were driving around. Approximately 150 yards from the road, back to my right amongst the rocks, cactus and juniper trees I saw J-A-V-E-L-I-N-A! "I got pigs" I cried out to our crew. We stopped, grouped together and made a plan.

I hope all of you had a Merry Christmas and most importantly I hope you were able to celebrate Christmas and or the Holidays with your family and friends. With any luck you got everything you wanted however I did hear there was a Christmas shopping rush, by some of our spouses, to buy chunks of coal. I hope that was just a rumor and none of you received coal in your stocking albeit some of us deserved only that. LOL In just a couple of days we will be celebrating the beginning of the New Year... 2017!!! As unbelievable as it sounds this year will bring new milestones to all of us but for some of us old farts these milestones that always seemed to be held in abeyance in the very distant future are now here. They are upon us and our bodies, hair, wrinkles and stamina are all showing the wear and tear from the number of milestones we have left in the dust. In earlier times, we bound over those milestones with ease but not so much bounding now. Now it's more like crawling over those milestones just hoping that we get to the next one before the legs give out and cramps set in. All that aside I hope you had a wonderful New Year's celebration and may 2017, bring only the very best to each and every one of you. Happy Belated New Year!!!! As you read this the CBH/SAA Annual Meeting will be history as it will be held on January 13th, 14th and 15th. Much will have been discussed and many decisions made. State Tournaments will be set and the Big Game Club and the Small Game Club events will be scheduled and set. Your input at the Local Club and Regional Levels influence everything that is accomplished at this meeting. This is the only way CBH/SAA can work and your input is invaluable. So your participation in your Local Club's events and meetings is a must if the club is to exist as a member driven organization. Stay involved or get involved! On December 7th and 8th Legislative Team Members Chriss Bowles, Bill Gaines of Gaines and



Associates, and I attended the California Department of Fish and Game (DFG) Commission meeting in San Diego. The first day was of great concern to us as there was a petition put before the Commission to make it illegal to bowfish for sharks and rays. As usual, the argument in favor of the petition and against bowhunters and bowfishermen was baseless. However, with no objection to the petition as submitted, it could have had a huge negative impact on bowfishing in the ocean waters and bays along the coast of California as the Commissioners could be swayed by their one sided discussions. The petition leads the reader to believe that the "army of bowfishermen" were causing a huge and devastating impact on the shark and ray populations. Additionally, the petition and the arguments in favor of the petition, stated that it should be illegal to chum for shark because it is illegal to bait wildlife while in the process of hunting, therefore, it is "unethical". The last argument in favor of the petition is that unlike fishing, there is "no catch and release"! My objections and counter arguments against the petition were simple, to the point and logical.

First, addressing the "army of Bowfishermen", I informed the Commission that there is less than 100 bowfishermen that pursue sharks and rays in California and those that do only bowfish for sharks and rays one or two times a year. That's when I first got the attention of the Commissioners. Now, even though there are only a few that bowfish for sharks and rays, we can't allow bowfishing for sharks and rays to be taken from us as that is NOT where the antis... the predators will stop. We are the elephant and the predators that think they must control any and all things that they don't like to do, or enjoy themselves, are doing their best to eat us one bite at a time. For example, I don't own a one ton diesel pickup nor do I own a 20 pound 50 caliber semi-auto, tripod mounted rifle and I never will, but both are legal for a law-abiding citizen to own and use and there is no reason... ever... that will cause me to agree with those that want it to be illegal for the law-abiding citizen to own either of these items and allow them to take that right away from us. If you are a law-abiding citizen and you want to own the 50 caliber rifle or if you want to drive a 1 ton diesel truck then it is your LEGAL RIGHT to do so and you need to protect that right and the rights of other law-abiding citizens. Don't EVER agree with them on any issue as that will strengthen their assault on us and make our defense weaker. Once a bite is taken it is gone forever and the next bite will make the elephant weaker. I then addressed "chumming for ocean fish vs baiting for wildlife". Chumming for ocean fish is legal, ethical, and is an historic method of attracting fish. Current legal methods of attracting fish are by placing dead bait fish in a lobster or crab trap; dead ground up fish poured overboard to cause an oily, stink slick; or alive bait fish tossed overboard; or a bait fish or a worm on a single hook. Each of these methods attract predatory fish via its olfactory, auditory or visual senses and is NOT considered unethical or illegal. Likewise baiting wildlife has been utilized throughout history and was a legal and ethical method of attracting wildlife **UNTIL** it was found that baiting wildlife was the catalyst for entire populations of healthy wild animals being infected with communicable diseases. It was found that, at baiting sites, healthy animals, through direct contact with an infected animal(s), or healthy animals coming into contact with germs left behind by the infected animal(s) via their saliva, urine, or feces was the culprit. Therefore, some Fish and Game Departments

intervened, and made it illegal to bait wildlife in an effort to keep our wildlife populations healthy. Since then most people including our wildlife managers and enforcement officers, have forgotten, or they never knew, why the law was enacted. They now think that the baiting law is based upon it being unethical rather than a health concern to protect wildlife.

The last fallacy inferred by the petition and arguments for the petition is that "bowfishing is **NOT** a catch and release sport". I respectfully disagreed with the petitioner's concept and their lack of understanding of bowhunting and bowfishing. Hunting, bowhunting and bowfishing are all true catch and release methods and is the friendliest method of catch and release compared to any and all methods of take. For example, if I am hunting with a rifle, bow, or if I'm bowfishing, I MUST identify the animal or fish BEFORE I pull the trigger or draw the bow. If, upon identifying the target, it is exactly what I want to take home, I then pull the trigger or draw the bow and release the arrow. On the other hand if the target is NOT what I want to take home, I let it pass by without disturbing, injuring, stressing it, or causing it any harm what so ever. "That my friends is the ultimate method of catch and release"!!! We are a "catch and release" sport and don't ever let anyone tell you differently! My "Catch and Release" explanation caused smiles to appear on the faces of every one of the Commissioners.

When all was said and done the Commission made no decision on the petition and they sent it to the Department of Fish and Wildlife (DFW) for review. The legislative team and Gaines and Associates will keep an eye on the petition and we will be involved in the process prior to and during the final discussion.

As I always stress... we must remain one strong united family if we have any hope of fighting off the predators that are trying to destroy all outdoor sports.

Carrying my new Vortex Vipers bino's, Leupold rangefinder, Mathews Jewel bow, a Quiver full of Victory arrows topped with 75 gr. Wac'Em broadheads, pockets full of power bars, Sqwincher Electrolyte chews, beef jerky and water in my pack. I was ready to go! Keeping an eye on the area where we last saw the herd we maneuvered around until we had the wind in our faces then we carefully moved forward. We stalked in to 80 yards, 60 yards, 40 yards and then as crested the hilltop it was clear we had made a good stalk because there were pigs everywhere!! Bob cautiously moved in behind me and I motioned to him to look forward to the pigs just ahead. Then all of a sudden we busted a covey of quail and as they rocketed away they startled us both out of our skin.

Getting calmed back down, I surveyed the area in front of me and I found 2 pigs feeding, 20 yards away, just under a juniper bush. I ranged the pigs and got into shooting position, raised my Matthews Jewel, settled my 20 yard pin on the pig and released the arrow. An explosion of pigs and they went everywhere. I have no idea what I did or did not do during the shot but that pig did not come home with me. I motioned to Bob to move forward and he stealthily moved in on a huge sow and was able to get an awesome shot. That was an adventure!!

Adventures of 2016 continued on. Very early one morning in May EW and I rose at 4:30 am and drove to Julian, CA. for the spring turkey season. As we entered the private ranch, we came up a hill overlooking a meadow and saw a gobbler in full strut with to two hens. Wearing my H.E.C.S. (Human Energy Concealment System) under my hunting clothes, gloves, face mask and hat I ever so slowly approached the gobbler and shot it at 35 yards. The bird was down! I was so shocked. I looked at EW and said "Did you see that!" The gobbler didn't even know I was there. It looked in my direction once and then went back to strutting. A few days after returning home from the hunt I decided we would have wild turkey, mashed potatoes, stuffing and gravy for dinner the next day so I brined it for several hours and baked it. It was a delicious.

Getting ready for our Utah Deer and Elk hunt always begins in early summer with prepping vehicles, equipment and gear, so by mid-August we're ready for 30-40 days in the high country. Our son, Brian, daughter Melanie, friend's Bob King and Wayne Raupe joined us. We enjoyed fishing, ATV riding, setting up our tree stands and of course Melanie and Brian's good cooking. Melanie, Bob and Brian had to leave for home after the second week so it was just Wayne, EW and me for the next two weeks. We continued to pray for God's provision of opportunity, thanking Him that he always gives us opportunity. At 2PM on the 13th day of the hunt I once again climbed up into one of the tree stand where one of our trail cameras' had been regularly taking photos of elk passing through. After a short wait I began to hear what I thought was a bugle off in the distance. Up to this point I had never heard a real bull elk bugle in the wild. My only experience with hearing an elk bugle was on TV and other hunters bugling with the use of a diaphragm mouth call or a bugle tube. As I listened to the bugle in the distance I thought it was just another hunter bugling. So out of sheer fun and orneriness I picked up my Primos Hoochie Mama Elk Call, that mimics the sound of a cow elk mewing, and mewed back, multiple times. Every time I heard the bugle I would mew back. As time went on I realized the forest was filled with bugling and mewing. Within the hour I had a cow elk came walking in to my tree stand area. I waited for the cow to come in to 20 yards and quarter away from me. I pulled the 41lbs of my Matthews Jewel bow with Victory RIP arrows topped with 75 gr. 3 blade Wac Em broadhead, held steady, breathed, focused on my 20 pin to be sure I was holding steady and let go, making an accurate shot to the vitals. The cow ran 20 yards stopped, ran another 20 yards, wavered and was down within a couple of minutes.

I called my husband on my radio and told him I had a cow elk down and he said he would be there in about 20 minutes. As I waited in the tree stand I heard the bugle again and suddenly there he was, a real live bugling bull elk, the bull that I thought was another hunter. There he stood, just 35 yards in front of me, looking around and bugling. "Sorry Handsome" I whispered, an apology to him for not being the Cow Elk he was hearing and looking for. As majestically as he walked in, he left, holding his head high and bugling. WOW!!!

We are so blessed to experience the beauty of nature. From the loud thunder and lightning storms to sow bears with cubs to the amazing night sky covered with stars and constellations. Truly the heavens declare the glory of a good God and Creator. Only a good God can be the maker of this vastness beyond us and our little earth, reminding me He has a plan in motion. A few weeks after coming home from our Utah hunt I harvested my first California Pacific Hybrid Doe. It was an evening hunt and had been sitting in my tree stand since about 3PM. At about 5PM a group of doe's entered the meadow to my left feeding as they came. I ranged the closest doe at 43 yards but she was feeding slowly away from me. I realized if I was going to get this done I was going to have to do it soon. I ranged the feeding Doe again, now at 60 yards. I have been shooting targets out to 80 yards but I'd never taken this long of shot at an animal. I took a deep breath, saying to myself, I do this at 80 yards so this I know I can do. I had confidence in my equipment. I drew my bow and actually resting my left elbow against the tree behind me. Holding steady I held the sight pin on the Doe at 60 yards. The doe was quartering slightly away from me and OFF went that Victory arrow straight and fast with the Wac'Em broadhead finding its mark. The Doe kicked, sprinted 25 yards and tumbled over a quick and lethal kill. OOHH MY!! I can't believe it... she's down. The doe is down... I texted my husband and he said he was on his way. The venison we are enjoying now is so mild and the homemade jerky is delicious.





After experiencing back surgery and the recovery in 2015, I developed a deeper understanding and appreciation for those who keep getting up and going beyond their comfort level to follow their passions and in doing so they continue to "write" their life story. For this year 2016, my story is to give thanks to God in Heaven for healing, a year of bountiful harvest, memories with family and friends and the Gift of Jesus my Savior. I pray that you may know the goodness of God as He cares for you.





Record Year

June 14, 2016, started out like any other day at the office, but around noon, Dave called and asked me if I was sitting down. Over the next few minutes, he broke the news that not only had we both drawn our favorite California archery deer tags, but I had been lucky enough to draw an archery Likely Tables antelope tag, as well as an archery Owens Valley Tule elk tag. Once the screaming and victory laps around the office ended, we both got down to the business of research. I quickly realized that all three seasons were basically back-to-back in August and September, and had to make some tough decisions. I ultimately deemed it impossible to put forth the kind of effort respectfully due to all three tags, while preparing our eight-year-old for second grade, keeping my employer happy and Dave's business running, and we made the bittersweet decision to relinquish the antelope tag and reclaim the bonus points used to obtain it.

With our focus narrowed to our first hunt in the Owens Valley, Dave began doing what he does best...research. He spent weeknights scouring Google Earth and weekends learning back roads, meeting the locals, and glassing from any highpoint he could access. Along the way, Dave connected with a bunch of amazing people, landowners, utility-workers, fellow hunters, local hunting guides, friends of friends, etc., who helped us learn the lay of the land and formulate a plan of attack for my hunt.

Come August, we made base camp in a lonely Big Pine campground and settled in for the family adventure of the summer. Through our various scouting trips, Dave and I had made a "list" of top targets and settled on one monster bull to hunt opening morning. We put him to bed the night before, and on opening morning, flanked by a clutch crew of hunting buddies, we snuck in and started calling. Contrary to what normally happens with "hunting plans," this one actually worked and our monster came in on cue; only problem was that damn tree between him and me.

Throughout the next few sun-ups and downs, Dave and I had many heart pounding close calls with giant bulls. We crept through the lava in the midday sun, and waited patiently at 32 yards for a bull to stand, only to have a perfectly shaped rock block his entire vital zone. He never took that needed step forward, but instead blew out with the herd once their sixth sense of danger kicked in. With our crew glassing from afar, Dave and I belly crawled across a meadow, through spiky wildflowers and mud bogs to within 60 yards of a grazing bull and cow, only to have the wind change and a rushed arrow miss it's target low. Then, in what was one of my most heartbreaking moments of the hunt, we stalked into an area we nicknamed Jurassic Park for it's lush contrast to the stark windswept plain of the Owens Valley. Dave and I crested over the edge with our cow decoy, while our support team bugled from behind. And once again, the beautiful bull and his ladies slipped through our fingers with two more arrows missed low. Needless to say, this hunt was filled with enough heart pounding excitement, errors and missed opportunities to rival the final game of the World Series. The morning of our last full day in elk camp began in the same spot our beast had been on opening morning. Dave, Jack and I crept into a marshy spot and tried to sweet talk a mature bull we had heard in the distance. At first, it sounded as if he was headed our way, but he kept us at arm's length. Instead, two young bulls came to play and tempted me at 15 yards for a bit. Hoping for more, we regrouped and relocated south to the spot where my rushed arrow had missed low the night before. As luck would have it, we glassed up our bull, and this time he had company. After watching them bed in a thick patch of tall brush, Dave and I grabbed our packs and snuck in through the back door. We realized we weren't the only

ones hungry for a bull that morning when we crossed paths with a coyote on the way in. Thankfully, wide paths had been

trampled through the maze, which made our slow approach relatively quiet.

Knowing we were getting close, I knocked an arrow and Dave tucked in behind me. With another step, we heard some movement across the thinning vein of brush and the most beautiful antler tips came into view. The bull had stood up and was glancing around, but wasn't spooked. With the brush too thick to see through, we were confident he couldn't see us, so we crept sideways towards the clearing and only place I would have a shot, praying he might wander that direction. I snapped some ranges and made a mental map of the clearing; 38 yards to the other side, 15 yards to that tall tuft of grass. I anguished over the variety of shots I'd missed low and pondered whether adding yardage was the right thing to do. Then we waited. Dave's heart was pounding audibly, but mine was calmer than ever. Just as I decided that a wispy tree limb may pose a challenge and started moving left to take it out of play, the bull stepped out and stared us down through the limb's branches. Just as I feared, no shot. For several moments, it was just the bull and me. He'd take a step, I'd try to pull back, then he'd snap his head back and stare me down once again. Each time, he cleared that limb just a little bit more. Finally, with his vitals in clear view, he turned his head away just a bit, and I came to full draw. In an instant, I took aim and delivered an arrow exactly where I had aimed, just like one of those Shoot-N-C targets, only red.

The bull plowed out of the thicket and almost instantly, we heard our crew on the radio trying to figure out what had just happened. Through their binoculars, they had seen a bull running and by all accounts, he didn't look well. Those moments between making what you hope was a good shot on an animal and recovering that animal can only be described as a hot mess of exhilaration, self-doubt, thankfulness and anxious anticipation. As Dave and I sat there in the clearing, waiting an eternity that was likely only half that long, and hoping he was truly down, our nerves unraveled. We regrouped, mobilized our hunting crew, and the team trekked across the field to recover my bull. He was a beautiful non-typical 5X7 with character for days, with a perfect hole punched straight through both lungs. He was down within 70 yards.

Whereas filling a tag is the ultimate goal of any hunt, and we certainly accomplished that mission, our elk hunt also filled our souls. To us, the true measure of a hunt is in the fun and adventure of the process; it also means doing it as a family. Our daughter Jesey was always by our side, painting beautiful sunsets, eating all of the chocolate donuts and tormenting the "boys" who stayed back with her to glass. The eagle-eye crew we were lucky enough to have in camp bolstered my spirits when stalks were blown and arrows were missed. Together, we learned the area. And with each opportunity, we learned more about elk and how to perfect the craft of archery hunting. I look forward to the next time we can all pile into the truck, head to town and sing; Eric Church was right, "I owe you a beer for my record year."






