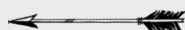

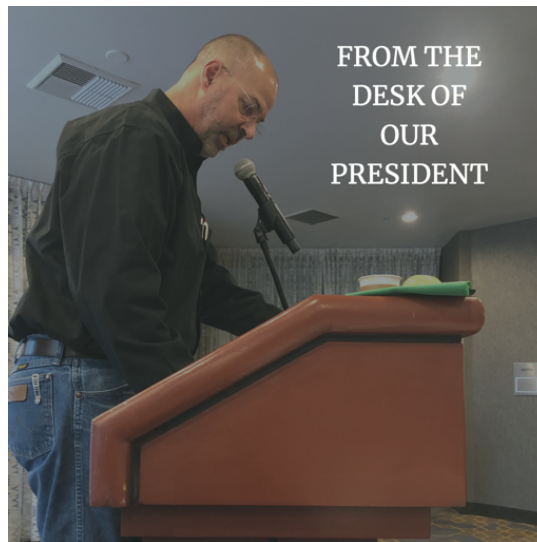
We again hosted the California State Traditional Archery Championship at Verdugo Hills Archery club in Southern California on the weekend of February 15th and 16th. CBH Vice President George Papac was the tournament director for this shoot and I know it was a success.

The California State Broadhead Championship will once again be held at Tejon Ranch in Lebec, California on the weekend of May 16th and 17th. This has been a very successful shoot and money maker for the CBH/SAA Big Game Club and we look forward to seeing everyone there. The classes and groupings will be the same as last year with Cubs shooting field points. This has been a fun destination shoot for many years and we want to continue the tradition so come on out.

The CBH/SAA State Field Archery Championship will be back up in Redding, CA this year on the weekend of June 13th and 14th. A huge thanks to The Straight Arrow Bowhunters for once again hosting this event. This will be full Field, Hunter and Animal rounds over 2 days. This is a beautiful range and a lot of fun to shoot.

I know all of the complaints about field archery, but it's a blast competing in this long and sometimes grueling event. It's a lot of arrows, but well worth the effort. I would really like to see a huge turnout for this flagshot Field Archery event.

The CBH/SAA State Marked Yardage 3D Championship will once again be held at Cougar Mountain Archery Club up near Oroville. A special thanks to Jim Clawson and his group for stepping up to host. Cougar Mountain is a beautiful club and everyone had great things to say about this shoot last year. CBH/SAA board voted to cut the piggyback shoot fee in half this next go around so don't let the cost scare you off this year. I know there was a lot of concern about the cost last year based on it being a piggyback shoot. We have really cut that down to a much more manageable number that should be fair for everyone. Oranco Bowmen committed to resurrect the old CBH/SAA State Unmarked 3D for 2020 and that will be held on Sunday June 28th. This will be a piggyback shoot on Oranco's Firecracker 3D

shoot that is held on that date every year. Oranco has plenty of camping and it should be a great shoot. Come on out for this one. We have not held the State Unmarked for quite a few years so it should be fun to get it going again.

We will need to wait a couple of months to finalize the list of host sites for the CBH/SAA State 900 Target Championship. I know Karen Keating is working to get the list finalized so you can start making plans now. As this is a multi-site tournament, I would re-iterate what I said earlier. Host clubs please make sure your tournament officials are adhering to the rules. I know Karen sends them out with every packet and they are available on line as well. Let's make sure the competition is fair for every shooter in the state.

Legislative Information

The next FGC meeting will be held February 20 and 21 in Sacramento. No agenda has been posted at this writing but mammal and waterfowl regulations ISOR was submitted in December. For mammal regulations the tag allotments won't be known until March. Adoption will be at their April meeting.

The next Wildlife Resources Committee will be held Thursday March 5th in Sacramento. The purpose of this meeting is to discuss 2020 Simplification of Statewide Inland Fishing Regulations proposal.

Recruitment, Retention and Reactivation (R3)

CDFW approved a R3 macro plan in early 2019. Stakeholder groups have been working within the macro plan to establish micro plans to be promoted as on the ground projects. Several organizations have implemented classes and hunts for new hunters/fishers, veterans and youth.

CDFW had an awareness campaign of their R3 program at the Sacramento International Sportsmen Expo (ISE) January 17 – 18. Approximately 23 booths participated with their prospective actions and programs within the R3 effort. Think of it as a scavenger hunt, new potential hunters/fishers can navigate through the Expo to the various participating booths concluding at the CDFW booth to receive an outreach bag.

CBHSAA participated by talking about the organization, promoting what we do and shoot a few arrows if they had not shot archery before. Friday session had Robert Williams, Chriss Bowles and I manning the booth and spoke to a dozen persons who specifically haven't been involved with archery. Saturday and Sunday sessions had Chriss, Robert, Richard English and I in attendance.

Legislation 2019/2020, below is a list of bills within the state legislature that we continue to track and providing comment on. These bills have until the end of 2020 to complete or they die. New legislation could be introduced but have to complete by the end of the year or they will also die. This is just a partial list of bills in the state legislature that could affect sportsmen. January 24th was the last day to pass out of house of origin to continue or the bill dies. Not all information was posted before writing this article.

AB 18 (Levine) – Firearms: Excise Tax 2 year bill; would add additional cost to purchasing a firearm. AB 18 was held in Assembly Appropriations Committee and not heard. **Update:** Failed to get out of committee, ends.

AB 276 (Friedman) – Firearms: 2 year bill; Storage, would require a person who is 18 years of age or older and who is the owner, lessee, renter, or other legal occupant of a residence to ensure that any firearm that person owns or controls is securely stored against theft or unauthorized access while that person is outside that residence. The bill defines a firearm as being “securely stored” if it is secured with an operable device that is listed on the Department of Justice’s roster of approved firearm safety devices and that is identified as appropriate for that firearm by reference to either the manufacturer and model of the firearm, or to the physical characteristics of the firearm that matches those listed on the roster for use with the device.

AB 284 (Frazier) – Junior Hunting Licenses: Eligibility: Age Requirement, 2 year bill; In 2014, AB 1709 – legislation authored by Assembly Member Jim Frazier (D/11-Fairfield) was signed into law which increased junior hunting license age eligibility

from 15 to 17 years of age. However, that legislation included a “sunset” provision which requires the age eligibility to revert to 15 years on July 1, 2020, unless the provision is extended by subsequent legislation. As revised March 26th, AB 284 – legislation also authored by Assembly Member Jim Frazier – would extend the junior hunting license age eligibility of 17 years indefinitely.

AB 584 (Gallagher) – Sport Fishing Licenses 2 year bill; As introduced, AB 584 by Assembly Member James Gallagher (R/03-Yuba City) remains a “spot bill” that, as introduced, makes non-substantive amendments to a provision of the Fish and Game Code which deals with sport fishing licenses.

Update: Bill has been gut and amended to water conveyance for Paradise.

AB 688 (Chu) – Firearms: Vehicle Storage 2 year bill; Current law requires that a handgun in an unattended vehicle be either locked in the vehicle’s trunk, in a locked container out of plain view, locked in a container that is permanently affixed to the vehicle’s interior and not in plain view, or locked in a toolbox or utility box.

As introduced, AB 688 would make those requirements applicable to all firearms and would require the firearms to be secured to the vehicle’s frame using a steel cable lock or chain and padlock, or in a locked container that is secured using a steel cable lock or chain and padlock or that is permanently affixed to the vehicle.

AB1305 (Olberolte) - Junior Hunting Licenses: Eligibility: Age Requirement, 2 year bill; see AB284 language above. Continued on page 6

Legislative Information from page 5 Upon introduction in mid-June, AB 1305 was sent to Senate Rules Committee for referral to the Senate Natural Resources and Water Committee. However, due to the bill's language being highly similar to AB 284 (which was held in Assembly Appropriations Committee), Senate Rules has yet to refer the bill. With the deadline to be heard in policy committee being July 10th, AB 1305 is now a "two-year" bill which, at best, cannot be heard until early 2020.

AB 1387 (Wood) – Sport Fishing Licenses: 12 Consecutive Month Licenses 2 year bill; would, in addition to offering California residents a traditional calendar year fishing license, require DFW to offer a license that is valid for 12 consecutive months beginning on the date of purchase upon payment of a fee that is equal to 130% of the cost of the traditional calendar-year sport fishing license. AB 1387 would require DFW to provide applicants for these licenses the option of signing up for automatic renewal of the license by electronic payment and would set the fee for licenses issued upon automatic renewal at the same price as a calendar-year sport fishing license.

notes from January 10-12, 2020

The meeting was called to order by President Chriss Bowles, Saturday, January 11, 2020 at 8am. The Pledge of Allegiance was started by Joe Dotterer. The invocation was read by Pete Budding and dedicated to Joan Becker and Rudy Folds. Wayne Raupe was appointed as Sgt at Arms. The minutes from the previous meeting in 2019 were presented. Joe Dotterer motioned to accept, Kathy Budding 2nd, passed.

Reports presented:
President by Chriss Bowles, VP by George Papac, Secretary by Pam Severtson, Treasurer by Terry Mikesell, 2nd VP Field prepared by Daniel Stafford and presented by Pam Severtson. Wayne Raupe asked if the Treasurer's Report was the auditors final report. Terry Mikesell answered yes. Target by Karen Keating, Indoor by Dawnel Scott, Legislative Coordinator by Robert Moore. Robert expanded on his report that fundraising is occurring this weekend with wristbands and other items. IBEP by Johnnie Waddles. Newsletter by Lori Raupe and expanded on the deadlines for the newsletter articles and flyers. Webmaster by David Bacon explaining that we got back the website, cbhsaa.org. He also advised that he will be working on an online registration format for state shoots. NFAA Director by Gary McCain. NFAA Southwest Councilman Tom Daley reported that the "twirling" issue is in the RIC and he is on the committee. A question was presented whether the Nationals at Darrington is a 3 or 5 day event. It was clarified that it will be 3 days, due to the limited number of volunteers (7). Discussion on the financial report regarding deposits and placement of income and expenses within the Big Game Club. Discussion on newsletter expenses and how to bring this cost down. It will be worked on within the entire body to push email receipt of newsletter link. Joe Dotterer motioned to accept the reports as submitted. Pete Budding 2nd, passed.

CBH/SAA Petitions, those passed; 02-20, 03-20, 04-20, 05-20, 06-20, 07-20, 08-20, 10-20, 12-20, 14-20, 15-20, 16-20, 18-20, 20-20, 21-20. Those that did not pass; 01-20, 13-20, 19-20. Those amended; 09-20 with the following-motion was made by Joe Dotterer and 2nd by Terry Mikesell that refunds allowed 2 days before the shoot if requested by phone, email, text with a 30% administrative fee withheld. 11-20 with the following-motion was made by Joe Dotterer and 2nd by Karen Keating to add "or have a reciprocal agreement with NFAA on file". 17-20 with the following-Karen Keating motioned and Kathy Budding 2nd, to amend whistle commands "3-collect arrows, 4 or more to terminate shooting immediately" 16-20 was referred to the Secretary Committee Meeting. Meeting done for the day, and to reconvene at 8am Sunday. Continued on page 10



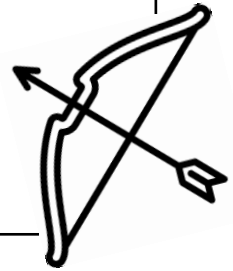

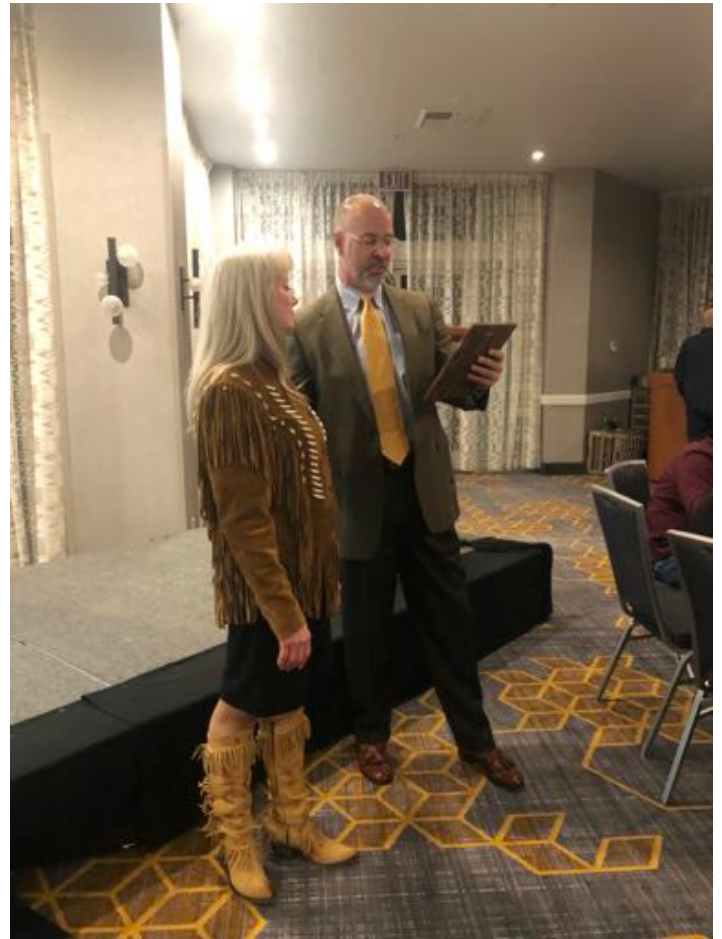

How to Mess Up On A Once In A Lifetime Buck

I have messed up on many hunting opportunities in the past but this time I messed up royally on a 200+ class Missouri Whitetail Buck!!!

This was the third year that I hunted with **Weaubleau Creek Outfitters LLC** (WCO) just a little over an hour north of Springfield, Mo., and I was fully expecting to put my tag on a very nice Whitetail Buck this year.

This is how this trip started and how it ended with much in between...



I had just moved to Chino Valley, AZ., on October 22, 2019, and had registered my truck with the AZ Motor Vehicle Department. They provided me with one license plate which was to be put on the back of my truck, another story in and of itself... Anyway, I got the plate put on the back of the truck and 5 days later I headed to Missouri. I made it to Amarillo, Texas the first day and stayed in a motel. I parked my loaded truck facing the front door under a very well-lit parking lot. As I headed to my truck the next morning I was thinking how nice it was to not have California tags on my truck and would not have to endure any of the normal ribbing that Californians have to endure when hunting in conservative, hunter friendly states. As I neared my truck, I looked at the front and noticed a license plate on the front... I thought to myself... What the hell is that??? Oh, crap I forgot to take my California plate off the front!!! (my first mess-up on the trip)! It is a darn good thing I didn't get stopped by a Highway Patrol while driving through Arizona, New Mexico and into Texas. It could have been a challenge to explain to the officer just how and why I ended up with two different state's plates on my truck.

I stopped in Springfield at the largest Bass Pro Shops (BPS) in the world which is also the "Original" BPS store and purchased my hunting license, two deer tags and two turkey tags then I headed north to the Weaubleau Outfitters Headquarters.

When I arrived at the WCO ranch house and parked I noticed no one came out to greet me. In Missouri the doors to homes and vehicles are never locked so I went into the ranch house and I found **Rob Gamberg**, Co-Owner of WCO, sitting at the dining room table looking at his phone. I said hi and he looked at me and said hi back. I asked where all the others were, and he said they get in tomorrow on the 8th. I said, the 8th? Isn't today the 8th? He said... nope today is the 7th! (this was the second mess-up on my trip, but on the upside I wasn't late to my hunt).

Steve Harden (the other Co-Owner) arrived from his other job around 4pm. Anna, Steve's wife and Jennifer, Rob's wife arrived, and things really started to get fun. The ladies fixed dinner for us, which is always awesome, then we relaxed for the rest of the evening.

The next day others arrived which included Mike Nolte, Carlos Mejia (member of Oranco Bowmen in Chino, CA) and his very young, beautiful wife Laura. Carlos and Laura were new to WCO, but it took no time at all for them to be a BIG part of the WCO family. Laura was a little reserved at first, but it didn't take long until she was teaching Anna and Jennifer how to make some of her Speciality Mexican food. I have eaten lots of Mexican Food, but her's was the BOMB!!!! The Lady absolutely knows how to cook!!! Anna and Jennifer turned the kitchen over to her for the remainder of our stay. Laura whipped up some fantastic meals and Anna and Jennifer enjoyed watching and learning as she performed her magic in the kitchen.

I asked Rob if I could hunt out of the treestand I helped put up last year. It is in an area where I saw lots of deer crossing at a choke point in the timber about 300 yards from the blind I had sat in last year where I had successfully taken my first whitetail doe. Continued on page 12

How to Mess Up from page 11- He said, you mean Wayne's Stand... that's what we call it. Yep you sure can he said. The next morning, I climbed into MY treestand well before light, it was below freezing. I waited for dawn to break and for the action I was anticipating. Just as dawn was breaking the Chipmunks, Gray Squirrels and Red Tree Squirrels began searching the ground for acorns in the big dried leaves that carpeted the ground under the oak trees in the oak tree grove where I was sitting. The noise they made was loud and sounded like something walking or running in the leaves all day long. My neck finally got a kink in it from looking from one side to the other and back again, all day long, just to find out it was another rodent. However, I did see eight deer that day and the only ones that came close were the fawns and two little bucks.

In a tree about 15 yards from me lived a family of six raccoons which provided several hours of entertainment as they went in and out of their den, a hole in the tree which was about 30 feet off the ground. Day one ended with no deer on the hit list showing up.

When we got back to the truck Carlos asked if I had seen anything and I said yes, I had seen 8 deer but nothing close that I wanted to shoot. He then said he saw a giant buck as he and Rob were walking to his treestand in the dark. They both had headlights on their hats and Carlos said he looked to the right and saw the buck in his light at 25 yards. He moved his light off the buck and tapped Rob on the shoulder and said look over here and as his light swept the area to their right they watched as the monster buck trotted into the trees and out of sight. Carlos said it had to have had a 32-inch spread. He was one excited bowhunter!!!



Day two, again it was dark and below freezing when I climbed into my treestand. The squirrels and chipmunks were at work again just as daylight was breaking. I think they created more noise than the day before and it sounded like 50 of the little critters were at work. I, for a while, followed the sound they made and was soon conditioned to and ignored their noise. I put my reading glasses on so they rested on the lower portion of my nose so when I looked up, I could see over the top of the glasses and survey the area for any deer activity. I could see out to 30 yards behind me and to my right, 45 yards directly to my left, 34 yards to the edge of the tree line where the deer always stop before stepping out into the open field, 250 yards across the field, 55 yards directly in front of me and to the right, 200 yards in front and 60 yards to my right. I couldn't see behind me very well without lots of movement, but I felt comfortable counting on my ears for covering the area behind me and my eyes everywhere else.

So, I got my phone out and started texting and emailing to pass the time. Some people read a book to pass the time and others do what they should be doing... doing the job they are there to do and be ready for anything at any time. Lots of my friends have told me that one of these days I was going to screw up by playing with my phone and I always poo pood their comments as I have yet to get caught off guard. Well at 8:45am, your CBH/SAA Magazine Editor, Lori Raupe, sent me a text that said... Today is 11-10-19, and you are going to get a big 10x10 buck. I responded and said I would be on the lookout for that big-en! She then said she finished writing her second book and had just uploaded it on Amazon and she asked me to download it on my phone. It is well known that I always follow directions from my wife, so I went to Amazon and started to download it. The squirrels were extremely active that morning, as it was going to rain, freeze and snow the following day, so there was noise all

around me and every time I looked, I identified the noise as one of the little critters. At about 9am, I was leaning forward, looking down at my phone, with my elbows on my thighs downloading Lori's book when I heard a slight sound behind me and close to the base of my tree. I thought to myself... that little sound had to have been a squirrel as I'm sure a deer would make more noise than that. I continued with my phone and then in my peripheral vision I saw movement, a big shadow, much bigger than a squirrel,

moving on the ground directly below me. I look down and there was a big doe walking past my tree. I had a doe tag so...

I normally put my phone in my left zippered chest pocket but because she was so close I was sure she would hear me slide it into the pocket so I decided to put it into the flip top of my binocular case where I always put my reading glasses. With my phone secured I reached over and got my bow off the bow hook and attached my release to the "D" Loop. I drew the bow as the doe was 10 yards in front of me, quartering away, just off from a broadside shot. I looked through my peep and everything was blurry!!! My peep, my pins, and the doe were all blurry! I looked up and everything was in focus... got back to my anchor point looking through my peep and EVERYTHING was blurry again. Now she is at 20 yards and I'm starting to get buck fever because I can't figure it out and I can't tell how far she is or which pin to use due to the blurriness. She is at 25 yards now and I'm still at full draw with my head exploding with confusion when I hear another slight noise at the base of my tree. I look down and there stands a MONSTER 200+ class buck!!!! Still at full draw I think to myself he is going to follow the doe and I will get a broadside shot at him. Continued on page 13

How to Mess Up from page 12- He stood and stood and stood until I finally had to let down. Just then he started walking directly away from me, NOT following the doe. I started to draw my bow, but my elbow hit the big limb behind me, so I had to adjust my position as the buck was walked away. Relocated I drew my bow, got my anchor point and looked through my peep and EVERYTHING WAS BLURRY!!! The buck is now at 10 yards, I look through my peep again and its still blurry!!! My head is ready to explode now, and buck fever has really set in. I look up and the buck is now at 20 yards and I don't know what pin to use... he is at 25 yards and still I can't figure it out. Should I use my 30- or 40-yard pin???????? I don't know... shit he is at 30 yards... now he is at 34 yards standing broadside... WHAT PIN DO I USE???????? I'm screaming in my head!!! He turns and jumps the fence and walks into the woods and out of my life... forever!!!! What the @#&%#@*\$#@%*\$%# just happened??? I'm looking at the trail the doe took and the trail the buck took, and both are in focus... NOT blurry!!! What the... NO WAY!!! I still had my reading glasses on!!!!!!!!!!!! I'm screaming in my head... Aaaaaaaaaaaaaaaaaaagh!!! You have got to be kidding me!!! My stupid glasses, I was looking through my stupid glasses when looking through my peep and that caused everything to be blurry!!! Aaaaaaaaaaaaaaaaaaagh!!! I can't believe I MESSED UP on a once in a lifetime whitetail buck... A BUCK that was STANDING UNDER MY TREESTAND!!!!... Aaaaaaaaaaaaaaaaaaagh!!!

Rob and Steve were sorely disappointed when I texted them what happened. They were wanting one of us to put a tag on this monster and I failed the test.

That afternoon at 1:19pm I had 4 big bucks, not the monster, chasing a doe in heat in the wooded area to my right but they offered no shot as they ran and darted back and forth and two of them started fighting for about 30 seconds. A young eight point came in from behind me on the left and stopped broadside at 34-yards at the edge of the trees for about a minute and a half. I thought to myself that I could fill my buck tag with him but if I let him walk, he could be a great buck in two or three years, so I let him walk. Then a young 7 point came in and walked under my tree at 5 yards then a spike and 2 fawns found some tasty acorns under my treestand. Later a young genetically inferior buck, a 4x0, came in and ran the spike off.

The next day it rained on us from daybreak until 9am then it froze, and I had ice covering me, my treestand, the tree, my backpack and my bow then it started to snow and blow... like blowing HARD and COLD.

At 11am I texted Rob and told him that Mike Nolta and I had been texting and were coming out to warm up.

Rob called Carlos on a radio and he said he was going to stay in the stand as he hadn't seen anything but didn't want to take the chance of missing an opportunity. A side note... Carlos doesn't play with his phone while in his stand...

The last day I had some things to attend to so I asked Rob if he would put Carlos in my treestand as I was going to stay at the ranch house. Carlos was excited as he really hadn't seen anything up close except for that monster the first morning and he was looking forward to seeing several deer and maybe a nice buck. Carlos did see a nice 8-point buck at 34 yards standing right where I told him they all would stop before going out into the meadow. Carlos was excited to see the buck and when he had the opportunity, he tried to draw his bow but couldn't break it over... he was so cold his muscles wouldn't work, and he couldn't draw his bow! Yeah, it was a really cold Missouri day. However, he was VERY excited about having the opportunity but still had to laugh at himself.

Mike Nolta got a nice big doe on day one, Carlos and I blanked but we both have stories to tell and friends in Missouri that we call family. It's not always about filling your coolers, albeit that is the goal and is very nice when it comes to tossing a steak on the BBQ, but an overall great time is the frosting on the cake... and we had that!

Carlos and Laura on the way back to California stayed overnight in Amarillo, Tx., and during the night the motel clerk saw a guy break a window in their SUV, so he called 911. The POS burglar grabbed one bag from behind the seat that contained Carlos's binoculars and rangefinder and took off with it. Carlos and Laura were not able to leave Amarillo until 11am instead of the 6am departure time they had planned on. They had to wait until they could get the window replaced. What a bummer!

The two trail camera pictures that accompany this... AWESOME STORY... are of this buck last year... no current pictures of him this year... but I can say with certainty that he is even bigger this year!!! He now has 16 to 18 scorable points.

The original range fund monies were collected by charging shooters \$1 extra per shoot. It was to be a one year voluntary trial period. Some people jumped the gun and made it mandatory at the state shoots which upset many people and the fundraising was stopped. The clubs and regions that could provide proof of the donations were refunded their money. The rest of the funds were put in a separate account within CBH.

I was asked to develop a program using those monies. The IRS informed me the money could only be used for land purchase or range improvements because that was the reason for its collection. Those funds are 501C4 as are all CBH funds.

The Range Committee are a clearing house to see if the clubs are applying for the money and appears to be able to repay CBH. The committee would then make a recommendation to the full CBH board would then vote to release the funds. Money can only be released by the full board decision.



INTRODUCING RODNEY YORK

I would like to introduce Rodney York as the new Second VP of Hunting. He lives in central California with his wife of 48 years - Alice. They have three grown daughters and nine grandchildren.

The office of second VP of Hunting and its obligations are nothing new to Rodney as he has held this office before. He first started his affiliation with CBH under the mentorship of Dave Duncan in the early 70s. Rodney was soon appointed by second VP of hunting Michael Penn as an official measurer. From there he also became involved with Pope and Young as a measurer. He was also a member of the Longhunters Society (Muzzleloaders) and Boone and Crockett as well.

During the 70s and 80s, he began working with the Department of Fish and Game and the State Legislative Team from CBH, to proposing new hunts. Rodney worked on presentations and drafts to the Department of Fish and Game to initiate archery only hunts for Pronghorn. This program lasted about three years until they finally granted the right to hunt with a bow and arrow for antelope. He also offered two different deer seasons, one which was adopted called the Anderson Flat Hunt. When writing these proposals Rodney set the boundaries using roads and confluences.

When he first became second VP of Hunting he was tasked with gathering all of the old records from his predecessor so that he could compile the sheets for entry under each applicant's name. It took eight Committee members about three months to reconstruct the records for CBH hunters. Also during his term he started the first electronic record keeping system for all applicants.

Rodney initiated the use of 3-D targets from Longhorn at the State Broadhead held at the Woodlake range in the mid 1980's. Despite the wide held belief that this would be a waste of time and money, its long term success has proven otherwise.

A major hurdle that was faced at this time was the making of the very first hardback CBH Record Book. It included not only black-and-white pictures but also a limited addition of 100 copies made with color inserts, a first for CBH.

The prestigious Whitney Hill Award was also established under his direction.

The office of CBH second VP is a success due to an outstanding and involved Big Game Committee. It is Rodney's feeling that this committee should be made of bowhunter members throughout the state, some with little to no experience, some with moderate experience and finally those with advanced experience.

Newer members will bring a fresh perspective and new ideas. While those who have served for several years and know the history of record keeping and the Big Game Club can mentor the other members.



It would also be his hope that at least half of this committee are measures for Pope and Young, to ensure the measuring and record keeping heritage of California's Big Game Club persists.

It has been my distinct pleasure to know Rodney York for nearly 40 years. I can think of nobody else that can service this office with more integrity, ethics and bow hunting knowledge than Rodney York.

UP THE RIVER ZUCCHINI BOATS LORI RAUPE

The first time we prepared this delicious dish it was after watching a cooking video. The Chef used venison as the protein or meat for this meal. I would love to tell you the Chef's name or give you the title of the video series, however they all went up in smoke. ;) Really, not from cooking but lost in the California Cedar Fire. Thankfully the recipe is easy and one of our all time favorites. I hope you'll

3-4 Zucchini Squash (Larger ones from a home garden are the best!)
1 lb. Ground Venison
1 Large Sweet Onion
2 Gloves of Garlic
EVOO or oil of your choice (used to sauté the onions and garlic)
1 Cup (or more) Mexican Cheese Blend or your favorite
Worcestershire Sauce
1-2 Jalapeño Peppers
Salt and Pepper to taste
Heat oven to 375 degrees

1. Chop onion, mince garlic, cut zucchini in half lengthwise, scoop the seeds from the center of each half. Cut Jalapeño peppers into discs, remove seeds (you can use gloves to protect your hands from the pepper's juices.)
2. With a small amount of oil sauté onions and garlic in a skillet until translucent.
3. Add ground venison to the skillet with onion mixture and brown on medium heat to avoid burning the mixture, it's OK if some of the meat is still pink it will complete cooking while baking in the oven. Salt and pepper to taste.
4. Spray olive oil on the cooking sheet or baking dish, then place the zucchini face up.
5. Pour one to two Tablespoons of Worcestershire sauce to each scooped out Zucchini half or "boat".
6. Add the meat mixture to each boat and generously cover with cheese blend.
7. Top the cheese with 3-4 Jalapeño slices spaced over your boats. Depending on your tolerance of spicy foods you may add or reduce the Jalapeño.
8. Place Zucchini dish into the oven for 20-30 minutes until the zucchini is soft and the cheese is bubbling.
9. Remove from oven, let cool, then serve.

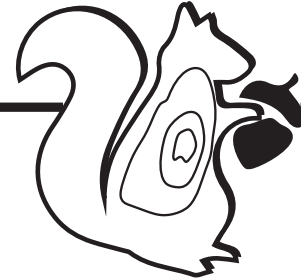

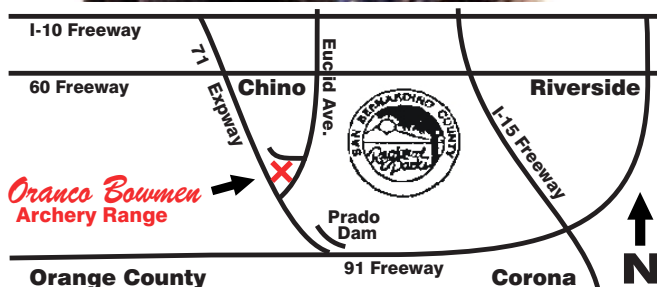

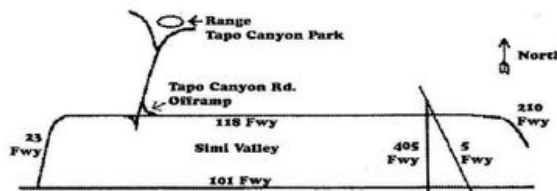
