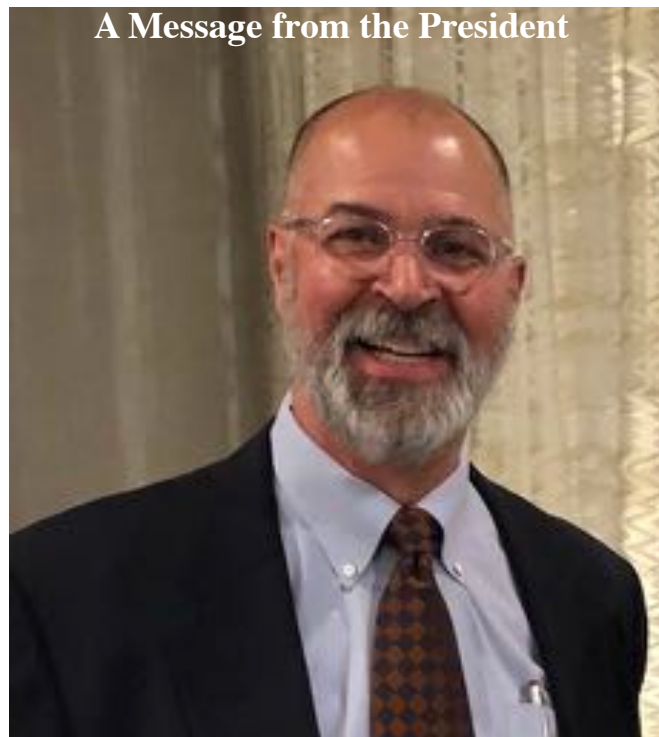

Legislative Team Update

Greetings CBH/SAA friends and family!

I hope you all are ready for another exciting legislative season! We are set up with **VOTER VOICE** to let you know when we need **YOU** to jump in and take action, but to be part of the action **you MUST SIGN UP for our Legislative Alerts** at <https://cbhsaa.net/Legislative/LegHome>.

In last month’s newsletter, I reported that the Legislative Team was following up on rumors that CDFW staff at the **Los Banos State Wildlife Area** were proposing to disallow archery equipment during waterfowl season. Los Banos is the **ONLY** Type A Wildlife Area that allows archery equipment during the waterfowl season. Despite best efforts to engage CDFW staff and track down the proposal, we were caught flat footed when CDFW notified our lobbyist Bill Gains an hour before Day 2 of the Wildlife Resource Committee (WRC) meeting that the proposal was included in a large land use package as part of that day’s [agenda item 10 - Public Use of Wildlife Areas and Ecological Reserves!!!](#) Well, it was a mad scramble with a lot of clock watching, text updates, and ducking in and out of work meetings, but CBH/SAA was able to provide verbal testimony on this issue via Zoom. Bill Gains also provided in person testimony on our behalf and rallied our California Hunting and Conservation Coalition (CHCC) partners including California Rifle and Pistol Association (CRPA) and California Waterfowl Association (CWA), among others, that spoke up for the archery community. We **TRULY** appreciate their support and partnership! **THANK YOU!**

Our direct testimony kicked off with a request to meet with CDFW prior to this proposal being brought before the Fish and Game Commission (FGC). We want to better understand why their staff believe hunting pheasant with archery equipment is an “incompatible use” with the waterfowl season and to discuss possible win-win solutions that may preserve this unique hunting opportunity for archers. I also noted that I was scheduled to participate in a Special Women’s pheasant hunt organized by CDFW at the San Jacinto Wildlife Area that weekend. This would be my first hunt with a firearm and I would be attending with a mentor (CBH/SAA Small Game Chairman J-Barr and his amazing retriever Josie) and participating in a clinic on how to field dress pheasant. I expressed gratitude to CDFW for this opportunity to expand my hunting experience from bowhunting big and small game to hunting upland game birds with a firearm. However, as a predominant bowhunter,

I asked why archery is not permitted within the San Jacinto Wildlife Area and speculated that if there were more archery hunt opportunities on State Wildlife Areas, like the one at Los Banos, that it could have a positive effect on CDFW R3 (recruit, retain, reactivate) goals and efforts.

We feel **VERY** strongly about preserving this unique bowhunting opportunity and want to see archery opportunities like this increase throughout the state. Therefore, the Legislative Team is researching this topic in preparation to defend and expand archery opportunities on State Wildlife Areas. If you have stories and insights to share that could help our cause, please reach out to the Legislative Team ASAP; our contact info is in this newsletter and online.

Other proposed rulemaking on State Wildlife Areas (WA) and State Ecological Reserves (ER) include:

- Proposed designations and allowable uses (including hunting) on three new properties
- Prohibition on e-bikes and drones on CDFW lands
- Define a time limit for entry on hunt days

- Change in dog training/trial season on 3 properties to avoid conflict with proposed deer hunting
- New hunt opportunities on Type A and Type B WAs including Los Banos WA deer and quail, North Grass WA deer and quail, Mendota WA quail, Tehama WA deer, and Upper Butte Basin WA turkey and quail
- New species hunt and permit details for deer at O’Neill Forebay WA
- **Remove ALL archery from Los Banos WA**
- Change in waterfowl season to avoid conflict with proposed deer hunts at Los Banos WA, North Grassland WA, and O’Neill Forebay WA
- Updates and edits to existing hunting opportunities on Boden Canyon ER, Kerman ER, Stone Corral ER
- New hunting opportunities on Boulder Creek ER, Burton Mesa ER, Chorro Creek ER, Proposed Peace Valley ER

As you review these proposed changes, I also encourage you to check out existing hunting opportunities available on CDFW WAs and ERs (see Title 14 [§ 550 General Regulations for Public Use on All Department of Fish and Wildlife Lands](#), [§ 551. Additional Visitor Use Regulations on Department Lands Designated as Wildlife Areas](#) and [§630. Additional Visitor Use Regulations on Department Lands Designated as Ecological Reserves](#)).

Agenda item 10 was not the only agenda item of interest at the WRC meeting. The CBH/SAA Legislative Team is also following up on:

ing up on:

- [Preference points and refunds for hunt tags](#). CBH/SAA supported CDFW’s approach in the past. We are reviewing CDFW’s proposal to close the “grandma loophole”.
- [Chronic wasting disease](#). CDFW’s presentation at the meeting appeared to provide answers to many of our questions related to the proposed ban on biological scent-based lures for cervid hunting. The Legislative team is reviewing the responses and will provide CDFW with additional comments as needed.
- [Commission regulation change petition 2021-017](#). Commission staff supported CDFW’s

- o recommendations, specifically: Grant or deny item 1 (Party Applications Return of Tags Rule) based on whether the WRC supports the proposal in agenda item 2 during the meeting
- o Deny item 2 (Returned Tag Reissuance for Elk, Pronghorn, Sheep) because there is no refund mechanism for returned tags and loss of revenue for CDFW,
- o Deny item 3 (Second Bear Tag Option) because more information/science is required and defer all bear regulatory changes until the updated Bear Management Plan is completed (anticipated May 2023).
- o Deny item 25 (Non-resident Elk Opportunity) on the basis that the change is limited by statute. The petitioner indicated that only one elk tag is available to non-residents and proposed that 10% of tag be allocated to non-residents.
- o Deny item 27 (Archery and Muzzleloader Desert Big Horn Sheep Hunts) on the basis that archery and muzzleloader are existing methods of take for bighorn sheep and allocating method specific tags would limit the hunt opportunity to the majority of the constituency.
- o Grant items 23 and 24, which are being considered within the Commission’s elk hunting rulemaking.
- Petition 2021-17 is also known as the “omnibus hunting petition” that proposes sweeping changes to big game hunts in California. Other items in the petition that we are monitoring include:
 - Item 4 (General Deer Tag Archery/Rifle Separation A, B, and D Zones). The petition would separate archery and general tags, which would require an AO tag for archery season in A, B, and D Zones and add late archery hunt for AO tag holders. CDFW indicates that this may be warranted but additional research is needed, and they have no recommendation at this time. Items 5-22 proposed additional changes to deer zone boundaries and hunts. CDFW identified the need for research and defers on a recommendation; likely waiting on the Deer Management Plan.

- Items 23 (Elk antlerless season change) and item 24 (Grizzly Island Wildlife Area [GIWA] Antlerless Archery Elk Hunt). CDFW proposed regulation changes at the December 2022 Commission meeting.
- Item 26 (Alternate seasons or longer seasons for elk hunts affected by wildfire). CDFW does not have a recommendation but continues to evaluate options. CBH/SAA notes the current system for preference point and fee refunds may be sufficient.

I also want to take a moment to remember long time CBH/SAA past president and Oranco Bowmen President Joe Dotterer who passed in December. Joe was passionate about archery, our organization, and especially our legislative activities. The CBH/SAA Legislative Team extends our heartfelt condolences to Joe’s family and friends and our special thanks to the Dotterer family, which asked for donations to the CBH/SAA Legislative Fund in Joe’s memory in lieu of flowers. Joe is greatly missed but his legacy continues. Thank you, Dotterer Family and friends, for your generosity.

Thoughts From A Long Time CBH/SAA Member Joe Becker

After reading Rodney York's article about the State Broadhead Tournament (February 2023), I recalled being a part of the Broadhead and other shoots back in my recurve days. In the 60's, 70's & 80's my wife and I attended many tournaments, and up to the early 2000's, most of the CBH/SAA annual meetings, as a delegate from my region Nor Cal. We were also on the Leg Team and Bowhunter Ed Program. As someone who has attended these meetings and tournaments I remember many of the points Rodney mentioned from days gone bye. I was never one of the top target shooters, but more of a hunter. We attended shoots to support clubs and socialize with friends. Many of those friends were average shooters, but also some were champion archers.

Hunting and education of hunters was my priority in archery. I was a serious bowhunter and my success was between me and the animal I was stalking, so that I could provide meat for the dinner table.

The reason for so many years I have pushed for education was because when I started I did every thing wrong for several years. I still have problems with Buck Fever. Excitement is one of the reasons we hunt. The easy part is hitting the animal, then the real work begins. Recovering, tagging, field dressing, packing the animal out, and then putting the meat on table to eat, are all part of the ethical hunting experience.

As Rodney mentions no matter how many times rules are changed it will never satisfy every shooter. Manufacturers will continue to make improvements on equipment to make archery easier to hit the target and to sell more equipment. The placement of the arrow, and where the broadhead hits the animal, is what makes for quick kill. Bows, arrow quality, and all other gadgets are marketed to archers. Businesses sell new equipment every year as we like the newest and latest greatest equipment available.

Thoughts From page 7~ Most harvested animals are shot at close range, so being able to hit the orange spot at 100 yards in a tournament is not the reason we take up archery. The broadhead tournament was started back in the recurve days, and yes, we still have several archers who enjoy longbows, recurves, and shoot wood arrows. A hand-crafted wood crested arrow is a beautiful piece of equipment, which shoots very accurately.

I am still a member of two local clubs, CBH/SAA, NFAA, CA-DFW and an Instructor for NASP, IBEP, and Hunter Ed. I keep up with our Legislative Team activities, but for several reasons I do not attend tournaments other than to work at my clubs tournaments.

Archery is still my favorite pastime activity. Not a day goes by when I am not hunting or promoting it in some way. I agree with Rodney, offering a rendezvous like many eastern states which are well attended. I believe this would increase knowledge of our sport as well as to offer shooting and socializing. An added benefit would be the dealers and manufacturers having new equipment available to sell at tournaments. And also include shooting form recommendations for various tournament styles. The offering of classes such as bowhunter education, with short sessions like bow set up; tuning for broadheads; stalking; treestand use; tracking; recovery; field care; legislative concerns; the \$10,000 drawing; equipment swapping & sale; fundraiser drawings; and lastly a membership drive for our many non-club member archers, all would add to the value of the event.

Lastly, being in Paradise again in a replacement home with my dog, archery equipment, teaching equipment, and bow and arrows, has given me the opportunity to be teaching again. I have two beginner archery classes a year and I'm planning to also teach an IBEP and Hunter Education Class. My life as a "has been" archer,

as I sometimes call myself, isn't over. Giving back for all who have given to me is a worthy cause for my time and hopefully a legacy in the making.

Bow Fishing!!! Continued from page 8 I can't say the same for carp, but Tilapia are beautiful and great tasting fish. Tilapias are very elusive but abundant, most years, and challenge the bow fisher. You will be looking for any size Tilapia for your species credit, but a 3-pound tilapia will get you into the Small Game Records that are found in the CBH/SAA Big Game Record Book. Also, you can put your sights on any carp you may see for your species credit. There is the possibility that you may arrow a 10 pounder, or bigger and that will also get you into the Record Book.

If you are lucky enough to bring in, by weight, one of the top three Tilapia, or the top carp, you will receive a beautiful plaque recognizing your accomplishment. Additionally, if you enter the Big Carp Jackpot and you capture the first-place carp you will receive your share of the Carp Jackpot money. The plaques are adorned with a hand-crafted, 3-dimensional Tilapia or Carp, created by artist Gilbert Olivas. Gilbert has been creating these special awards for the Small Game Club for many decades. He is a long-time member of the CBH/SAA and is a Senior Member of the Big Game Club with eleven different California big game species to his credit.



Seven of those species meet the minimum measurement requirements to be recorded in the BGC Record Book. Additionally, his small game list is extensive.

Don't forget to bring your bowhunting bow so you can add, or attempt to add, additional species to your small game list. This will happen on Friday and Saturday night. Bull Frogs are abundant and sometimes you can find other little critters. Bring your binoculars, range finder and a good handheld flashlight.

So, grab your gear and come join the fun and support the CBH/SAA Small Game Club and have a little fun at the same time. See the flyer found elsewhere in this Magazine for details.

I really liked the way James H. Faulkner put the story together. James Faulkner expressed that Ben Pearson is rank with Howard Hill and Fred Bear as the top three in Archery. These three men have manufactured Archer equipment and films showing how deadly bow and arrow can be in the hands of a skillful Bowhunter. His hunting skills are comparable to these men. I encourage you to read this article that I picked out of Archery magazine that date to September 1964.

The Ben Pearson Story By James H. Faulkner

Excerpt from Archery Magazine (1964)
Pine Bluff Arkansas

You begin to know and understand Ben Pearson, the hunter, even before you meet him.

In the reception room of this gigantic archery firm which bears his name are his trophies a mountain lion, in antelope, and eight point buck. They speak highly of this man's hunting prowess.

"Mr. Pearson will see you now," and attractive young receptionist informs you.

Inside an extremely unpretentious office a graying gentleman of 60 bids a warm welcome. This is Ben Pearson, the man, initially shy and not at all the hunter type one expects on first encounter.

To Pearson's left flank on a file cabinet are a group of tarnished trophies won in various archery meets. Behind him snarls the head of a Javelina, a surly wild hog like animal that Pearson pinned to the ground with an arrow from an incredible distance of 130 yards (this feat was recorded on motion picture film). To all sides are framed photos—Person in the classic pose with 1 foot on the kill—Pearson showing Will Rogers, Jr., the tricks

of shooting—Pearson beside an antelope he had just downed in New Mexico.

This is the man who launched the worlds leading archery firm. This is the man they rank with Howard Hill and Fred Bear as the Top Three in archery today. But, despite his fame, Pearson is not the gregarious type.

It becomes clear: one must pump for any and all clues as to what motivated this man to stake his future on archery in the midst of the nations worst depression. What makes this man who despises the needless killing of game one of the world's outstanding hunters? What prompted this seemingly shy and sensitive man to stock wild, often dangerous animals?

It's best to begin in the beginning.

It was during the lean and hungry days of the early thirties when Pearson filled is first order for a Ben Pearson bow. He carved it by hand from a hickory stave, using an ordinary drawknife.

It was a good bow, so good that the word soon spread among archers all across the land. And, despite the fact that the average family had a little money, if any, to spend on hobbies or entertainment, orders for the handmade Ben Pearson Bow began to grow.

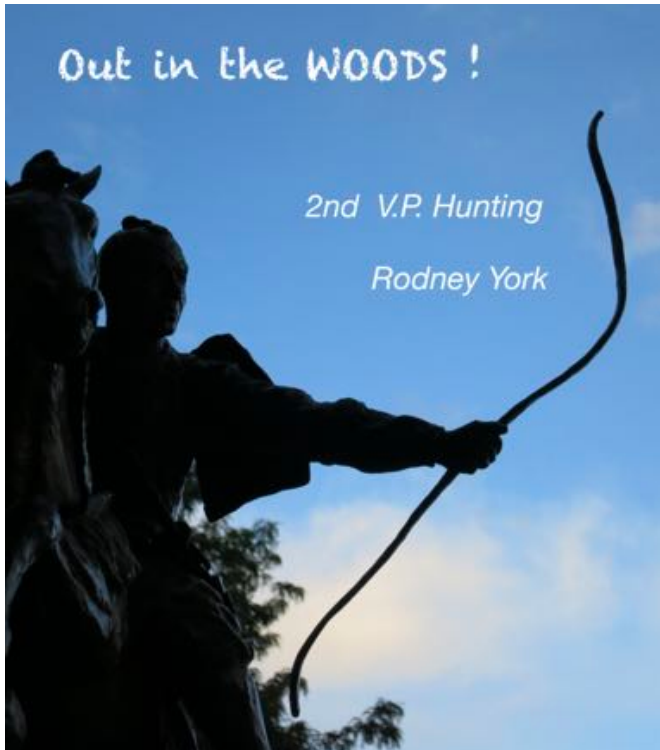
In time it was necessary to hire additional workers to supply the demand. At this stage, Person began to formulate the idea of mechanizing the bow making operation. His dream was to produce archery tackle on a mass production basis. But this required financing. And, despite his already apparent success and growing reputation as a bow- maker, no financial institution would even consider the idea of financing a "bow and arrow" manufacturer in such hard times.

Then an Oklahoma oil man, Karl Haun, heard of Ben Pearson and learned of his reputation as a bow-maker. Primarily out of curiosity he decided to visit Pearson and observe his operation. During this visit Pearson related his dream of mass producing archery equipment and produced drawings of equipment he had designed solely for this purpose. Haun was so impressed with what he saw that he offered Pearson financial backing. Shortly thereafter, March 19, 1938, Ben Pearson, Incorporated was formed.

Later, Gerry Powell, and associate of Haun's in the Oklahoma oil business, joined the company to help manage the thriving new business. Powell's experience and ability in business finance and accounting completed the managerial combination that has so successfully guided the firm since its beginning.

Powell was recently made president and general manager of the company after the death of Haun. Pearson is the firm's secretary treasurer.

The hunter separates sounds into specific groups of birds awaking with their own greetings to the morning. 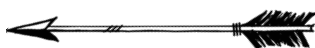
Ingredients

- cooking spray
- ½ cup milk
- ½ cup prepared ranch dressing
- ½ cup all-purpose flour
- 1 cup dry bread crumbs
- ½ cup grated Parmesan cheese
- ½ teaspoon seasoned salt
- ½ teaspoon ground black pepper
- ½ teaspoon celery salt
- ½ teaspoon garlic powder
- ½ teaspoon onion powder
- ½ teaspoon ground paprika
- ½ teaspoon dried parsley
- ¼ teaspoon dried basil
- cooking spray
- 8 (6 ounce) tilapia fillets

Directions

1. Preheat an oven to 425 degrees F (220 degrees C).
2. Line an 11-17-inch baking sheet with aluminum foil and lightly spray with cooking spray.
3. Mix milk and ranch dressing in a shallow bowl. Place flour in a separate shallow bowl; set aside.
4. Whisk together bread crumbs, Parmesan cheese, seasoned salt, black pepper, celery salt, garlic powder, onion powder, paprika, parsley, and basil in a bowl.
5. Spray bread crumb mixture with cooking spray until damp, then whisk bread crumbs. Repeat spraying and whisking 3 more times to lightly moisten crumb mixture with cooking spray.
6. Transfer crumb mixture to a large resealable plastic bag.
7. Gently press tilapia fillets into the flour to coat, and shake off the excess flour.
8. Dip the fillets into the ranch dressing mixture.
9. Place all the fillets into the resealable plastic bag; seal bag and shake to coat fish with bread crumb mixture.
10. Arrange tilapia on prepared baking sheet. Lightly spray the breaded fish with cooking spray.
11. Bake in the preheated oven until the fish is easily flaked with a fork, 20 to 25 minutes.

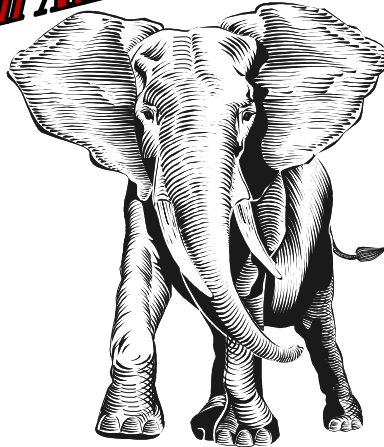

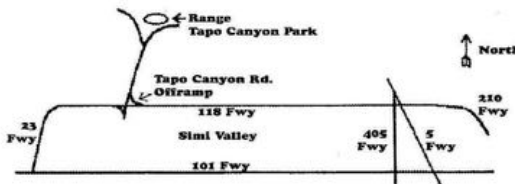

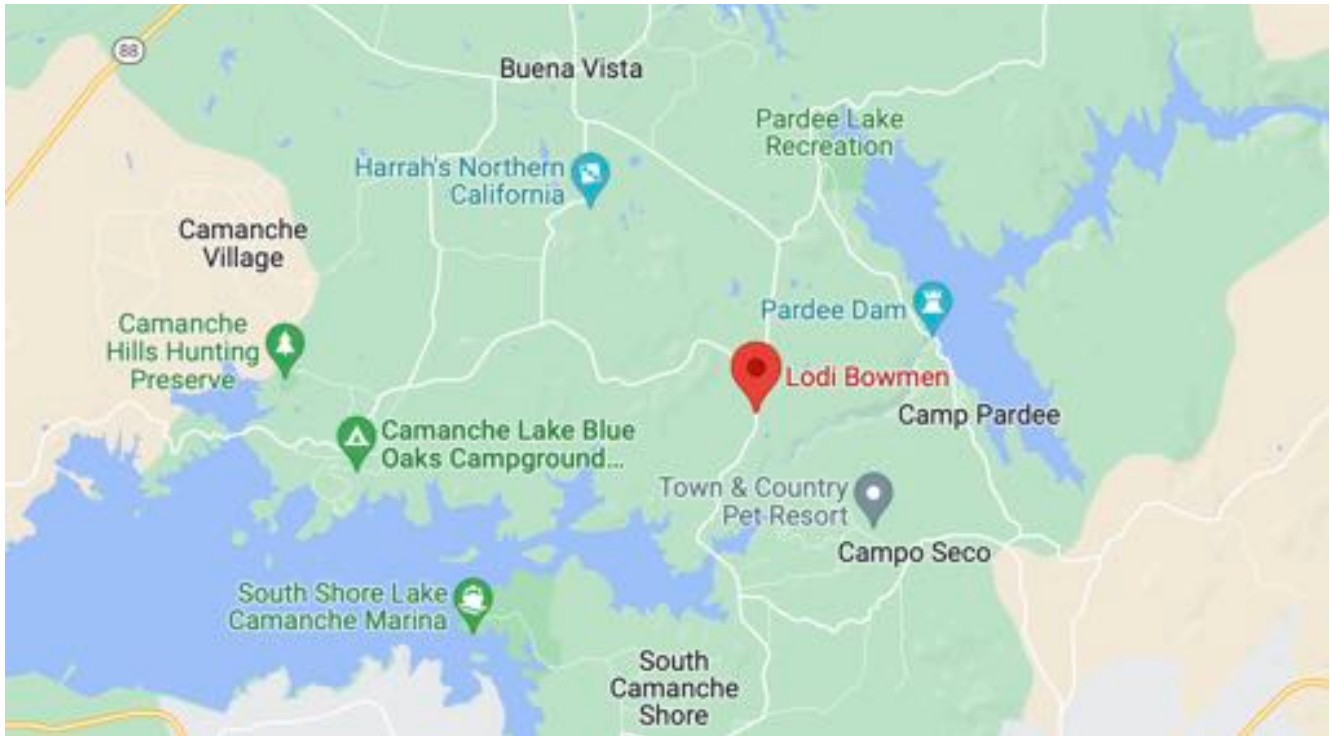

CBH/SAA State Broadhead Championship Tournament General Working Mechanics

1. This tournament is designed to appeal to the bowhunter as opposed to the tournament archer. It is designed to offer the hunter some benefits without his/her becoming entangled in the aspects of a Field tournament. NFAA rules do not apply to this event
2. The State Broadhead Tournament shall be a one or two day event held on Memorial Day weekend.
3. The 2nd Vice President of Hunting or his delegate shall govern this tournament
4. The range for this event shall be laid in such a manner as to simulate hunting conditions when possible.
5. Archers shall use hunting tackle for this event which is keeping with California State Fish & Game Laws on Big Game Hunting.
 - A. Scoring:
 - 1) Vital—10 Kill-8 Wound-5
 - 2) An arrow must be in the target to score, except a “pass-through” which must be witnessed and scored a witnessed by other shooters in the group.
 - 3) “Bounce-ins and Glance-offs” shall not score.
 - 4) “Antlers” do not score.
 - 5) Shaft of arrow must touch the line for higher score.
 - 6) Double scoring is required.
 - 7) This shall be a one-arrow tournament at unmarked yardages.
 - B. Divisions and Styles of Shooting:
 - 1) Divisions
 - a) Seniors (65+)
 - b) Adult (18-64): Male and Female
 - c) Young Adult (15-17): Male and Female
 - d) Youth (12-14): Male and Female
 - 2) Styles:
 - a) Sight Fingers (SF)
 - b) Non-Sight (NS)
 - c) Release ®
 - d) Recurve (RC)
 - e) Longbow (L)
 - C. Awards:
 - 1) CBH/SAA Membership (Regular or Associate) is required to compete for awards.
 - 2) Guest Class is one Class (Male and Female combined) and there will be no awards.
 - 3) No awards will be mailed.
 - 4) Cubs and Peewees Participation Awards Only
 - D. Tackle
 - 1) No Mechanical Broadheads
 - 2) Only ONE “izer” whether it be stabilizer, equalizer, side bar or any such weighed balance with a total protrusion from the bow not to exceed 12 inches.
 - 3) Bow Quivers are allowed in all styles.
 - 4) No magnifying scopes are allowed.
 - 5) No compound over 80 pounds peak draw weight. Recurves and longbows have no weight limit.
 - 6) Binoculars are allowed. No rang finding binoculars allowed even with the battery removed. NO RANGEFINDERS , Period!
 - E. Miscellaneous:
 - 1) Cubs and Peewees will shoot field points only
 - 2) Parents will be responsible for the supervision of their children at all times.
 - 3) All protests to the Protest Committee will be in writing within thirty (20) minutes of the end of the tournament each day an include a \$25 fee which will be returned if the protest is upheld.
 - 4) There must be a minimum of three shooters per target at all times.
 - 5) Top shooters from each style will be grouped on the 2nd day of the tournament. Clubs and Peewees will not be allowed to shoot in top flight groups. NO EXCEPTIONS
 - 6) No target or sight notes allowed (sight tapes ok)
 - 7) No discussion of yardage prior to shooting. Discussions afterwards must be done in a manner to ensure that other archers who haven’t shot will be assisted .
 - 8) No one is allowed on the tournament course before or after the tournament shooting hours except for tournament officials
 - 9) Spectators will only be allowed with unanimous approval of the group.
 - 10) Rule violations can result in disqualification.
 - 11) No cell phone, computers or any other electronic devices allowed on the range or bow.
 - 12) Tournament officials will have communication devices for emergencies and range duties.
 - 13) Unsportsmanlike conduct can result in disqualifications.
- 7) Broadheads must be dulled and meet Fish & Game Codes at all times during the shoot—No Mechanical/Expandable Blades period!
- 8) Practice blades are allowed if they meet Fish & Game Codes (7/8 minimum diameter
- 9) Broadheads may be subject to size testing at any time during the tournament.
- 10) All bows shall be limited to 300 fps with a 3% tolerance for differences in chronographs.
- 11) Arrow speed may be checked anytime during the tournament.
- 12) Longbows: any type of arrow shaft is allowed.
- 13) Longbows: must be shot off the shelf
- 14) Clickers allowed in all styles.

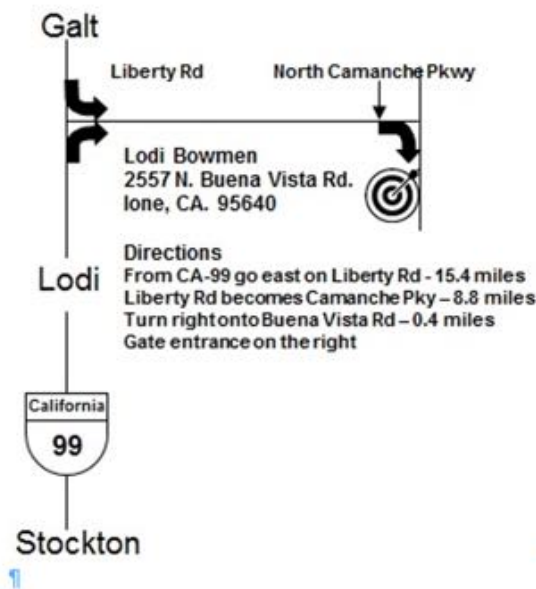
