
I hope not to steal Jim Clawson's thunder here, but we just recently held the new CBH/SAA State

Marked 3D Championship at Cougar Mountain. Once again, work got in my way but I understand a good time was had by all. I would like to thank Dan Stafford for presiding over the State portion of this piggybacked event. After talking with Jim at the President's meeting he tells me they had 80 plus shooters knock out both events. This is a huge success for a first time event. A big thanks to the entire Cougar Mountain team for hosting. We will be looking forward to the State Marked again in 2020. More to follow from the CM group later in the newsletter.

I want to leave a quick reminder about the State 900 coming in September. The 900 will be run at various locations throughout California in the month of September. As I read it, the USAA event will be September 21 and 22 so we might lose a few shooters, but the 900 should be available on some weekend date for you to shoot. All of the venues are ready

and should provide you a quality shoot and give you opportunity to put up a big number! Get the kids going and come on out to a range near you!

I wanted to remind all of our ranges, clubs and hosts to please pay attention to your charters and range inspections. It is our responsibility as tournament hosts to see to it that the range has current inspection and charter. It is against our rules to hold any state championship level tournament at a range that is not chartered and inspected by CBH/SAA and its national affiliate NFAA. Dawnel Scott will be calling and checking with all of the shops as we approach the 2020 State Indoor and making sure the shops are current. It is the responsibility of club Range Captains and regional Presidents to get the outdoor ranges current. I also want to remind all tournament directors and chairpersons to refresh themselves with the rules as stated in NFAA and CBH/SAA.



Please make sure that your shooters are following the rules and that you are giving appropriate opportunity to file a protest if needed. There have been more than a few complaints about certain venues being more lax or stringent about rules than others. The multi-site tournaments are always difficult as the 2nd VP's are not always available, but we need to make sure that the competition in classes and age groups are as fair as possible.

Please make your calendars for October the 1st. October 1 is the deadline for any petitions for changes in the bylaws. Those petitions should be discussed with the regional President and delegates and submitted properly

to the Secretary of CBH/SAA. I will tell you that the by-laws and standing rules are the regulations that we go by when deciding issues having to do with CBH/SAA members and tournaments. If you are unhappy with the rules then present a change and we will discuss and decide. Remember that involvement is the key to our success as a group. The team will not succeed with you sitting on the sideline. Also note that 2 offices are up for re-election this year and that is President and 2nd VP of Hunting. If you wish to run for office or know someone that does then have them nominated through the regular process in your region. Every head of household has a vote and election results will be concluded at the state meetings in January.

Now for a touchy subject. We hold multiple CBH/SAA State Championship tournaments every year.

2019 State Broadhead Championship

On Saturday and Sunday, May 18 &19, 2019, I participated in the California Bowman Hunters (CBH) annual 'Broadhead Championship'. This is an annual event where competitors shoot with broadheads rather than target points. This is a 3-D target shoot which is not very common when using broadheads because of the toll it takes on the targets. Targets are only good for a limited number of years due to the damage done by the razor tipped arrows, with some targets costing over a thousand dollars each you can see the problem.

The event was held again this year at the Tejon Ranch about eighty miles north of downtown Los Angeles. If some other club has the facilities and would like to host next years shoot I'm sure that the CBH planning committee would be interested in hearing from you. The weather was a bit foul this year, but not as bad as last year. I arrived on Thursday to set up camp and it was very cold, windy and rainy and remained the same all through Friday. On Saturday the weather improved and it was nice with some cloud cover and a little breeze. On Sunday it was colder but it only sprinkled on and off during the shoot. Fortunately my squad finished shooting before it started to rain harder. There were 185 competitors, about the same as last year. Thirty-eight others who had pre-registered did not show up. I think the weather predictions kept a lot of people away after last years miserable Saturday.

The shoot is forty-two targets on Saturday and then another forty-two on Sunday with the top shooters 'flighted' with their peers to make sure everything is on the up and up with score keeping.



This year there were separate shooting stakes for Compound, Recurve, Longbow/Youth and Cub. The targets or shooting stakes are moved on the second day so that the target presentation is different. The scoring was 10,8, 5, with 840 points possible over the two days. This year was the first time that kids were allowed to compete but they shot with field points under the supervision of adults.

Can you imagine children running around with razor tipped arrows, it's bad enough letting me do it. I didn't hear of anybody getting cut this year, but it does happen, one friend of mine cut his pants and apparently also his bow string this year.

This is one of four California State Shoots that leads to winning the annual Grand Slam if you place #1 in all four during a single year. The others are the 900 round, the State Field Shoot, and the State Indoor. If you hunt with your bow and want and opportunity to practice with your hunting equipment this is the place to do it.

2019 Lake Isabella Carp Tournament

On June 8-9, 2019, I participated in the 2019 California Bowman Hunters (CBH) Small Game Club's bow fishing Carp Tournament at Lake Isabella, CA. Lake Isabella is about one-hundred and fifty miles north of Los Angeles. The weather was in the low 90's and the wind which had been howling on Friday decided to give us a break for the weekend. The water in the lake was fairly high due to the winter rains. The shoot commenced at sunrise on Saturday and Sunday and concluded at noon on Sunday. If you're not at the weight-in site at noon you are disqualified.

This years tournament had about twenty competitors some fishing off of boats and some from the shoreline. Unfortunately for those hunting from shore the fish were absent and I don't think anyone even saw a carp. Those of us shooting off of boats faired a little better and got some fish which were out towards the center of the lake lurking around the partially submerged trees and out in the deeper water.



Once again this year Rodger Cady, at 83, invited Karen Freed and me to join him on his seventeen foot Tracker fishing boat. We've done this for the past several years and we seem to make a good team working together to hunt down the fish and bring them on board the boat. I usually handle the killing and removing the fish from arrows while Karen handles the net. Rodger captains the boat and deftly maneuvers it with the tiller and trolling motor.

When all was said and done I took second place for the most total weight of fish taken and Rodger won first place for the biggest fish at 9lbs 5oz. The fishing this years wasn't great but that's why they call it fishing not catching. If you've never given bow fishing a try you should give it a whirl. It can be a lot of fun when you get into the fish and a little frustrating when you don't, but that's just the nature of the game.

A Wildlife Resources Committee was held Tuesday September 10th in Santa Rosa. No agenda has been posted at this time.

Legislation 2019/2020, below is a list of bills within the state legislature that we are tracking and providing comment on. This is just a partial list of bills in the state legislature that could affect sportsmen.

AB 18 (Levine) – Firearms: Excise Tax, would add additional cost to purchasing a firearm. AB 18 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 18 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session.

AB 44 (Friedman) – **Fur Products: Prohibition,** make it a crime to sell, offer for sale, display for sale, trade, give, donate, or otherwise distribute a new fur product in the state. The bill would also make it illegal to manufacture a fur product in the state. *AB 44 is now in the Senate Natural resource Committee*

AB 273 (Gonzalez) – Recreational and Commercial Fur Trapping: Prohibition, would make it illegal to trap any furbearing mammal or nongame mammal for purposes of recreation or commerce in fur; prohibit the purchasing or sale of raw fur, as well as products or handicraft items made from fur-bearing mammals and nongame mammals; and recast the authorization provided by a trapping license to only apply to the taking of furbearing mammals and nongame mammals, and remove the authorization of the sale of raw fur. AB 273 would also eliminate fur dealer and fur agent licenses. Now on the Senate side, the bill has been referred to the Senate Natural Resources and Water Committee.

AB 276 (Friedman) – **Firearms:** Storage, would require a person who is 18 years of age or older and who is the owner,lessee, renter, or other legal occupant of a residence to ensure that any firearm that person owns or controls is securely stored against theft or unauthorized access while that person is outside that residence.

The bill defines a firearm as being "securely stored" if it is secured with an operable device that is listed on the Department of Justice's roster of approved firearm safety devices and that is identified as appropriate for that firearm by reference to either the manufacturer and model of the firearm, or to the physical characteristics of the firearm that matches those listed on the roster for use with the device. *Failing to meet the legislative deadline*.

The bill defines a firearm as being "securely stored" if it is secured with an operable device that is listed on the Department of Justice's roster of approved firearm safety devices and that is identified as appropriate for that firearm by reference to either the manufacturer and model of the firearm, or to the physical characteristics of the firearm that matches those listed on the roster for use with the device. Failing to meet the legislative deadline.

AB 276 is now a "two-year bill" and cannot be heard until the 2020 Legislative Session.

AB 284 (Frazier) - Junior Hunting Licenses: Eligibility: **Age Requirement,** In 2014, AB 1709 – legislation authored by Assembly Member Jim Frazier (D/11-Fairfield) was signed into law which increased junior hunting license age eligibility from 15 to 17 years of age. However, that legislation included a "sunset" provision which requires the age eligibility to revert to 15 years on July 1, 2020, unless the provision is extended by subsequent legislation. As revised March 26th, AB 284 – legislation also authored by Assembly Member Jim Frazier - would extend the junior hunting license age eligibility of 17 years indefinitely. AB 284 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 284 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session. Recognizing the importance of extending the junior hunting license age eligibility to the R3 Program and the need to do so prior to the July 2020 sunset, the bill's sponsor, California Waterfowl Association and Gaines and Associate is working to find another viable vehicle to move this proposal forward during the 2019 Legislative Session. AB1305 was gut and amended with this bills language to move forward this year. Bill is in the Senate Rules committee.

AB 584 (Gallagher) – Sport Fishing Licenses As introduced, AB 584 by Assembly Member James Gallagher (R/03-Yuba City) remains a "spot bill" that, as introduced, makes non-substantive amendments to a provision of the Fish and Game Code which deals with sport fishing licenses. Pursuant to Assembly Rules, AB 584 cannot be referred to a committee until it takes on substantive amendments. Missing legislative deadline, AB 584 is now a "two year" bill at best.

AB 688 (Chu) – Firearms: Vehicle Storage Current law requires that a handgun in an unattended vehicle be either locked in the vehicle's trunk, in a locked container out of plain view, locked in a container that is permanently affixed to the vehicle's interior and not in plain view, or locked in a toolbox or utility box.

As introduced, AB 688 would make those requirements applicable to all firearms and would require the firearms to be secured to the vehicle's frame using a steel cable lock or chain and padlock, or in a locked container that is secured

using a steel cable lock or chain and padlock or that is permanently affixed to the vehicle. AB 688 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 688 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session

AB 1254 (Kamlager-Dove) – Bobcats: Take Prohibition would, until January 1, 2025, fully prohibit the hunting of bobcats. Commencing January 1, 2025, AB 1254 would reauthorize the Fish and Game Commission -- through its normal mammal hunting rulemaking process -- to reopen a bobcat hunting season in any area determined by the Commission to "require" a hunt. The language of the bill specifies that, in doing so, the Commission shall consider the potential impacts of a bobcat hunting season, including: 1) bobcat populations; 2) bobcat wild prey; 3) disease abatement; 4) the control of invasive species, especially nutria; 5) consideration of public values with regard to the hunting of bobcats; and 6) the administrative, implementation, and enforcement costs to DFW and the Commission associated with bobcat hunting. Regardless of the bill's unreasonable price-tag, in Senate Natural Resource Committee

AB 1387 (Wood) – Sport Fishing Licenses: 12 Consecutive Month Licenses would, in addition to offering California residents a traditional calendar year fishing license, require DFW to offer a license that is valid for 12 consecutive months beginning on the date of purchase upon payment of a fee that is equal to 130% of the cost of the traditional calendar-year sport fishing license. AB 1387 would require DFW to provide applicants for these licenses the option of signing up for automatic renewal of the license by electronic payment and would set the fee for licenses issued upon automatic renewal at the same price as a calendar-year sport fishing license. Bill in now in Senate Natural Resources Committee.

SB 395 (Archuleta) – "Wildlife Traffic Safety Act" would improve public safety and help protect our wildlife resources by reducing the frequency of vehicle-wildlife collisions on California's roadways. Coined the "Wildlife Traffic Safety Act", SB 395 would also help clean California's roadways, while reducing the needless waste of a healthy, free-range wild food source. This legislation is sponsored by the California Deer Association with the assistance of Gaines & Associates, and in coordination with the Road Ecology Center at the University of California at Davis. Passed Senate and no in Assembly Water, parks and wildlife committee
