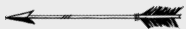

I regret to inform everyone that the CBH/SAA Executive Board has voted to cancel the State 900 Target Championship for 2020. 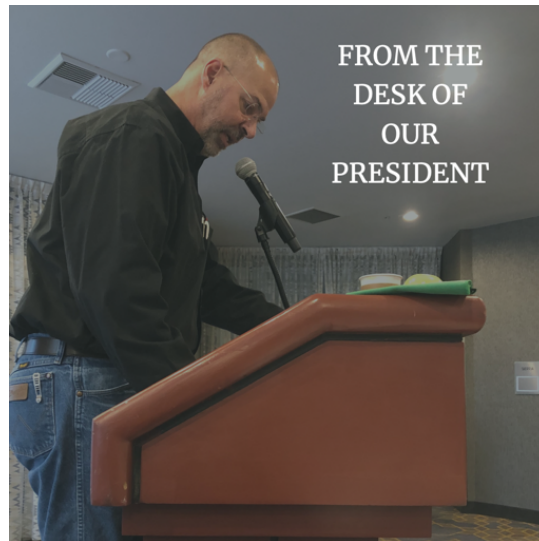

## Legislative Information

The last FGC meeting was held June 24 and 25 as a teleconference meeting. Meeting agenda highlights DAY 1 – June 24, 2020, 10:00 AM 16. Strategic planning review provided by Commissioners and the public regarding potential revisions to the mission and draft goals. Potentially adopt draft goals and a revised mission statement, and provide direction on a draft plan. Staff will recommend that this item be continued to a future meeting. DAY 2. Duck Stamps Consider approving proposed projects for the Duck Stamp Dedicated Account funds in Fiscal Year 2020-21. 24. Department informational items (wildlife and inland fisheries) The Department will highlight wildlife and inland fisheries items of note since the last Commission meeting. (A) Director’s report I. Update on actions taken after May 14, 2020 pursuant to the emergency sport and recreational fishing regulations that expired on May 31, 2020 (B) Wildlife and Fisheries Division, and Ecosystem Conservation Division I. Update on the Strategic Surveillance Plan for the Treponeme-Associated Hoof Disease in California 25. Wildlife Resources Committee Discuss updates and recommendations from the May 14, 2020 committee meeting. Consider approving new topics to address at a future committee meeting. 26. Simplification of statewide inland fishing Consider authorizing publication of notice of intent to amend inland sport fishing regulations (Add sections 5.84, 5.89, 7.40, and amend sections 3.00, 4.00, 5.00, 5.41, 5.85, 7.00, 7.50, and 8.10, Title 14, CCR) 28. Riparian brush rabbit Receive overview of the Department’s five-year status review of riparian brush rabbit (*Sylvilagus bachmani riparius*), which is listed as an endangered species under CESA (Pursuant to Section 2077, Fish and Game Code) 29. Wildlife Prosecutor of the Year, announce recipient of the Commission’s annual Wildlife Prosecutor of the Year award, consistent with the Commission’s policy adopted in 2016. 30. Petition #2020-005: Striped bass slot limits (B) Action on pending regulation petitions referred to staff or the Department for review – None scheduled at this time 32. Wildlife and inland fisheries items of interest from previous meetings, these items are generally updates on agenda topics recently heard before the Commission. (A) Discuss urban coyote issues Staff will recommend that this item be continued to a future meeting. (A) Next meeting – August 19-20, 2020 in Fortuna, Adjourn

#### Legislation

**AB 1387** (Wood) – Sport Fishing Licenses: 12 Consecutive Month Licenses; would, in addition to offering California residents a traditional calendar year fishing license, require

residents a traditional calendar year fishing license, require DFW to offer a license that is valid for 12 consecutive months beginning on the date of purchase upon payment of a fee that is equal to 130% of the cost of the traditional calendar-year sport fishing license. AB 1387 would require DFW to provide applicants for these licenses the option of signing up for automatic renewal of the license by electronic payment and would set the fee for licenses issued upon automatic renewal at the same price as a calendar-year sport fishing license. **Update: Now on the Senate side, AB 1387 has been referred to the Senate Natural Resources and Water Committee but has not yet been set to be heard. AB 1387 has until August 7, 2020 to meet legislative deadline for being heard and passed out of Senate policy committee.**

**AB 2106** (Aguiar-Curry) –Nesting Bird Habitat Incentive Program: Upland Game Bird Stamp/State Duck Stamp. Legislation passed in 2018 required the Department of Fish & Wildlife (DFW) to establish the “Nesting Bird Habitat Incentive Program” and authorized DFW to make payments or provide other incentives to encourage landowners to voluntarily cultivate or retain upland cover crops or other upland vegetation on their idled lands to provide habitat and nesting cover for waterfowl, upland game birds, and other species. AB 2106 would help generate the funding necessary to implement the Nesting Bird Habitat Incentive Program by raising the California upland game bird stamp and the state duck stamp by \$5 each. AB 2106 would also create the Nesting Bird Habitat More on page 6

Incentive Subaccount within the California Waterfowl Habitat Preservation Account and require the incremental revenue to be deposited in that Subaccount and available upon appropriation to DFW for the Nesting Bird Habitat Incentive Program.

**Update:** AB 2106 passed the Assembly and is now in the Senate AB 2106 has not yet been set for hearing in Senate Natural Resources and Water Committee.

**AB 2523** (Gray) – Fish and Game Commission: Youth Hunting Program: Special Hunting Permits As amended May 6, 2020, AB 2523 by Assembly Member Adam C. Gray (D/21-Merced) would require the California Fish and Game Commission to establish a program to increase opportunities to hunt big game, upland game birds and migratory game birds for youth under the age of 18 with terminal illnesses or who lost a parent in service to the state or country. AB 2523 defines “in service to the state or country” as a person who died while actively serving in the Armed Forces or in local, state, or federal law enforcement or fire service. The legislation defines “terminal illness” as an incurable or irreversible condition with a corresponding life expectancy that does not exceed 60 months.

The bill would require the Commission to report any findings to the Legislature and the Governor on or before January 1, 2022, on the progress of the program.

**Update:** AB 2523 is being held under submission in Assembly Appropriations Committee.

**AB 3022** (Oberholte) – Junior Hunting Licenses: Age Eligibility

Legislation passed in 2014 increased junior hunting license age eligibility from 15 to 17 years of age. However, that bill included a “sunset” provision which requires the age eligibility to revert to 15 years on July 1, 2020 – the beginning of the upcoming 2020/2021 hunting license year – unless the provision is extended by subsequent legislation.

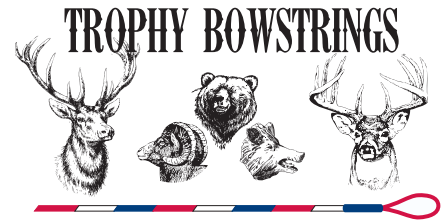
As introduced, AB 3022 by Assembly Member Jay Oberholte (R/33-Hesperia) proposes to extend the “sunset” for one year to July 1, 2021. To have the bill take effect before the 2020/2021 license year begins on July 1, 2020, AB 3022 also includes an urgency statute which states the bill will take effect immediately upon enactment. **Update:** AB 3022 has been held under submission in Assembly Appropriations Committee.

**SB 1175** (Stern). Animals: prohibitions on importation and possession of wild animals: live animal markets. **Update:** Passed out of the Senate and now in Assembly, read first time and held at desk.

that is new to archery deer hunting in California please be aware that early archery seasons will see plenty of very hot days. Plan accordingly with clothes and plenty of water.

Not a huge legislative update here as Robert Moore will have more detail in his report, but things are progressing about as normal. We do have one ugly piece of legislation pending approval which would outlaw the importation of any part of several African big game species into California. CBH/SAA has voiced its strong opposition to this bill as have most conservation organizations in the state and country. This bill looked doomed until the author tied a prohibition on “wet markets” to the bill and the thing really grew legs. With the current COVID climate in California, it easily passed the Senate and is on to the House where we believe it will ultimately be passed. Not a good thing for any California archers headed to Africa for a hunt. All that being said I would encourage all of us to contribute wherever you can to traditional conservation organizations. With the COVID crisis ongoing it has been very difficult for any one organization to hold the traditional fundraisers. I recently saw that California Waterfowl is laying off 10 percent of its staff due to reduced revenue. CBH/SAA has been able to maintain a strong balance sheet as most of our labor is volunteer, but most organizations will hold out only so long. Let's all continue to support those that support wildlife conservation in California.

In closing I will say the same thing that I have been saying, please be patient with your local shops and clubs. Everyone is under different land and lease agreements and all are trying to open up as quickly as possible. As of this writing it looks like the government may have us doing this whole thing again if COVID numbers don't improve. Keep in mind that hunting big game may be the best social distance activity ever so get out there next month and enjoy! Until next month please be safe and shoot em straight.





## CALIFORNIA BOWMEN HUNTERS BIG GAME CLUB POSITION STATEMENT

The California Bowmen Hunters-Big Game Club (CBH-BGC) has historically utilized the Boone & Crockett (B&C) / Pope and Young (P&Y) Measuring system (copyrighted 1887) to record trophy animals taken with a bow and arrow in California. CBH-BGC received copyrighted, but revocable, permission many years ago to utilize not only their scoring system, but their score forms, affidavits, and use of the term 'Fair Chase'. Both P&Y and B&C require an almost identical code of conduct and ethical requirement listed under their respective Fair Chase Affidavits for any animal submitted to their record programs.

On June 14, 2020, your CBH-BGC voted unanimously to continue to align with Pope and Young and Boone and Crockett's Fair Chase requirements and measuring system. Under their rules of "Fair Chase" neither club allows any animal harvested using electronic rangefinding bow sights (Garmin, Burris, IQ, etc.) for entry into their records program. This would violate number III of B&C's Fair Chase Affidavit, as well as #7 of P&Y's Fair Chase Affidavit. While the use of such electronic sights may be legal in California, they, unfortunately, will not be accepted into the CBH-BGC records program, as they clearly violate our rules of Fair Chase. This should, in no way, minimize the trophy taken or the hunter who utilizes such equipment; we (CBH-BGC) simply must maintain the integrity of our records program and continue to practice and encourage Fair Chase.

### **The Rules of Fair Chase for P&Y and CBH-BGC:**

*The term "Fair Chase" shall not include the taking of animals under the following conditions: ()*

- 1. Helpless in a trap, deep snow or water, or on ice.*
- 2. From any power vehicle or power boat.*
- 3. By "jacklighting" or shining at night.*
- 4. By the use of any tranquilizers or poisons.*
- 5. While inside escape-proof fenced enclosures.*
- 6. By the use of any power vehicle or power boats for herding or driving animals, including use of aircraft to land alongside or to communicate with or direct a hunter on the ground.*
- 7. By the use of electronic devices for attracting, locating or pursuing game or guiding the hunter to such game, or by the use of a bow or arrow to which any electronic device is attached with the exception of lighted nocks and recording devices that cast no light towards the target and do not aid in rangefinding, sighting or shooting the bow.*
- 8. Any other condition considered by the Big Game Committee as unacceptable.*

In closing, the Fair Chase concept extends beyond the hunt itself; it is an attitude and a way of life based in a deep-seated respect for wildlife, the environment, and for other individuals who share the bounty of this vast continent's natural resource.

## HUNTING HERITAGE - WHAT'S YOURS ?

Back in the day, is a saying we've heard many times. And when we put that into the context of hunting; it may or may not be that you had a "history" of hunting or what is referred to here as *Hunting Heritage*.

Before walking down memory lane with me, let's preface the entire reading by remembering that hunting is a privilege and NOT a right. We have NO promises and thus must exercise our hunting in the most ethical and positive manner as individually possible. As Boone and Crockett state in one of their "*Position Statements*" it should be the pursuing and not shooting or killing that draws one to the field. My *Hunting Heritage* is rich and I am able to trace it back (verified by photos) into

the early 1900's,... circa 1919. That would calculate into me being a at least a fourth generation hunter. My Great Grandpa George York Taylor Osterburg is pictured here in what is currently part of the Santa Monica Mountains, where homes now abound. It was through his tutoring my grandfather Kenneth York became bitten with the passion for the adventure of the mountains. However, this passion was not limited to the masculine side of the family. In a day when few women attended universities my grandma Alva taught Japanese students at UCLA and went on "*men's hunting trips*". Her first trip she begged to accompany her husband to the famed (by Teddy Roosevelt) Kaibab. She owned no rifle, but upon spotting a splendid non-typical buck at nearly 300 yards distant she proclaimed she could easily make the shot count. Her husband handed her the new 250-3,000 and told her, "*Prove it, and the rifle is yours*".

Well, when returning home Kenneth had to purchase a new Savage twin - the lever action 300. My father, and both uncles were not exempt from the luring of the mountains either. All of them enjoyed each others company throughout their life times. Grandma Alva enjoyed her last hunting trip with her grandson at the age of eighty-four. On the trip, yours truly placed her where he knew two huge 4 point bucks would travel shortly before night fall. As time passed and the shadows gave way to the dark, no shot had been fired. The author was perplexed and upon seeing her still seated where he had left her, questioned if any bucks

From page 11-had shown up. She excitedly explained two nice fat bucks had indeed approached and fed less than a hundred yards away. Still interested (and convinced it had been been the four points) she was questioned why she hadn't shot one of the bucks. She related she could see the huge racks but couldn't make out the forks that made them legal to harvest. That remains one of the most ethical and positive individual choices I have encountered a hunter make. Last of all, my father made an ethical choice a concrete lesson. My brother and I had accompanied him on the last weekend of season to hunt the high country. We were returning home "empty handed" and turned onto the dirt road which lead to our house. There at the bottom of the hill the trucks' lights illuminated a monster buck. Dad stopped the truck and we watched as the buck fed away and into obscurity. "Too bad we didn't see him before dark", dad stated. Indeed hunting is a privilege and we want to pass along a commitment to "Fair Chase" and a heritage of pursuing game in "the hunt".

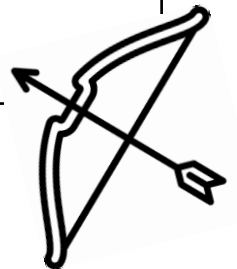

# Grilled Marinated Rabbit

With Rabbit season started July 1st, now is a great time to get cooking!

Enjoy this great BBQ recipe you can enjoy at home or in the field.

## Ingredients

- 1 or 2 preferably a wild Rabbit.
- 1 handful fresh thyme and rosemary, leaves picked
- 4 cloves garlic, peeled
- olive oil
- 1 lemon
- 1 teaspoon honey
- 4 thick slices higher-welfare pancetta
- Salt & Pepper

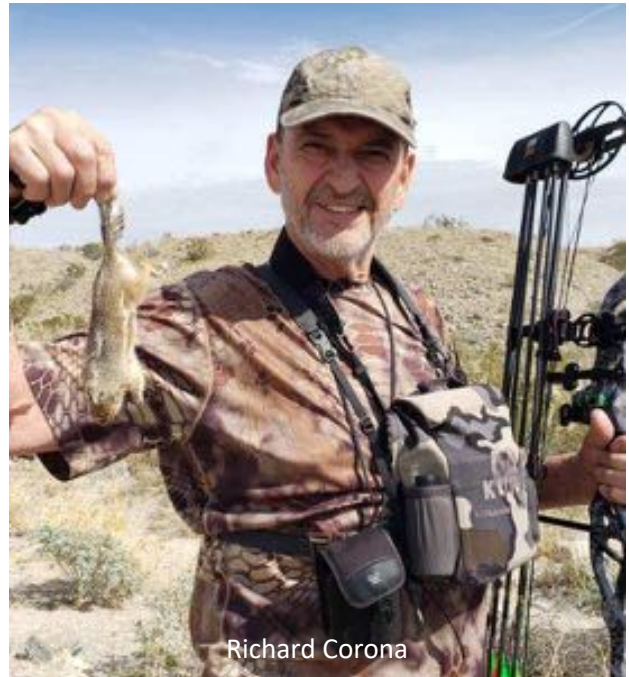


Grilled Rabbit

## Method

1. *I've written this recipe to be cooked on the barbecue, because the flavour will be amazing, but it also works really well when roasted in the oven at 200°C/400°F/gas 6. If you cook it in the oven, turn the pieces of rabbit several times to ensure even colour and cooking. If you cook it on the barbecue, you'll need 5 wooden or metal skewers (soak wooden ones before you use them). Whether barbecuing or roasting, here are your rough timings:*
2. *Belly: 25 to 30 minutes.  
Kidneys and liver: 4 minutes.  
Saddle and ribs: 15 to 20 minutes.  
Legs and shoulder: 35 to 40 minutes.*
3. Put your rabbit pieces into a bowl. Using a pestle and mortar, or a liquidizer, bash or whiz up the thyme and rosemary leaves to a pulp, then add the garlic cloves and bash or whiz again. Stir in 8 tablespoons of olive oil, the lemon zest and juice and the honey, and pour this over the rabbit. Put the meat to one side and let it come to room temperature while you light your barbecue.
4. Now I'm going to talk about flavour. Get a couple of sprigs of fresh thyme and tie them together like a little brush. Each time you turn the meat, dab it with a little of the marinade to give you a lovely encrusted layer of flavour. This rabbit is going to be really tasty!
5. Keeping the marinade to one side, remove the pieces of meat and season with salt and pepper. Sandwich the pancetta between the 2 pieces of belly using 3 skewers. Put the legs and shoulder on the barbecue. When they've been cooking for 10 minutes, put the belly on. After another 10 minutes put the saddle and ribs on. Make sure you turn the meat over every so often. Look after it by controlling the temperature and basting it continuously with the marinade. Cut three-quarters of the way through each kidney and open them out like a book. Cut the liver into 4 pieces and push one piece on to each remaining skewer, followed by a kidney and more liver.
6. When all the pieces of meat are beautifully cooked, add your skewered bits of kidney and liver on to the barbecue and cook until golden, along with your 2 remaining slices of pancetta. After a few minutes, when the pancetta is browned, put it on top of the meat at the cooler end of the barbie. Now get your guests round the table.
7. You can serve the rabbit with any white beans, or roast potatoes, or grilled vegetables, or different salads – it really depends on how you feel and what the weather's like. Just put a big bowl of your chosen accompaniment in the middle of the table and serve all the meat on a board. Lovely with a glass of white wine. Simple, honest and bloody good.
