From previous FGC meeting, modified Title 14 section 354 to a 30lb minimum draw weight for big game and carry fire-

arm while bowhunting during an Archery Only season or Archery Only tag has finalized with the Office of Administrative Law approval. The firearm change doesn't apply for deer hunting due to language in Fish and Game code. The code can only be modified by the state legislature and there is no current bill to do so. Caution; if you're in possession of a deer tag and it's the archery season or Archery only tag but claim to be only bear hunting and possess a firearm, you could be cited but is dependent on the Wildlife Officer.

A Wildlife Resources Committee will be held Tuesday September 10th in Santa Rosa. No agenda has been posted at this time.

Legislation 2019/2020, below is a list of bills within the state legislature that we are tracking and providing comment on. This is just a partial list of bills in the state legislature that could affect sportsmen.

AB 18 (Levine) – Firearms: Excise Tax, would add additional cost to purchasing a firearm. AB 18 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 18 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session.

AB 44 (Friedman) – Fur Products: Prohibition, make it a crime to sell, offer for sale, display for sale, trade, give, donate, or otherwise distribute a new fur product in the state.

The bill would also make it illegal to manufacture a fur product in the state. *AB 44 is now in the Senate Appropriations Committee* **AB 273 (Gonzalez) – Recreational and Commercial Fur Trapping: Prohibition,** would make it illegal to trap any furbearing mammal or nongame mammal for purposes of recreation or commerce in fur; prohibit the purchasing or sale of raw fur, as well as products or handicraft items made from fur-bearing mammals and nongame mammals; and recast the authorization provided by a trapping license to only apply to the taking of furbearing mammals and nongame mammals, and remove the authorization of the sale of raw fur. AB 273 would also eliminate fur dealer and fur agent licenses. *Now on the Senate side, the bill has been referred to the Senate Natural Resources and Water Committee.*

AB 276 (Friedman) – Firearms: Storage, would require a person who is 18 years of age or older and who is the owner, lessee, renter, or other legal occupant of a residence to ensure that any firearm that person owns or controls is securely stored against theft or unauthorized access while that person is outside that residence. The bill defines a firearm as being "securely stored" if it is secured with an operable device that is listed on the Department of Justice's roster of approved firearm safety devices and that is identified as appropriate for that firearm by reference to either the manufacturer and model of the firearm, or to the physical characteristics of the firearm that matches those listed on the roster for use with the device. Failing to meet the legislative deadline.

AB 276 is now a "two-year bill" and cannot be heard until the 2020 Legislative Session.

AB 284 (Frazier) - Junior Hunting Licenses: Eligibility: Age Requirement, In 2014, AB 1709 - legislation authored by Assembly Member Jim Frazier (D/11-Fairfield) was signed into law which increased junior hunting license age eligibility from 15 to 17 years of age. However, that legislation included a "sunset" provision which requires the age eligibility to revert to 15 years on July 1, 2020, unless the provision is extended by subsequent legislation. As revised March 26th, AB 284 legislation also authored by Assembly Member Jim Frazier would extend the junior hunting license age eligibility of 17 years indefinitely. AB 284 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 284 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session. Recognizing the importance of extending the junior hunting license age eligibility to the R3 Program and the need to do so prior to the July 2020 sunset, the bill's sponsor, California Waterfowl Association and Gaines and Associate is working to find another viable vehicle to move this proposal forward during the 2019 Legislative Session. AB1305 was gut and amended with this bills language to move forward this year. Bill is in the Senate Rules committee.

AB 584 (Gallagher) – Sport Fishing Licenses As introduced, AB 584 by Assembly Member James Gallagher (R/03- Yuba City) remains a "spot bill" that, as introduced, makes nonsubstantive amendments to a provision of the Fish and Game Code which deals with sport fishing licenses. Pursuant to Assembly Rules, AB 584 cannot be referred to a committee until it takes on substantive amendments. Missing legislative deadline, AB 584 is now a "two year" bill at best.

AB 688 (Chu) - Firearms: Vehicle Storage Current law requires

that a handgun in an unattended vehicle be either locked in the vehicle's trunk, in a locked container out of plain view, locked in a container that is permanently affixed to the vehicle's interior and not in plain view, or locked in a toolbox or utility box.

As introduced, AB 688 would make those requirements applicable to all firearms and would require the firearms to be secured to the vehicle's frame using a steel cable lock or chain and padlock, or in a locked container that is secured using a steel cable lock or chain and padlock or that is permanently affixed to the vehicle. AB 688 was held in Assembly Appropriations Committee and not heard. Failing to meet the legislative deadline for passing out of fiscal committee to the Floor, AB 688 is now a "two-year" bill, at best, and cannot be heard until the 2020 Legislative Session

AB 1254 (Kamlager-Dove) - Bobcats: Take Prohibition would, until January 1, 2025, fully prohibit the hunting of bobcats. Commencing January 1, 2025, AB 1254 would re-authorize the Fish and Game Commission -- through its normal mammal hunting rulemaking process -- to reopen a bobcat hunting season in any area determined by the Commission to "require" a hunt. The language of the bill specifies that, in doing so, the Commission shall consider the potential impacts of a bobcat hunting season, including: 1) bobcat populations; 2) bobcat wild prey; 3) disease abatement; 4) the control of invasive species. especially nutria; 5) consideration of public values with regard to the hunting of bobcats; and 6) the administrative, implementation, and enforcement costs to DFW and the Commission associated with bobcat hunting. Regardless of the bill's unreasonable price-tag, in Senate Appropriations Committee

AB1305 (Olbernolte) - Junior Hunting Licenses: Eligibility: Age Requirement, see AB284 language above.

In Senate Rules Committee

AB 1387 (Wood) – Sport Fishing Licenses: 12 Consecutive Month Licenses would, in addition to offering California residents a traditional calendar year fishing license, require DFW to offer a license that is valid for 12 consecutive months beginning on the date of purchase upon payment of a fee that is equal to 130% of the cost of the traditional calendar-year sport fishing license. AB 1387 would require DFW to provide applicants for these licenses the option of signing up for automatic renewal of the license by electronic payment and would set the fee for licenses issued upon automatic renewal at the same price as a calendar-year sport fishing license. Bill is now in Senate Natural Resources Committee.

SB 395 (Archuleta) – "Wildlife Traffic Safety Act" would improve public safety and help protect our wildlife resources by reducing the frequency of vehicle-wildlife collisions on California's roadways. Coined the "Wildlife Traffic Safety Act", SB 395 would also help clean California's roadways, while reducing the needless waste of a healthy, free-range wild food source. This legislation is sponsored by the California Deer Association with the assistance of Gaines & Associates, and in coordination with the Road Ecology Center at the University of California at Davis. Passed Senate and is now in Assembly Appropriations committee.

As a young boy, Don got interested in archery by watching cowboy & Indian movies on tv. He had his first bow, a starter fiberglass bow, at eight-yearsold. When the original string broke, he had to keep going so he used a boot lace as a string.

Don's interest in archery turned to the FITA style and whenever he could, he would shoot 100 arrows a day to hone his skills and it worked. He had won many CBH/SAA Indoor and Outdoor Championships as well as with National titles.

Don attended San Bernardino Valley College and was a four time All American and was National Collegiate Champion in 1975. By 1976, Don was hired to work at Easton. He continued at Easton until he retired as Vice President after 42 years with the company.

In 1986, Don won the National Archery Association Trials in Oxford, Ohio. This gave him the first spot on the U.S. Team for the America's Tournament in Rio De Janeiro. He went on to defeat the 1984 Gold Medalist.

Don has been involved with world archery for many years. He was the Archery Competition Director for the 1984 Los Angeles Olympic Games, Competition Director for the 1983 World Championships and Competition Director for the US Nationals. Don had also served on the Board of Governors for USA Archery for over 12 years.

He is also an author and inventor with 3 patents. He wrote the Easton tuning and maintenance guide and collaborated on several archery history books and produced technical archery articles for various publications. He had also created many Easton spine charts for over 30 years.

Don is also known over the world for his seminars. He has presented in over 40 countries, teaching the technical aspects of Olympic style archery.

Don had received the World Archery Bronze Plaquette for outstanding service to the sport of archery.

He will always be known as a terrific shooter, teacher, coach, promoter and the nicest person you would ever want to meet!

Craig Fritz 2020 Inductee CBH/SAA Hall of Fame

Craig began shooting a bow in the early 1980's when he was given a bow for Christmas. It wasn't long after that, that he, his family members and guys from work set out to bow hunt goats and pigs on Catalina Island. He was soon introduced to 3D shooting and target archery, and of course this led to the administrative side of archery.

He joined CBH and NFAA, Conejo Valley Archers and started attending the Southern California Archery Association region meetings. He was President, Secretary and Chairman of the US Country Classic for 2 years, spearheaded the securing of the lease for the current home at Tapo Canyon Park. He had also served as SCAA Legislative Representative.

Craig was elected as the 2nd VP Hunting in 1995. He wanted to bring target archers and bowhunters together again and did. He worked hard for the Big Game Club and the CBH/SAA Broadhead Tournament. He held this position until 2018.

Craig created the now known "\$10,000 Drawing" for the Broadhead Tournament inspired by Rocky Chisholm. From those funds, CBH/SAA programs thrived; The Legislative Defense Fund, Hall of Fame, numerous regions and many others. He created the computer database for the Big Game Club membership.

He also created the Whitney Hill Award, Category E., created the Big Game Club Lifetime Achievement Award, Chaired 11 of the Big Game Banquets and Awards Dinner, Editor of the Big Game Club Records Book, Co-Chaired the BGC Records book.

Craig was the Chairman of the BGC and brought back the financial solvency to the BGC within one year. Also while chairman, the Broadhead Tournament was moved from cardboard targets to 3D's. He led the charge to raise \$18,000 for the CBH/SAA Legislative Defense Fund in the battle over Burbank.

He led the movement by the BGC to create the Tule Elk category in the Pope & Young Club.

Along with "chairing" committees and leading the charge for bow hunters and target archers, he

actually did shoot a bow for target and was recognized as the NFAA Southwest Section Champion in BHFSL and also won a BGC Two Year Competition with a 78-0" Pronghorn Antelope (#5 at the time recorded).

Other memberships; South Bay Archers, Life Member of CBH/SAA and NFAA, Official Measurer for CBH/SAA, Member of Boone and Crockett, Official Measurer of Boone and Crockett Club, Member of Pope & Young Club, Official Measurer of Pope & Young Club, Life Member of the NRA and Life Member of the North American Hunting Club.

Now, Craig can add one more membership...a member of the CBH/SAA Hall of Fame.






