# Jim Cox Newest Recipient of CBH/SAA Big Game Club Lifetime Achievement Award

The CBH/SAA Big Game Club awarded a Lifetime Achievement Award to Jim Cox of Salinas, California. The award was presented on May 25<sup>th</sup>, as part of the Saturday night festivities at the 2016 CBH/SAA State Broadhead Championship at the Lodi Bowmen range. Jim was unable to attend due to family commitments but was contacted by cell phone to receive his award in front of the gathered crowd.

Jim started in archery at the age of five years old. He has hunted in many different states and countries during his career and his preferred hunting style is "still hunting". Only twice has he used a tree stand and both times to take whitetail bucks. He loves the excitement and interaction of still hunting and it fits the terrain of the areas that he prefers to hunt. He has taken big game and small game animals in 16 different states, plus Africa, Australia, and Mexico. He has successfully taken Merino sheep and island hogs on Santa Cruz Island, as well as Spanish goats, island hogs, and buffalo on Catalina Island.

### President's Message-by Wayne Raupe

This is going to be another short message, even shorter than last month. I have been off the grid for three weeks while elk hunting in Utah. I'm currently sitting in one of Earl (EW) Williams's tree stands. I have an either sex tag but it only allows me to shoot a cow or spike. I am VERY fond of elk meat so a cow or spike will fit the bill nicely but alas none have happened by the stand I'm in. However, on the other hand I am, at this moment, watching four bull elk sleeping at a mere 80 yards from me. They came in silent... how 4 bull elk can do that is beyond me. I just happened to be scanning the edge of the dark timber when I saw a head move, then antlers and then three more bodies, heads and antlers. A small bachelor herd. I watched a couple of them, the 6x6 and the 5x5 sparred for a little bit, tapping and clicking antlers, then the all bedded in the shadows of the big pine

Being a bow hunter brings the best of nature up close and personal but last night was almost too personal! At 7:20pm I watched a doe and her spotted fawn feed below my stand. They fed out to my left to about 50 yards then they bolted and ran past my tree stand. Thinking that was a little strange I watched the area where they were feeding. Soon a mother black bear and her 1 ½ year old cub sauntered into view. The sow was a good 300 pounds and the cub was pushing 80 pounds. They padded along on the trail that I followed as I entered the area. At approximately 15 yards from my stand the sow turned and moved directly toward the tree where I was perched. She continued sniffing the air as she came. She walked directly to my tree and sniffed the bottom step leading up the tree then looked up directly up into my eyes. She turned and started walking away in a very deliberate, aggressive and defiant manner looking over her shoulder at every step until she and her cub had put 80 yards between us then they loped off out of sight. By the way, I have that all on video. Cell phones are the bomb!!! All is good and exciting in the mountains of Utah!

On to more important stuff. As a CBH/SAA member it is imperative that you help protect our sport, including all other outdoor sports. Remember the November elections are coming up and if you haven't registered to vote or if you have moved



since you last voted you need to re-register so that you can cast your ballot for the individuals that are going to protect your archery, hunting, gun rights and all rights guaranteed to you by your State and US Constitutions. Legislative Information

### Legislative Information

The next Fish and Game Commission (FGC) meeting will be held August 24 and 25 in Folsom, Ca. Agenda has not been posted at the writing of this article. Upland bird regulation changes that include requiring the use of broadheads for turkeys should be finalized at this meeting.

The next Wildlife Resources meeting will be September 21st in Woodland Ca. Agenda has not been posted at the writing of this article.

State legislation for the current cycle has a few bills remaining. These have been listed in previous articles using Gaines and Associates Leg reports to keep us up to date. These reports are also on our website under the Legislative link. Below are listed bills and a brief synopsis, for more information on these bills you can view at http:// leginfo.legislature.ca.gov/

AB 499 (Cooley) – Archery Hunting: Concealed Firearm, In June, with the bill having met all of the necessary legislative deadlines, Assembly Member Cooley choose to gut the bill's original text and replace it with language which now deals with earthquake insurance.

AB 1792 (Wood) - Elk Tags: Federally Recognized Tribes, After much effort, in late May, AB 1792 was substantially watered down to, among other things, delete the language which authorized the Commission to allocate tags to the tribes. As newly amended, the bill now would only direct DFW to meet with individual tribes, if requested, to discuss elk-related issues for elk located within the territory of that tribe, and to work with the tribes to identify possible science-based solutions. Bill failed deadline and is dead.

AB 1844 (Gallagher) – Reduced Veterans Hunting/Fishing License Fees, AB 1844 passed out of the Assembly Appropriations Committee in late May on a 20 to 0 vote, and off of the Assembly Floor just days later on a 78 to 2 vote. Now on the Senate side, AB 1844 passed out of the Senate Natural Resources Committee in late June on a unanimous 8 to 0 vote. The bill is now slated to be heard in Senate Appropriations Committee on August 1st. The hearing will be held in State Capitol Room 4203, beginning at 10 a.m. Gaines & Associates has been pleased to testify in support of this legislation. Bill failed deadline and is dead.

**AB 2148 (Holden)** – Drone Regulation, Recognizing the possible benefits of this legislation to the promotion and protection of wildlife, Gaines & Associates worked with the bill's sponsor in an effort to help insert language which allows agency use of drones for wildlife research and conservation, while ensuring protections remain in place which fully prohibit their use by others for scouting, herding or other purposes which do not embrace the fair chase ethic. AB 2148 passed off of the Assembly Floor by a 57 – 18 vote on May 19th and moved to the Senate. The bill was then heard in the Senate Natural Resources and Water Committee on June 28th, passing out on a 6-2 vote. The bill's next stop is Assembly Appropriations Committee, where it is yet to be scheduled, but must be heard by August 12th to meet legislative deadline.

SB 345 (Berryhill) – The Sport Fishing Stimulus Act of 2015, After sitting idle for over a year – but having met all the necessary legislative deadlines – SB 345 was finally brought up for hearing on the Assembly side, passing out of the Assembly Water, Parks and Wildlife Committee on a unanimous vote in late June. The bill's next stop will be the Assembly Appropriations Committee, where it is scheduled to be heard on August 3rd. The hearing will be held in State Capitol Room 4202, beginning at 9:00 a.m. Bill failed deadline and is dead. SB 868 (Jackson) – Drones, Among other things, AB 868 would prohibit the operation of a drone within the airspace overlying a state park, or land or waters managed by DFW without a permit, or regulations authorizing the use. Bill failed deadline and is dead.

Authorize publication of notice of intent to amend sport fishing regulations (Sections 1.74, 5.05, 5.40, 5.60, 7.00, and 7.50, and subsections 29.45(a)(1), 43(c), 671(c)(3), and 671(c)(7), Title 14, CCR) 31. Authorize publication of notice of intent to amend falconry regulations (Section 670, Title 14, CCR), 32. Authorize publication of notice of intent to adopt regulations concerning enhanced penalties for illegal take of game (Add Section 748.6, Title 14, CCR) this will complete legislation to implement additional penalties for take of game considered to be trophy's. 33. Discuss proposed regulations to establish an upland game bird special hunt drawing and fee (Section 702 and add Section 715, Title 14, CCR) 34. Adopt proposed changes to Department Lands Pass Program and lands public uses regulations, and certify the addendum to the final 2012 environmental document (Sections 550, 550.5, 551, 552, 630 and 702., Title 14, CCR) 35. Adopt proposed changes to definitions for tidal waters and finfish gear restrictions in San Francisco and San Pablo bays (Sections 1.53 and 27.00, and subsection 28.65(a), Title 14, CCR) 36. Adopt proposed changes to upland game bird hunting regulations (Sections 300, 311, and 745.5, Title 14, CCR). He has taken 100 Spanish goats, 30 island hogs, and 140 Merino sheep during the heyday of the island hunting at Santa Cruz and Catalina. He has nine elk from six different states and is looking forward to adding a California elk to that list. His fifty-nine mule deer from seven different states is an astounding number. He has arrowed seventy-three wild boar in California plus an additional fifteen in Australia. He also has a long list of small game to add to his massive library.

During the late 70s and early 80s there was a bow, mostly manufactured by Martin Archery called the Dynabo, to which Jim devoted much of his time improving on the design. The Dynabo incorporated a then novel idea of a draw stop at the shooters draw length. Unfortunately, the bow was not recognized for competition. Jim pushed hard to get the bow recognized and now, as you well know most bows are designed with draw stops and are recognized bows for tournaments by both NFAA and NAA.

In the late 90s he designed and patented a take-down compound bow. Bear Archery then manufactured the bow under Jim's patent. Unfortunately, the bow really never took off but the concept was great.

Jim continues to support the bowhunting and archery through his shop (Jim Cox Adventures Archery Shop) in Salinas, California, by hosting CBH/SAA measuring clinics, organizing bowhunting activities, and teaching his beloved support to many newcomers. His wife, Sandee, is equally adept at bowhunting and has mirrored his success throughout the years. Their daughter, Tiffany, has twice been named Bowhunter of the year by the Big Game Club.

It is with an immense amount of pride that the Big Game Club announces this well-deserved award to Jim Cox. We congratulate him on his incredible career of success, and are honored that he has chosen to give so much back to the people of California.








