**AB 614** Aguiar-Curry. Wildlife habitat: birds. This bill  
would raise by \$5 the upland game bird hunting validation  
and the state duck hunting validation fees, as specified, with  
that \$5 to be deposited, and available upon appropriation to  
the department for the Nesting Bird Habitat Incentive  
Program, in the Nesting Bird Habitat Incentive Program  
Account, which the bill would create in the Fish and Game  
Preservation Fund. This bill instead would require the  
Upland Game Bird Account advisory committee to annually  
review and provide comments to the department on all  
proposed projects and other expenditures funded from the  
Upland Game Bird Account to help ensure that specified  
requirements pertaining to the Upland Game Bird Account  
have been met and require the department to post budget  
information and a brief description on its internet website  
for all projects and other expenditures funded from the  
Upland Game Bird Account. **Update:** Sits on the Governor’s  
desk for signature.

**AB 645** (Gallagher) – Fish and Wildlife: Poaching  
Violations – Probation. Laws which significantly increased  
fines for possessing more than three times the daily bag  
limit and for the illegal take of wildlife for profit or personal  
gain which increased penalties for the illegal take of trophy-  
class animals took a step back last year when the State  
Legislature passed legislation that reduced maximum  
probation from three years to one year for all misdemeanor  
violations whose provisions do not call out a specific  
probation length.

## Legislative Coordinator Report

A Fish and Game Commission meeting will be held October 14<sup>th</sup>, 2021 by webinar teleconference. Agenda item of interest 14. Wildlife Resources Committee Receive summary and consider approving recommendations from the September 16, 2021 committee meeting. Discuss referred topics and consider revisions to topics and timing. (A) Previous committee meeting report (B) Committee work plan 15. Mammal hunting preference points and tag refunds. Consider authorizing publication of notice of intent to amend regulations for big game species preference points and tag refunds. 16. Tribal Committee Discuss referred topics and consider revisions to topics and timing. Consider approving draft agenda topics for the next committee meeting on December 14, 2021. **Legislative Report** from page 4- Because current law does not specify maximum probation periods for any poaching crimes, the effect of this legislation was to limit probation for even the most serious misdemeanor poaching violations to one year.

Said differently, prior to passage of last year's legislation, a judge could sentence individuals convicted of serious poaching crimes to probation that would prohibit them from hunting for up to three years. The option of a longer probationary period also helped to ensure that penalty assessments could be collected.

To address this serious concern, this bill as amended March 11, 2021, would reinstate a maximum 3-year probation for the following serious violations of the Fish and Game Code:

- §12012 – The illegal take of wildlife for profit or personal gain
- §12013 – The illegal take or possession in the field of more than three times the daily bag limit
- §12013.3 – The illegal take of trophy deer, elk, antelope, bighorn sheep or wild turkey
- §12002.3(b) - The illegal sale purchase of abalone

AB 645 **Update:** is in appropriations committee and held under submission

**AB 804** Megan, Dahle. Free hunting days. Existing law authorizes the Director of Fish and Wildlife to establish 2 free hunting days per year: one in the fall, and one in the winter. Existing law authorizes a California unlicensed resident to hunt during a free hunting day if accompanied by a licensed hunter, subject to certain conditions. Existing law prohibits these provisions from being implemented until the Department of Fish and Wildlife's Automated License Data System is fully operational for at least one year. This bill would require, rather than authorize, the director to establish 2 free hunting days per year, one in the fall and one in the spring, no later than July 1, 2022. The bill would delete the prohibition requiring a delay in implementation of the above-described provisions. **Update:**

Governor desk for signature

**AB 1223** (Levine) The Gun Violence Prevention, Healing, and Recovery Act, The Gun Violence Prevention, Healing, and Recovery Act, would, commencing July 1, 2022, impose an excise tax in the amount of 10% of the sales price of a handgun and 11% of the sales price of a long gun, rifle, firearm precursor part, and ammunition as specified. **Update:** In floor process

**AB 1237** This legislation requires the DOJ to release the personal information of law-abiding individuals who purchase ammunition/firearm parts in California to the Firearm Violence Research Center at U.C. Davis and allow the release of the data to other nonprofits/agencies involved with the study and prevention of violence.

**Update:** This unpopular bill was put through a legislative end run from the normal process. AB173 and SB173 bills that were sitting on the floors for a simple vote, was gut and amended with the AB1237 language. This allowed the bills to be passed without debate. AB173 passed and was sent to the Governor's Desk and he signed it on 9/23/2021 and is effective immediately.

**SB 370** Dodd, Wildlife: Big Game Management Account: uses. Existing law establishes the Big Game Management Account within the Fish and Game Preservation Fund. Existing law requires revenue from the sale of tags for antelope, elk, deer, wild pig, bear, and sheep to be deposited in the account, except as provided. Existing law requires funds deposited in the account to be expended, upon appropriation by the Legislature, by the Department of Fish and Wildlife, solely for specified purposes and pursuant to specified limitations. This bill instead would

authorize the department to make grants to, reimburse, or enter into contracts or other agreements with public and private entities, including nonprofit organizations, and federally recognized Indian tribes for the use of the funds from the account to carry out those purposes. **Update:** SB 370 was ordered to inactive file by author

**SB 470** Jones, Fishing and hunting: annual combined hunting and fishing licenses. This bill would create the annual combined hunting and fishing license that would grant the holder of the license the same privileges as the annual hunting and fishing licenses and that would be valid for a term of one year from the date specified on the license. The bill would limit the issuance of these licenses to residents and would require the department to issue these licenses beginning January 1, 2023, upon payment of a fee of \$100, as adjusted annually for inflation. The bill would require the Fish and Game Commission to adjust the amount of the fee to fully recover, but not exceed, all reasonable administrative and implementation costs of the department and the commission relating to these licenses. The bill would require the department to provide an applicant for one of these licenses the option to automatically renew the license and would provide a 5% discount if the applicant selects this option. **Update:** Held in Appropriations committee under submission.

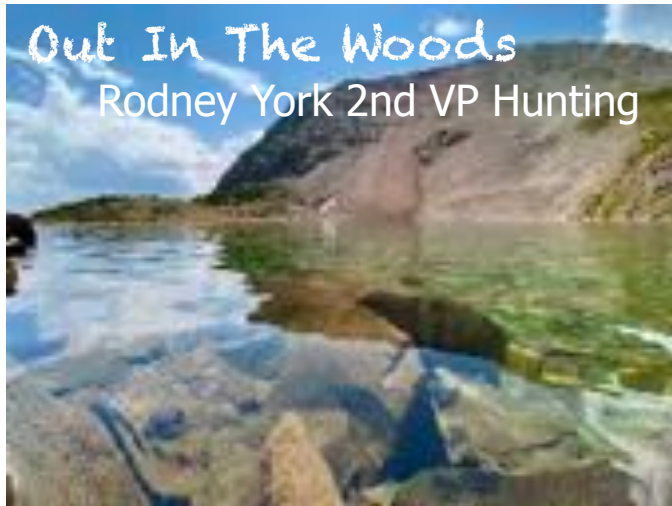
### **State Legislative Coordinator (Volunteer position)** Appointed by the CBHSAA president

Job description:

- Coordinate with 6 regional representatives (if all positions are filled). If position not filled seek volunteers to fill them.
- Work with our lobbyist as needed (if one is hired)
- Follow State, county and local government agencies to keep informed to laws and regulations that will affect bowhunting and target archery (can delegate)
- Attend/monitor FGC meetings and Wildlife Resources Committee meetings of FGC.
- Attend DFG meetings that CBHSAA is an active participant such as Hunter Conservation Coalition, Big Game Advisory Committee, Upland Bird Advisory Committee (can delegate).
- Write article for the CBHSAA newsletter
- Fundraising for the CBHSAA Legislative Defense Fund (seek assistance)
- Be familiar with CBHSAA constitution and bylaws on your described duties.

## Ole Men on the Mountain

Back in the day mountain men were a mystic group of men, and probably still known as the same. This elusive group of folks were indeed secretive and seldom seen. They lived off the land and for the most part were trappers by trade. They knew how to fend for themselves not only for food, but also survival, and making their own clothes from animals they harvested.

At ages 68 and 70, Scott Hargrove and I decided to join this clan in the high mountains of Colorado backpacking in just under 5 miles. Hunting above tree line most days would see us at above 12,000 feet or more in elevation, after an hour of climbing in the dark. Our camp was set up at the timber line next to our "kitchen"/water source (pictured above). There we would gather water after filtering it for our daily needs.



This type of backpack trip is NOT for everyone and certainly not for the faint of heart or mentally/physically limited. For example our daily routine went something like this:

Up at 4:00 am for oatmeal and coffee.

5:00 am packing and the next climb of at least 1,400 feet at a vertical gain in the next hour to procure the advantageous glassing point known as "Marmot Lookout". From here we would spot the prospective buck we wished to stalk. Our observation would generally be a couple hours watching the bucks feed and then bed down. If they were in an approachable area our stalk would be planned.

We found most often the bucks would rise and feed roughly every two hours. Sometimes they would simply readjust their position in their bed. Other times they would feed to another "more suitable location" for shade, or shelter from prevailing winds. Glassing from the north permitted us to view bucks which even at these elevations prefer to be in the shade. It was during these afternoon winds we would wait for our final stalks. By then the winds were strong enough to bend the head-high willows and boughs of bristols. The noise it created along with the frequent jets, which pasted overhead, provided extra "cover" for a silent approach in moccasin clad feet. Additionally, the wind created "movement" everywhere, making it more difficult for the deer to discern something out of the ordinary.

After staying at it all day, we would return to camp and eat a quick freeze dried dinner between 8 and 9 pm. We found several "target" bucks which actually earned names and locations (changed to protect the "innocence"). Some worth mentioning are "Boxcar," a narrow buck of 20" but with depth in his tines of nearly the same. His buddy "Potbelly," which was probably the oldest buck we located, sported only two huge forks in his rack. He was approaching 30 inches in spread and super FAT with a sagging back from his obesity. Then there was "34 CHEATER" also known as "Sticker," whose antlers were approximately that wide and then had a sticker which protruded off the right G-2 (rear fork) of his crown.

**Ole Men on the Mountain** continued from page 7- Finally, there was "Fifteen," named for his 3x5 rack with inline/non-typical placement of a tine on his right with a four inch sticker coming out the back on the same side. All were trophies in their own right and were chosen because of their unique structure.

Day after day we watched the seasons change and sometimes were able to approach these monarchs.

After 15 days of these charades we had enjoyed sightings of several elk, Shiras moose, golden eagles, marmots, Ermin pika, chipmunks, several coyotes, two wolves and so many more they are too numerous to mention.

In the same length of time after sixteen separate attempts it was Scott who found the lucky ticket. His well planned approach from the top into "striking distance" had been silent. The winds had just picked up to a howl, with jets still camouflaging the sounds from overhead. The deer were feeding in the willows below. Unaware of Scott's presence as he drew his bow fully to anchor and then he released the arrow from his traditional weapon. It was "fifteen" who would be the unsuspecting recipient of the launched shaft as his head was buried in the browse. It took only a fraction of a second for the missile to travel the 25 yards and pierce the buck just behind the front shoulder blade angling back to the opposite side. A few bounds later the giant would succumb to the lethality of the razor tipped arrow. After some photographs of the giant and Scott's joyful face we began the task of boning out the meat and securing the cape and antlers in the packs.



Tired (more like exhausted) the two ole mountain men retired for the night. In the morning resupplied with necessities, I returned to the to mountain while Scott continued to prepare the meat for table fare. Not that this experience made us mountain men, but we certainly enjoyed our time in the mountains being ole men and trying to digest all of God's creation for man. We recommend this type of adventure for each of you but realize that few will accept the challenge therein.

November is here, so pack those bags and equipment for your whitetail hunt. By the way, keep tune for more updates on our Big Game Awards banquet slated for February in Visalia. We will advise you as we have more information. As a post note, look for the video in months to come which takes you on the above adventure/hunt at one of these locations:

After the diagnosis, Mike was obsessed with wanting to see the finale of StormChaser. His friend Sammy Aquino set Mike up with HBOMAX so that Mike could watch the last 2 episodes while being hospitalized at Valley Medical Center in San Jose. Mike wanted to live long enough to see another 4th of July. He loved seeing fireworks!! Mike bought over \$200 worth of Fireworks and he was able to watch while his neighbors' grandson set off the fireworks in the street. He wanted to be able to hear and watch the ocean one more time. He was able to spend a weekend in Pacifica listening to the waves crash against the shoreline. He wanted to see another Halloween, his favorite holiday (but he didn't meet that goal).

Mike was born in Richmond, CA to Don & Bev Pierce. His older brother, Don and he got closer as Mike battled this disease. The family moved to Gilroy when Mike was 3 years old. He lived in the same neighborhood for 52 years. When Mike was a child, walking to school, he always stopped at his neighbor's house and got a donut every morning! Mike loved his sweets! When Mike was in High School, there was a student in a wheelchair who wasn't able to play basketball. He really wanted to learn how to shoot hoops. Mike gave up his lunch time for a month and taught this guy how to shoot hoops. This student went on to win an award for being extremely proficient at shooting a basketball. Mike was so good at mentoring others. Helping others achieve success was his legacy.

Mike was a great storyteller and could tell a joke so easily that you were rolling on the ground with laughter. Many of you will remember his stories and I hope you share them with each other.

One of my favorite stories and most thrilling story is a hunting story involving a bear charging him and a friend. Four arrows later and only 10 yards to spare, the bear finally dropped.

Mike loved to travel, meeting people throughout the world. Many of you traveled with Mike to Australia, New Zealand, Scotland, England, South Africa, Germany, Italy, Watkins Glen, NY, and Yankton, South Dakota for IFAA and NFAA tournaments. He loved hearing your stories. He was quick with a smile and laughed easily.

Some of Mike's accomplishments:

Mike's attitude during competition was to do well but more importantly, to have fun. He couldn't tell you his score five minutes after completing a tournament but he could tell you what a great time he had shooting that day. He competed in various local, regional, State, National, and World events. One of Mike's proudest moments was in Dahn, Germany when he was asked to carry the American Flag during the parade of Nations that started the IFAA WFAC tournament in 2010. He shot FS, BHFS, BH, BB, Trad-recurve and FSL-R styles. He was a very accomplished archer and coach. In 2011, he traveled to Australia to compete in the WBHC. He was one of 4 Americans competing in that event. I remember meeting the Avard family from Australia who changed their vacation plans because they knew Mike would be competing in Wagga Wagga that year. Trevor and Sindy's son, Jack, a Junior at that time, was really struggling with yardage. Mike worked with him for 30 minutes at the practice range, encouraging him and instilling confidence in him. Jack took 1<sup>st</sup> place at that tournament. So many times, I've seen Mike stop warming up at the practice range before a tournament and help fellow archers improve their game. As Sue McColl said on the Predator's FB page, "Mike was always such a generous person".

Mike's true passion was coaching. He was a level four coach - a rarity for sure. He was very gifted in being able to teach new archers how to hit a bulls-eye in 12 shots. Doreen Hassen shared that "Mike was an inspiration! He helped to introduce archery to so many kids at the YMCA". Heather Pierce wrote "What a gift Mike gave to so many, including my daughter Lily. He inspired a love for archery and was such a kind and generous soul, who also enjoyed giving a bit of ribbing". Many of us still hear Mike's voice as we compete..."Now the first step is to set your feet and when we were aiming, ball... ball... ball".

He trained many, many World Champions. Continued on page 10

Nothing gave him more pleasure than to see you succeed. Jeremy Liem posted this message on the Predators FB page: "Such a great teacher! He had the unique skill to tell you that you're doing everything completely wrong and make you honestly appreciate his direct criticism at the same time".

There is so much to say about Mike but let me end this article with a quote I received from Pam Severtson, which comforted me greatly and I hope it does the same for you... "Grief never ends...but it changes. It's a passage, not a place to stay. Grief is not a sign of weakness, not a lack of faith...it is the price of love."

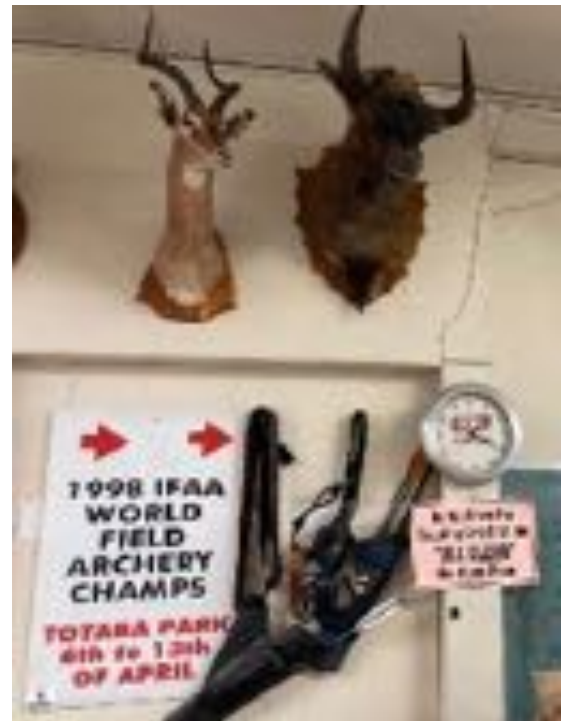

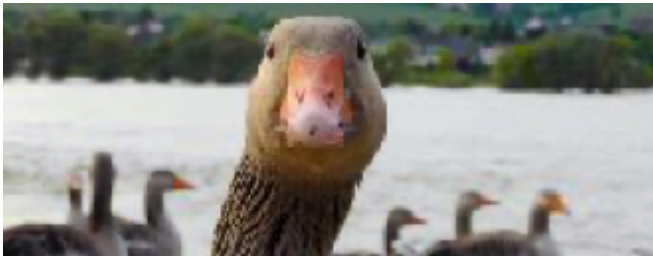

# GOOSE HUNTING TIPS

JBarr - Small Game Chairman

Waterfowl hunting is something I enjoyed as a young boy with my dad, family and friends. Goose hunting with archery equipment WOW that would be a rush and a huge challenge for anyone. Just like any other species you're hunting you need to hunt where they are or going to be. Hunting waterfowl has lots of disadvantages for the hunter, as they see almost a 360° bird's EYE view. Concealment and having room to shoot a bow will be one of your challenges. Of course, for those who like to spot and stalk, have fun, slow down your movement, sound is not your friend and windy days are tricky.

I would like to point out something for you to think about from the DFW regulations code: 507. PROVISIONS RELATED TO THE TAKING OF MIGRATORY GAME BIRDS [as defined in Section 502 but also includes mourning doves, white-winged doves, band-tailed pigeons, and snipe.] Bow and Arrows. Only arrows with flu-flu fletching may be used except that conventionally fletched arrows may be used to take waterfowl sitting on the water from scullboats or similar watercraft. ## **Now a few tips for you goose hunters: When in doubt, spread your decoys out**

No matter what decoys you are using they all work better when you spread the decoys out. I constantly see guys put decoys practically on top of each other and watch the birds hover and not land because there wasn't enough room to land. Even Lesser (small) Canada geese have a four-foot wingspan and larger Canada geese up to six feet. I've never seen geese get tangled on takeoff or landing. I often watch geese landings. That is,

they are landing inside a group of geese, not in a large opening between groups. So, logically speaking, there is enough space between birds.

## **Have more than one style of goose call on hand**

"When selecting your goose calls, I recommend choosing two different styles of calls. I would choose one acrylic short-reed goose call that produces a very loud, sharp, and somewhat high-pitched tone for field and windy day calling. I would also recommend having one wood short-reed goose call that produces a softer, deeper, and more realistic sound. These calls complement each other for different hunting and weather conditions. Keep one thing in mind: you can blow a loud call soft, but you can't blow a soft call loud.

## **Stay still, keep your head down, and don't gawk**

"One important factor for everybody in the blind is to keep perfectly still—no movement until the shot is called. People in your group shouldn't be looking up at the geese. To be on the safe side, I think it's even better when everyone wears a face mask. One of the golden rules is that if you can see the geese, they can see you better; so keep still and don't move. I promise you that this simple bit of discipline in the blind will help you put more geese in your decoy spread.

## **Land-and-water spreads are a productive combination**

"When 'running traffic' for Canada geese, I like to set up land-and-water spreads whenever I can. Water seems to 'soften up' geese and they tend to work really well. A combination spread of sleeper shells, full-bodies, and floaters can be deadly. During times of freezing temperatures, I like to run an 'ice eliminator' to ensure I have open water in traffic areas. Having access to open water when it's really cold can make a big difference in your success."

## **Practice shooting in natural hunting situations**

I have hunted with a lot of different people. The number one thing I see that would make guys more successful would be spending a little more time practicing their shooting. When hunting is tough and opportunities are few and far between, you need to make every shot count. Go out and practice shooting in a natural hunting situation. Practice with your FLU FLU arrows, practice shooting coming out of a pit or layout blind, from behind bushes, sitting in a chair and get out on those wet and windy days to practice in some 'fowl' weather. Get out, get uncomfortable and practice. All these things will make us all more effective when that magical time happens.



## WILD GOOSE RECIPE

### **CROCK POT WILD GOOSE**

1 goose, skinned and cut up  
 2 TBS butter  
 4 garlic cloves, peeled  
 1 onion, sliced  
 1-1/2 TBS homemade worcestershire sauce (on this page)

2 cups chicken broth (homemade or substitution below)

In a heavy skillet, melt the butter over medium high and quickly brown each piece. Place the browned goose pieces into your crock pot and set it to high heat. Add the garlic cloves, onion, Worcestershire sauce and broth.

Slow cook for 6-8 hours, or until the meat falls off the bone. Shred with a fork and mix with your favorite barbecue sauce. Thanks for using my recipes for goose; these are great sandwiches, don't you think?

Easy Chicken Broth Substitute  
 1/4 tsp to 1/2 tsp "Better Than Bouillon"  
 chicken base  
 1 cup water, boil

### HOMEMADE WORCESTERSHIRE SAUCE RECIPE FROM SCRATCH

(This makes a great gift too.)

2 TBS olive oil  
 6 cups chopped onions  
 4 jalapeños with stems and seeds, chopped  
 2 TBS minced garlic  
 2 tsp freshly ground black pepper  
 1/2 tsp cloves  
 2 TBS coarse salt  
 2 medium lemons, peeled and pith removed  
 4 cups dark corn syrup  
 2 cups pure maple syrup  
 8 cups white vinegar  
 1 cup fresh horseradish, peeled and grated

In a stock pot over high heat, combine olive oil, onions, jalapeños and sauté until soft; about 4 minutes. Add the remaining ingredients with 4 cups of water; bring to a boil.

Reduce heat and simmer, stirring occasionally, until the mixture barely coats a wooden spoon; about 6 hours. Strain through a fine mesh strainer and let cool to room temperature. Use immediately or keep refrigerated indefinitely.
