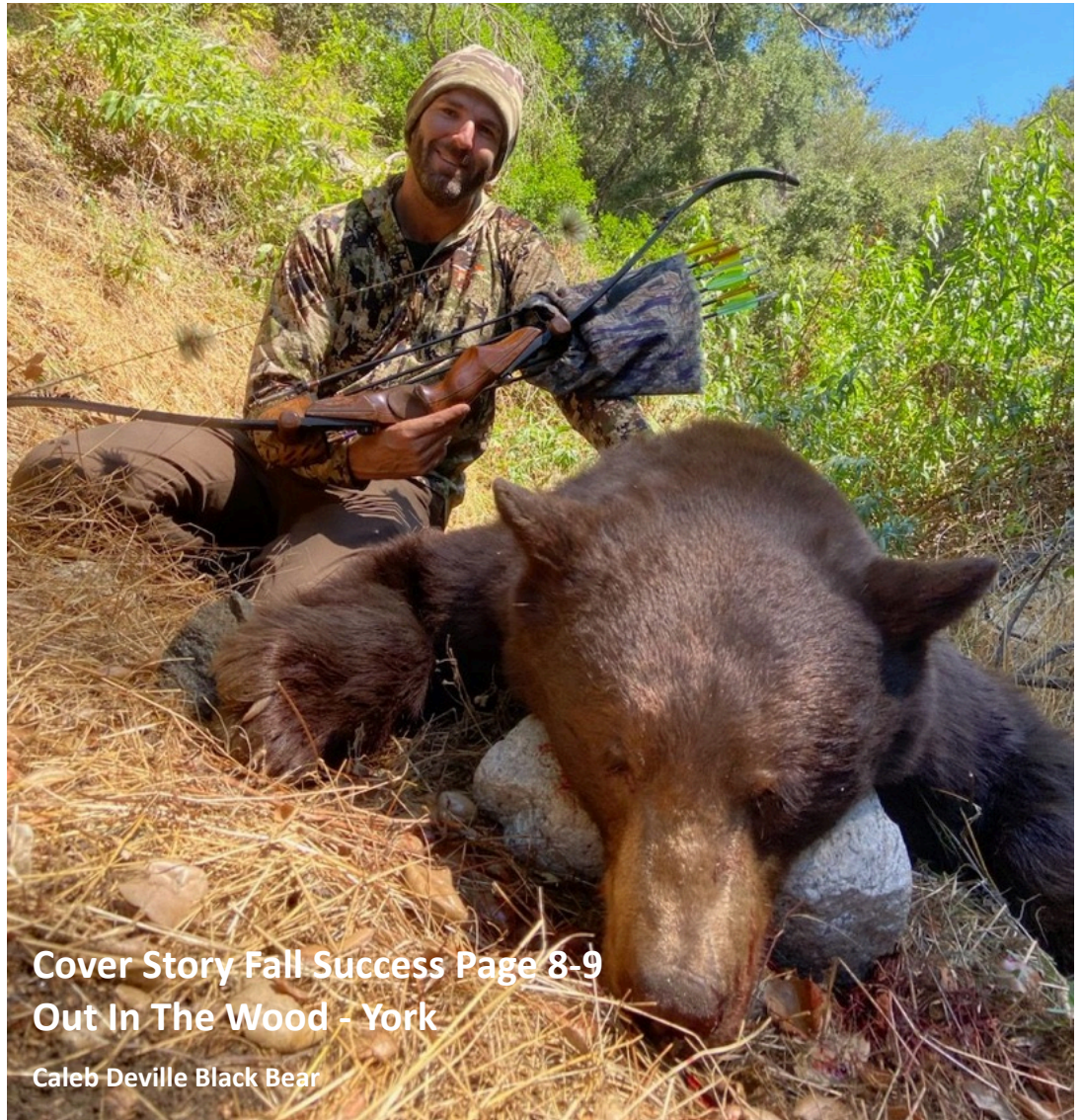

Team it's been a busy couple of months and it doesn't look to be getting any easier. Let's get right to it.

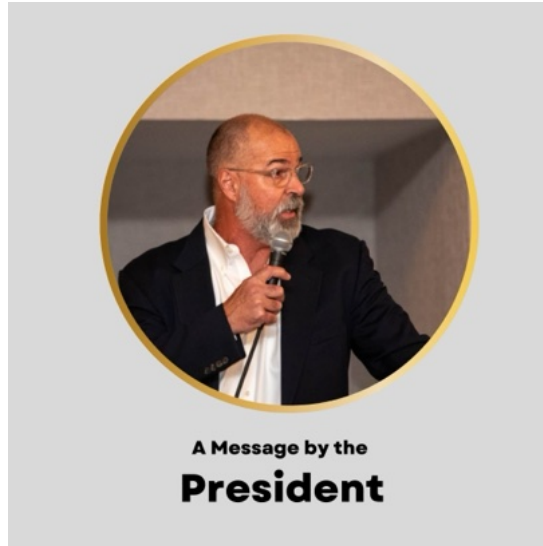

I traveled to northern California to attend and host the California State Outdoor Sportsman's Legislative Caucus. There has been quite a bit said about this already, but it is always good to speak with a few members of our state legislature and some of the local CDFW Warden community. It was a little somber as this was always Robert Moore's event and this is the first one without him, but he left quite a legacy for all of us to follow. Huge thanks to Rodney York, Mark Rubio, Heather Gore and John Sklarr for their support at the event. Legislative efforts are our most important challenge right now.

There have been several meetings of various state committees and commissions since last letter. All of that is being watched and covered closely by our Legislative Director Amanda Duchardt, and her team. There is a lot of frustration in the air right now. As you no doubt heard, AB28 passed the legislature and is on the Governor's desk. He is sure to sign it, but you can always take time to write him and voice your displeasure. This bill puts an 11% excise tax on all of the guns and ammo bought in the state of California starting Jan 1st 2024. This new tax on law abiding gun owners will go to a gun violence prevention program. While I have my opinions about where it will REALLY end up...I will stick to my script. This is a problem bill and my biggest fear is that it somehow migrates to archery. Rest assured we will keep you informed of any additional developments, but hunting just got more expensive.

I know many of you have been very concerned about the Federal Government abolishing funding for all Hunter Education and Archery programs in our local schools.

We have watched this closely and have been getting feedback from Bill Gaines concerning this ridiculous mandate. I have asked Lori to put a piece in the newsletter letting you know what Senators and Congressmen/women are doing to clear this up. Senator John Cornyn of R-Texas has written a letter which both Democrats and Republicans have signed to get the Department of Education Administration to re-evaluate their mandate before the legislature takes action to fix the problem. It looks very good at this point but may take a little time. More to follow as it develops.



It is my intention to attend the Fish and Game Commission meeting in San Jose this next month. More to follow on that. I encourage anyone with a day to spare to attend that meeting. If you have never attended a meeting it's a great experience. It gives you some perspective on what our sport is up against. As I always teach in Hunter Ed..."Be a safe, responsible, knowledgeable and INVOLVED hunter."

Hopefully all of you had a chance to shoot the State 900!

This is always a very well attended shoot and there surly will be some great scores as the weather really cooperated this year. We didn't have the blistering heat down south that we usually do and I think shooting may have been just a little easier. I'm looking forward to seeing the scores!

Legislative Team Update by Amanda Duchardt, CBH/SAA Legislative Director

Greetings CBH/SAA friends and family! The Legislative Committee has LOTS of updates for you this month and MOST of it is good news so grab a beverage of your choice and settle in for the ride.

First, thanks to bipartisan efforts in Washington DC, there appears to be a fix for language in the 2022 **Bipartisan Safer Communities Act (BSCA)** that the Department of Education (DOE) interpreted in a manner to excluded federal funding for hunter education, wilderness courses, archery in schools, school sponsored shooting teams, and other critical enrichment programs. For the last few months, the Congressional Sportsmen's Caucus has been working to ensure a legislative fix to the BSCA moves quickly through Congress and on September 26, the House passed the **Protecting Hunting Heritage and Education Act (H.R. 5110)** on an impressive vote of 424 – 1. The following day, the Senate also unanimously passed the bill, which now heads to the President's desk for signature. The bipartisan H.R. 5110 will ensure that critical enrichment programs for millions of students are eligible to receive federal funding under the Elementary and Secondary Education Act (ESEA) and will resolve the funding limitations under the BSCA.

Next, if you've been following along with our Legislative Alert emails and Voter Voice updates, you are already aware that on September 7, AB 28 - legislation which will impose an 11% excise tax on the purchase of all firearms, firearm parts, and ammunition passed out of the Senate with the absolute minimum number of votes required. Within hours it was passed back to the Assembly for a dizzyingly quick approval of amendments. After a few weeks on Governor Newsom's desk, **AB 28 was signed into law and the new tax will go into effect on July 1, 2024.** Thank you for doing your part to help us try to kill this legislation. This legislation WILL be challenged in the courts. Our California Hunting and Conservation Coalition (CHCC) partners at California Rifle and Pistol Association (CRPA) and other pro-second amendment organizations are already preparing their challenge based on the premise that you cannot tax an enumerated right. This will be a tricky proposition because firearms, ammo, and other outdoor equipment are already subject to the Robertson-Pittman excise tax to fund conservation efforts.

In happier news, the **California 9th Circuit ruled that AB 2571, (which was signed into law last year prohibiting the marketing of firearms to minors) is probably unconstitutional.**

This decision reversed the previous lower court ruling and the case has been sent back down to the lower court for further proceedings. The ruling, based on the 1st Amendment (freedom of speech) noted that:

- California permits minors under supervision to possess and use firearms for hunting and other lawful activities, Section 22949.80 facially regulates speech that concerns lawful activity and is not misleading.
- Next, the panel held that section 22949.80 does not directly and materially advance California's substantial interests in reducing gun violence and the unlawful use of firearms by minors.
- There was no evidence in the record that a minor in California has ever unlawfully bought a gun, let alone because of an ad.
- Finally, the panel held that section 22949.80 was more extensive than necessary because it swept in truthful ads about lawful use of firearms for adults and minors alike.
- Judge VanDyke wrote separately to emphasize that laws like section 2249.80, which attempt to use the coercive power of the state to eliminate a viewpoint from public discourse, deserve strict scrutiny.

Legislative Committee Update from page 4 Last month, we reported that we are also keeping a close eye on **AB 262 – legislation related to children’s camps’ safety and regulation**. We are pleased to announce that shortly after this article was published, the author of the bill pulled it from consideration. CBH/SAA and our partners in the CHCC believe that AB 262 was highly dangerous legislation due to its potential to result in unnecessary, burdensome, and costly regulations being placed on youth recreational camps – including those which introduce and educate youth on wildlife conservation and our hunting, fishing, shooting and archery pastimes.

Finally, a couple SoCal locals brought to our attention that the Catalina Island Conservancy is working with the CDFW to secure permission to **eradicate mule deer on Catalina Island**. Our lobbyist Bill Gaines has been tracking these efforts for several years, but the issue is picking up steam and Catalina locals and hunters are looking for support to stop the wholesale slaughter of these deer. CDFW is drafting an environmental document to support the decision and we will keep you posted on the opportunity to provide public comment. CBH/SAA supports wildlife management decisions backed by scientific data and research and there are concerns that the science behind the Conservancy’s plan is flawed. Hunting on Catalina is a unique experience and as I flip through the pages of the CBH/SAA Big Game Record Book, I see the success of Island pig and goat hunts that I and future generations will never get to experience. There is no doubt that pigs are incredibly destructive to native habitats and removing them from the Island was a sound wildlife management decision, but we will strive to protect this unique deer hunting opportunity and ensure that our wildlife is responsibly managed for all. Help Prevent the Spread of Chronic Wasting Disease to California


The California Department of Fish and Wildlife (CDFW) is requesting help from deer hunters to collect retropharyngeal lymph nodes from their deer harvests and submit those samples to CDFW’s Wildlife Health Lab for CWD testing. This can be done in one of three ways:

1. Bring your harvest, or just the head, to a CDFW operated sampling station or office: wildlife.ca.gov/CWD/Sampling-Station.
2. Bring your harvest and the head to a participating meat processor or taxidermist: wildlife.ca.gov/CWD/Meat-Processors-Taxidermists. Cont pg 6

Republicans, Democrats unite to oppose Biden admin's crackdown on hunting, archery

Bipartisan lawmakers say Biden administration is misinterpreting 2022 gun control bill to punish students enrolled in hunting, archery and even culinary classes

Senate Republicans and Democrats fired off two letters late Tuesday in opposition of the [Biden administration's crackdown](#) on school hunting education and archery programs nationwide.

The letters, led by Sen. John Cornyn, R-Texas, stated that the Department of Education misinterpreted legislation [regarding funding for such programs](#) and called on Senate Appropriations Committee leaders to restore funding. The first letter to Education Secretary Miguel Cardona was signed by nine Republicans and nine Democrats, while the second to Appropriations leadership was signed by six Republicans and 11 Democrats.

"Unfortunately, and contrary to Congressional intent, the Department of Education has misinterpreted the language to exclude certain educational activities from receiving federal resources," Cornyn and 17 other lawmakers wrote to Cardona.

"This is concerning because of the important role these enrichment programs can play in students' lives," they continued. "Archery is an inclusive extracurricular activity that empowers students from all backgrounds to learn a sport and compete. Hunter safety classes and programs play an important role in teaching safety, wildlife management, landowner relations and personal responsibility to students."

[Fox News Digital reported](#) in July that the Education Department shared federal guidance to hunting education groups highlighting that hunting and archery programs in schools would be stripped of funding. The guidance explained that the administration interpreted the 2022 Bipartisan Safer Communities Act (BSCA) to mean such programs can no longer receive taxpayer funds.

Republicans, Democrats from page 6- According to advocates, many schools that offer such courses have already nixed them from curriculums due to the federal guidance.

"We ask that the Department interpret the language as Congress intended and no longer ask educational entities to seek other funding sources for educational enrichment programs that align with the intent of ESEA — supporting student achievement and student well-being," the letter to Cardona continued.

Cornyn and Thom Tillis, R-N.C., were the two Republican sponsors of the BSCA, and Sens. Chris Murphy and [Kyrsten Sinema, D-Ariz.](#), were the Democratic sponsors. Tillis and Sinema signed the letter to Cardona on Tuesday alongside Cornyn.

The BSCA — a bill that was criticized as a "gun control" bill but touted by proponents as an effort to promote "safer, more inclusive and positive" schools — was passed overwhelmingly by Congress and [signed into law by President Biden](#) in June 2022 after mass shootings at a grocery market in Buffalo, New York, and a school in Uvalde, Texas.

The law included an amendment to a subsection in the ESEA listing prohibited uses for federal school funding. That amendment prohibits ESEA funds from helping provide any person with a dangerous weapon or to provide "training in the use of a dangerous weapon," but, according to Cornyn, was included to prevent ESEA funding for school resource officer training.

"These courses can play an important role in teaching firearm safety, wildlife conservation, and personal responsibility," Cornyn and 16 of his colleagues wrote in the second letter Tuesday addressed to the Senate Appropriations Committee. "The intent of BSCA was not to preclude students from participating in these kinds of opportunities."

They noted that, in addition to archery and hunting programs, the [Education Department's interpretation](#) of the BSCA may "be used to prohibit schools from providing kitchen knives that are larger than 2 ½ inches long in culinary classes."

The lawmakers called on the Appropriations Committee to include language in the upcoming FY24 Labor, Health and Human Services, Education and Related Agencies Appropriations Bill to reject the Education Department's interpretation of BSCA.

The second letter was signed by Cornyn, Tillis, Sinema and Murphy, in addition to several other Republicans and Democrats.

The Department of Education did not immediately respond to a request for comment.

House approves bill striking down Biden's crackdown on hunting and archery in overwhelmingly bipartisan vote

Biden admin interpreted 2022 gun control bill to strip funding from schools with hunting and archery programs

The House voted late Tuesday evening in favor of legislation striking down the Biden administration's [decision to block federal funding](#) for school shooting sports courses.

In a 424-1 vote, the House approved the [Protecting Hunting Heritage and Education Act](#) with 216 Republicans and 208 Democrats voting in favor, and just one lawmaker, Rep. Veronica Escobar, D-Texas, voting against. Rep. Mark Green, R-Tenn., introduced the bill on Aug. 1, days after a Fox News Digital report in late July revealed the Department of Education was withholding funds for school hunting and archery courses.

"Hunters and fishers are the best conservationists," Green told Fox News Digital after the vote Tuesday. "Hunting, whether it be with a firearm or bow, is one of the most effective ways to control wildlife populations, protect our beautiful lands, and connect with nature. My Protecting Hunting Heritage and Education Act is critical for our children."

He added in a separate statement that American students should be encouraged to "participate in enriching athletic activities that foster an appreciation for nature and the ability to focus on a goal." According to Green, in his state alone, the Biden administration's funding decision impacts an estimated 50,000 students.

The guidance explained that the administration interpreted the 2022 Bipartisan Safer Communities Act (BSCA) to mean such programs can no longer receive taxpayer funds.

Your options are almost limitless when it comes to small-game hunting. It is truly hunting season all year long. You do have to be aware of what is in season and what species are open all year. You also need to comply with bow equipment, arrows, and the broadheads that DFW requires by law. Most critters make great table fare. Catfish, ducks and rabbits are delicious, while others like carp, crow, and chipmunks, for example, are not what you really want to see on the dinner table.

Small-game archery hunting can be enjoyed with the whole family, with friends, or a great reason to get outdoors alone. The excitement is in the journey from start to finish. I have been asked, "How do I get started? Where do I go? What arrow can I use?" These are great questions.

If you are interested in our "Eagle" program, it's a whole different level of hunting challenges. You harvest species and turn them in by going to the CBH website. Check out the rules and enter your species information online. Once this is done, you will receive by mail, a Small Game Club certificate that will indicate the species for your records and keepsake. When you have reached thirty-five distinct species, you will be entered into the Eagle Society, and also listed in the Big Game Record Book. And, you will also be presented with the AMAZING trophy

at the next Big Game Banquet. This award will also have room for your 50th species harvested when earned, you will be entered into the double eagle society and be presented at the following Big Game Banquet. And a third spot on the trophy is for your 75th species. Again you'll be entered into the Triple Eagle Society with the few elite archers who have achieved this challenge.

"How Do I Get Started?" First, determine what your desire is, fins, feathers, or fur. Let us start with Fins, like catfish. You will need a bowfishing setup. Contact your local bow shop to get set up if you do not have one already.

"Where can I bow fish for catfish?" First, there are only three waters you can legally bowfish catfish, Big Bear Lake, Lake Isabella, and the Sacramento River Delta. The best time to bowfish is in warmer temperatures. The catfish will feed closer to the surface around shore; they love weedy areas in the shallows and around any plant life on the surface. Catfish will also be mixed in with the carp near the surface when they are all feeding.

"Feathers" may be your choice. Pheasant for example, a recurve is the preferred method, compounds work well too. California state law requires a flu flu arrow used when pheasant hunting. The fletching of a flu-flu arrow creates wind drag that will minimize the arrow's trajectory.. Shooting a flu-flu accurately is no easy task and takes lots and lots of practice, practice, and practice to get your 20-yard, 30-yard and beyond shots dialed in. Broadhead is best for penetration.

From my experience, I have used "G5" game heads and worked at close range. ARCHERY Pheasant season is October 15th – November 5th, / December 25th – January 21st, 2023. General Statewide season is November 11 – December 24th (2023). You are allowed two males per day for the first two days of the season. The Department of Fish and Game offers special hunts you can sign up for. Pheasant love agricultural areas, and the grassland is best.

"Fur" may be your choice. Cottontail Rabbit the season is July 1st – January 28th statewide. The limit is 5 per day, and only 10 in possession.

Fins Feathers and Fur -cont. from page 6- Cottontails are just about everywhere. Public land with low brush with food and water is best. Early morning and late evening will increase your chances. Grab your favorite bow, a few arrows, and let's get outdoors. Game heads like JUDU, G5 work within 30 yards. Outside of that, I would use a broadhead.

Small Game does not seem so small anymore, does it? Hunting is not for everyone; Archery is not for everyone. Hunting was a way of life and survival since the beginning of time. Hunting traditions are passed down through generations, they help preserve cultural heritage. Responsible hunting practices can play a huge role in conservation and environmental stewardship. There are many conservation groups besides CBHSAA, like National Wild Turkey Federation (NWTF), and Rocky Mountain Elk Foundation (RMEF). Pheasant Nuggets

Ingredients:

- 2 Pounds pheasant breast, cut into strips
- 1 Teaspoon meat tenderizer
- 1 Cup all-purpose flour
- seasoned salt and pepper to taste
- 1/2 Cup dry potato flakes
- ½ (16 ounce) Package buttery round crackers, crushed
- 1 egg
- 1/2 Cup Milk

Directions:

Preheat a deep fryer for 375 to 400 degrees F (190 to 200 degrees C).

Sprinkle the pheasant meat with meat tenderizer and pound lightly with a mallet to make all the pieces uniform and the same thickness. Using a medium bowl, combine the flour, seasoned salt, pepper, potato flakes and crushed cracker crumbs. Mix well and set aside.

In a separate medium bowl, combine the egg and the milk and whisk until smooth. Dip the pheasant meat strips into the egg mixture then dredge each strip into the flour mixture. Coat well and thoroughly and lay out on a plate so the strips can be easily transferred to the deep fryer.

Place the strips in a deep fryer set at 375 to 400 degrees F (190 to 200 degrees C) until golden brown. (Note: You can also pan fry these in a skillet over medium high to high heat with 1 cup oil for pan frying, but you may need to flip them if they are not submerged in oil.)

House Approves bill- from page 7- According to advocates, many schools that offer such courses have already nixed them from curriculums due to the federal guidance.

"The Department of Education and Secretary Cardona are blatantly misconstruing the law to withhold funding from schools that choose to teach beneficial courses like hunter safety and archery," Lawrence Keane, the National Shooting Sports Foundation's senior vice president, told Fox News Digital in July.

"Congress must hold Secretary Cardona and the department accountable for violating the letter and spirit of the law to unilaterally deny America's students access to these valuable programs as part of the Administration's continued attacks on the Second Amendment," Keane added. Tommy Floyd, the president of the National Archery in the Schools Program, said his organization boasts roughly 1.3 million students from nearly 9,000 schools across 49 states who are enrolled in archery courses.

However, the Department of Education has doubled down on its interpretation of the BSCA, saying it would only reverse course if legislation was passed explicitly revising the 2022 law to allow funding for shooting sport programs in schools.

The BSCA — a bill that was criticized as a "gun control" bill but touted by proponents as an effort to promote "safer, more inclusive and positive" schools — was passed overwhelmingly by Congress and [signed into law by President Biden](#) in June 2022 after mass shootings at a grocery market in Buffalo, New York, and a school in Uvalde, Texas.

The law included an amendment to a subsection in the ESEA listing that prohibited uses for federal school funding. That amendment prohibits ESEA funds from helping provide any person with a dangerous weapon or to provide "training in the use of a dangerous weapon," but, [according to the BSCA's sponsors](#), was included to prevent ESEA funding for school resource officer training.

Earlier this month, three of the four BSCA Senate sponsors — Sens. John Cornyn, R-Texas; Thom Tillis, R-N.C.; and Kyrsten Sinema, I-Ariz. — [introduced companion legislation](#) to Green's bill.

"The Biden administration's misinterpretation of these provisions has jeopardized educational enrichment programs like hunting and archery, which play a critical role in our next generation's development and well-being," Cornyn said Tuesday after the House vote. "This legislation would ensure these programs remain available in schools across the nation, and I urge the Senate to pass it as soon as possible." One more newsworthy article on page 13

Stop the Slaughter of Mule Deer on Catalina Island

September 23, 2023

Petition to California Dept. of Fish & Wildlife Tim



Why this petition matters.

Catalina Island, located off of the coast of Southern California, is home to a resident population of mule deer brought to the island in the early 20th century. Mule deer in California belong to the people of California. Population management falls under the jurisdiction of the California Department of Fish and Wildlife (CDFW). An agreement was entered into by the Catalina Island Conservancy in 1998 under the Private Lands Wildlife Management Program (PLM). to administrate issues pertaining to the deer population. The Catalina Island Conservancy is a private non-profit 501(c)(3) organization formed in the 1970's whose stated mission is to provide a balance of conservation, education, and recreation for Catalina and the general public. The Catalina Island Conservancy has applied to the CDFW to slaughter 100% of the mule deer on Catalina Island.

FINAL APPROVAL HAS NOT BEEN GRANTED. NOW IT THE TIME TO ACT!!

The application process includes a report covering a 5 year period (2017-2022). The approval process is very near completion and has been in place without transparent public disclosure for some time. Recent attempts have been made to appear to consult with concerned citizens. In fact they have waited until they are very close to approval (1-3 months). It does not grant the public, as legal stakeholders, the time needed to access further information in a transparent

manner, engage in constructive criticism and problem solving as well as register their humane concerns with the planned slaughter of the mule deer on Catalina Island.

THEY ARE NOT TRYING TO KILL THEIR DEER, THEY ARE TRYING TO KILL YOUR DEER

There are several areas of concern that we, as citizens of the State of California, urge the CDFW to consider sufficient to deny the current application by the Catalina Island Conservancy to slaughter the deer. These include, but are not limited to, questions about scientific integrity, cultural relativity, humane considerations, and our legal rights as citizens of California to be a greater part of the process.

READY, FIRE, AIM!!

THEIR REPORT IS SERIOUSLY FLAWED

The emphasis of the report is the need to protect and save rare and endangered plants on the island. This is an important and huge challenge in an era of climate change and increasing public access to the lands and the resulting affects. The report submitted to the CDFW is clearly a predetermined conclusion supported by assumptions. It is filled with photos designed to create an emotional response but lacking in comprehensive integrity. Just a small fraction of the potential questions raised include things such as.....

○If plant exclosures were used to determine the effect of deer browse, is there any data related to the other animals that could be excluded due to the fencing as well? Squirrels? Fox? The money making Bison?? Many island birds are ground dwellers and even those that aren't could be impacted by the fencing

○Flax-leaved broom spread. The report attempts to name deer as a culprit. This invasive plant, brought to the island by humans, spreads rapidly along roadsides, What is the effect of the massive increase in people traversing the entire island in a matter of days potentially spreading seeds on the soles of their boots? This argument is lacking in actual scientific integrity while attempting to elicit support for their point of view. This is not how science works. Continued on page 14

Stop the Slaughter from page 13:

○The Catalina Island Conservancy failed to successfully manage the population through hunting to achieve a target yearly percentage deemed necessary to protect rare and endangered flora. It presents some of the perceived issues with increasing hunting pressure such as cost of getting to the island, lack of local hunting guides, challenges in getting guns to the island, as problems that cannot be solved. Is there any evidence that they tried to solve these problems? These are not issues that don't have solutions. They didn't try to solve these problems because they didn't want to solve these problems. If it's "impossible" to control the deer to an acceptable percentage how is it suddenly possible to slaughter them all. This defies common logic.

These are just a few of the many many questions being asked by the public. Are these questions answered in some data not yet made available to the public? Maybe. WE DON'T KNOW. Is there healthy scientific debate that still comes to the conclusion that killing all of the deer is the only solution? WE DON'T KNOW. Are there emerging scientific schools of thought questioning the "kill em all" response to species deemed "invasive"? (the answer is yes but is not mentioned in THIS report) WE DON'T KNOW. And that's the point.

WE DON'T KNOW AND WE HAVE THE RIGHT TO KNOW

A 119 page report contains only a few short statements related to the cultural relevance of the deer to the people of Catalina Island. To quote "Only a small number of Catalina residents hunt and deer are not an essential part of culture, diet, or economy for the current generation." "Some senior residents express loss of self-sufficiency that while true in the past is no longer so" It claims if we really had to live off the land we would hunt all of the deer in a month. These statements are highly subjective, inaccurate, and inflammatory. . The are designed to paint a picture of Island culture as ignorant, outdated, fading and not worthy of consideration in the decision-making process. Nothing could be further from the truth. The relationship that Islanders have with the land is long term, deep, and almost impossibly important to describe. It is actively being passed on to the youth who are in no way passive or disinterested. The "seniors" are the best-underutilized resource of information regarding actual deer population, locations, and behaviors. There are intelligent, inquisitive, and motivated people who deserve to have their voices heard and questions answered.

LET THE CDFW KNOW THAT THIS IS YOU!!! Depopulate? Remove?? The report uses soft language to describe a proposed process that is anything but. They plan to slaughter all of the deer. They plan to kill all of the deer. Pictures of deer with cactus spines in their legs are disguised as concern for deer health. Pictures of high fawn mortality though tragic, are part of the reality of the natural world. What's not being said is that two large areas of concern are the burn area from the fire of 2007 and Avalon. These two areas are zones that for obvious public safety reasons cannot allow hunting. What is the plan then? Do we actually need to see pictures of pregnant does dying a slow and painful death from poison? What is exactly the plan? Again we simply do not know. Let the CDFW know that the humane treatment of the mule deer on Catalina is essential.

In summary we as citizens need to let the Catalina Island Conservancy and the California Department of Fish and Wildlife know that the current application to slaughter the deer on Catalina Island must be denied. There are alternatives that have not been sufficiently explored. The application is seriously flawed.

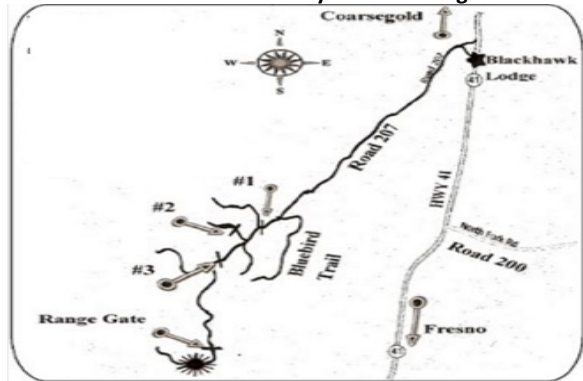

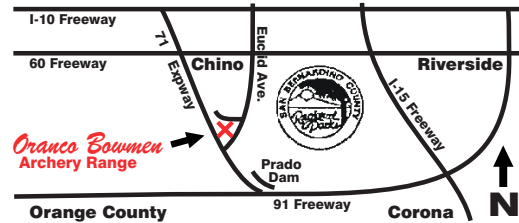
