SIC women's team wins Division I National Archery Championship

Harrisburg – In a Division I showdown that attracted 18 varsity teams and some 200 collegiate archers from across the nation, including University of Wisconsin, University of California, University of Nebraska, Liberty University, and Mississippi College, Southeastern Illinois College's women's bow hunter team consisting of Alli Armstrong (Elizabethtown); Jessica Morris (Golconda); and Kira McCalip (Rantoul) was crowned national champion after a grueling two days of competition.

The 2016 US Intercollegiate Archery Championships (USIAC) were held over the weekend at Sahara Woods State Fish and Wildlife Area, located between Carrier Mills and Harrisburg. Collegiate archery is governed by the US Collegiate Archery Association, a California-based group.

SIC's women have dominated Division I varsity archery over the past five years. As a team, they have to their credit three national championships, one second place finish, and one third place finish. In individual competition, Southeastern's Alli Armstrong won the national title in 2015.

In this year's overall competition, four Falcons were named All-American as a result of their individual top ten national finishes: Armstrong 2nd, Stephani Poe (Arthur) 6th, Morris 6th, and Casey Poe (Arthur) 5th. These four will carry equivalent national rankings for 2016-17.

Armstrong and Stephani Poe also were named to the USIAC Academic All-American team. Academic All-American honors are bestowed on those archers who finish in the top ten at nationals and carry an overall grade point average of 3.5 or higher.

In the open compound division, the mixed team of mother and son Stephani and Casey Poe finished third to take home bronze honors, while the duo of Armstrong and Elijah Bond of Thompsonville, garnered bronze medals in the mixed team bow hunter division.

Other members of Southeastern's archery team include Rhett Bullard (Iuka); Jeffrey George (Shawneetown) Makayla McKenzie (Carmi); Matthew Horton (Thompsonville); Garrett Lane (Elizabethtown); Kenny Raigner, Jr. (Carmi); Tyler Cheek (Shawneetown,); and Adriana Armstrong (Elizabethtown).

Armstrong, who is a freshman at Hardin County High School and a participant in Southeastern's developmental archery program, finished with a score that would have earned her 8th place in the nation and All-American honors in collegiate competition.

Southeastern's archery program now boasts of 13 national Division I titles, 24 All-Americans, and six Academic All-Americans.

I encourage all of you to attend the meeting and banquet. For those of you that have an interest in becoming an officer of your club, your region or the state, this is a great opportunity for you to learn the mechanics of CBH/SAA and the Annual Meeting. It will build on the foundation you might need for dealing with issues when you attain your goal as an officer. Besides, you will meet people who have been fighting for your sport whether it is target, hunting or both. It is also an opportunity for you to let them know you appreciate what many of them have been doing for the majority of their adult years... for you.

Having the meeting and banquet in Ontario means that all of you Southern California Members can make a short trip to attend the Big Game & Small Game Awards Banquet which is being held on Saturday evening. Please use the RSVP, see the flier located elsewhere in this issue, to advise the hosting region, OBFA, of your attendance. It will be a great night of recognition and a celebration with some of the best bow hunters in the state and the nation. See you ALL there!!!

The CBH/SAA, 2017 State Indoor Championship, 450 Round, will be held during the month of January at various shops and clubs throughout the state, as it is every year. See the flyer elsewhere in this issue for the venues near you. Be sure to make reservation and preregister in advance as there are limitations on the number of shooting lanes available at all venues. Again I am asking that you send me pictures of your archery experiences... target or hunting. I don't care if you are the State Champion or if you shot the Number One State Record Big Game Animal, or not. I want to read your stories and enjoy your pictures. Some of the best stories and pictures describe the experience you had, what you saw, and the people you were with and has nothing to do with a "trophy". Gary McCain I know you and Sandy are hunting whitetail deer in Nebraska so I expect pictures and a story from you also!!!!

Turkey hunters... it is now mandatory that we use Broadheads on our arrows while hunting turkeys... Like DUH!!! A year or so back the Department of Fish and Wildlife (DFW) expressed a concern to the CBH/SAA Legislative Team that the department had received reports of turkeys being wounded with arrows. They told us that upon investigation the responding wardens



found that in all cases the arrows were tipped with target or field points. Subsequently, DFW came to us, the CBH/SAA Legislative Team, and asked what we could do and what we would recommend, to curb this wounding issue. Our initial response was... Are the individuals who are wounding these turkeys being cited for shooting turkeys with arrows not tipped with broadheads? DFW then informed us that broadhead tipped arrows are not required by DFG Regulations. To say the least the Legislative Team, our Lobbyist Gaines and Associates, the Big Game Club and our bow hunting members who hunt turkeys were all shocked at learning that broadheads were not required. Logic and ethics both dictate that we use broadheads while hunting these smart, tough birds. In fact it is so well known that turkeys are a tough, tough, bird to kill that broadhead manufactures have designed special broadheads specifically for turkey hunting. The Legislative Team with the help of Bill Gaines of Gaines and Associates, then generated and took a proposal to the DFW and the Department of Fish and Game (DFG) Commission recommending a DFG Regulation change so that it is a requirement that all bowhunters hunting turkeys must have their arrows tipped with broadheads. The proposal was successfully presented and it was accepted by the DFG Commission as written and the regulations were changed. The broadhead must meet the same diameter requirements as the big game broadhead. That is, the broadhead must not pass through a 7/8 inch hole. Mechanical/retractable broad heads shall be measured in the open position.

I personally want to thank **Robert Moore, CBH/SAA Legislative Coordinator and his team, and Bill Gaines of Gaines and Associates** for all of the hard work they did on this issue. Without them we could have lost our ability to hunt turkey with archery equipment. If you are a hunter in California you might think about sending a thank you note to them to show your appreciation.

Writing this message has really been a struggle for me this time. I have sat in front of my computer for many hours over the last four days trying to figure out what to say and what not to say... and I hadn't typed a single line until tonight. I just couldn't get started. I finally forced myself to go back to the basics of the president's message and start this message off with what it should be about... archery and our organization. I apologize in advance for this rant but something must change because our countries future depends on it.

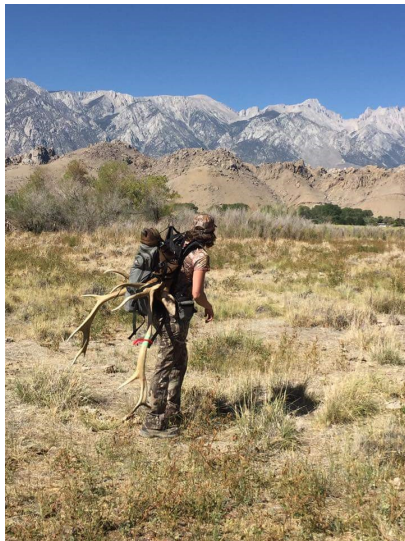
Remember, no matter what bow we bend or stick we shoot or outdoor sport we are involved in we must remain as one strong united family.

Legislative Information

Legislative Information

The next California Fish and Game Commission meeting (CFGCM) will be held December 7 & 8 in San Diego. Agenda has not been posted at this writing. Discussion on public comment petitions from the October meeting will be reviewed. A Petition to eliminate bowfishing for sharks will be discussed for further action to deny or refer to the Wildlife Resources Committee.

The Wildlife Resources Committee Predator Policy Workgroup will meet November 1st in Sacramento. Discussions on changes to predator management, pig management and non-game management will continue.

A meeting of the Hunting and Conservation Coalition (HCC) was held at the California Deer Association headquarters in Sacramento on October 12th. The coalition membership consists of the usual conservation groups associated with the Al Taucher Conservation Coalition (ATCC). The ATCC may have disbanded or changed to the new HCC as the Sportsmen Alliance has lessened its upfront status to back a states grass roots organization. Action items the HCC will focus on is Recruitment, Retention and Reactivation (or R3) of hunters and fishers, Outreach, Mentoring and Promotional. These action items are still being organized for implementation plans and volunteer assistance.

Zimbabwe Park to Cull 200 Lions, Cites Lack of Hunters

A wildlife reserve in Zimbabwe says it may have to cull 200 lions in the absence of hunters.

One of Zimbabwe's largest wildlife reserves, the Buby Valley Conservancy, recently announced that it was considering culling up to 200 lions as the cats have become increasingly overpopulated. The wildlife reserve said its current population of around 500 lions is unsustainable due to the dramatic decline in hunters, possibly caused by the controversy over Cecil, a lion killed near Hwange National Park last year. Buby officials say that without hunters to help manage the lion population, they are considering either hiring marksmen to shoot some of the animals, or capturing them and donating the cats to other reserves. Buby has historically held one of the largest lion populations in Zimbabwe.

“I wish we could give about 200 of our lions away to ease the overpopulation,” Blondie Leathem, the conservancy’s general manager, told the *National Post*. “If anyone knows of a suitable habitat for them where they will not land up in human conflict, or in wildlife areas where they will not be beaten up because of existing prides, please let us know and help us raise the money to move them.”

Leathem explained that the lions are a big threat to the park’s other denizens, which included antelope, giraffes, leopards, and a number of other native species. This problem is exacerbated by the fact that the conservancy is trying to recover from one of the driest summers on record.

Hunters traditionally helped to keep lion numbers in check, as well as bringing a much needed financial boost to the park. However, officials are now blaming something they call the “Cecil effect” for the lack of hunters. In 2015, the hunting of a black-maned lion named Cecil by an American dentist, [Walter Palmer](#), drew international outrage after the Zimbabwe government accused Palmer of poaching. The charges were [later dropped](#), but activist groups continued to target big game hunters in Africa and urged many governments, including Zimbabwe, to close their borders to hunters. This is despite the fact that many conservationists have long agreed that hunters are needed to not only manage wildlife populations, but also provide the funds to protect the same species they hunt.

Game species are not the only wildlife that hunters benefit. According to the Buby Valley Conservancy, it is funds from sportsmen and women that allowed it to create its rhino conservation project, which manages the third largest population of black rhinos in Africa.

“Today, the hunters’ legends live again in the Buby Valley, where populations of animals have had the time and the space to grow to maturity,” Buby stated on its [website](#). “Thriving herds live in balance on the open savannah, the mopani woodlands and in the dense riverine forests. The diverse habitats found in the Buby Valley Conservancy now support an astonishing 35 species of wild, free-ranging game animals including the classic Big Five.”

The conservancy spans roughly 850,000 acres.
