L. Communication Secretary

1. Be appointed or terminated by the CBH/SAA President and confirmed by a two-thirds (2/3) vote of the Board present at the annual meeting or by mail ballot.
2. Shall send out to the CBH/SAA membership, clubs, and shops, one standalone email with flyer at least three months before each state tournament.
3. Shall post the state flyer on all CBH/SAA social media accounts at least three months before each state tournament.
4. Shall email clubs & shops,
 - a. Email clubs and shops in February of bids for hosting the State Target due by April 15th. Bids to be sent to 2nd VP of Target.
 - b. Email clubs and shops in April of bids for hosting the State Broadhead due by June 1st. Bids to be sent to the 2nd VP of Hunting.
 - c. Email clubs and shops in April of bids for hosting the State Broadhead due by June 1st. Bids to be sent to the 2nd VP of Hunting.
 - d. Email clubs and shops in April of bids for hosting the State Unmarked 3D due two weeks before the State Meeting (typically held in June). Bids to be sent to the CBH/SAA Secretary.
 - e. Email clubs and shops in April of bids for hosting the State Marked 3D due two weeks before the State Meeting (typically held in June). Bids to be sent to the 2nd VP of Field.
 - f. Email clubs and shops in April of bids for hosting the State Traditional due by June 1st. Bids to be sent to the 2nd VP.
 - g. Email clubs and shops in June of bids for hosting the State Indoor due by August 6th. Bids to be sent to the 2nd VP of Indoor.
 - h. Email clubs and shops in December of bids for hosting the State Field due two weeks before the Annual Meeting (typically held in February). Bids to be sent to 2nd VP of Field.
