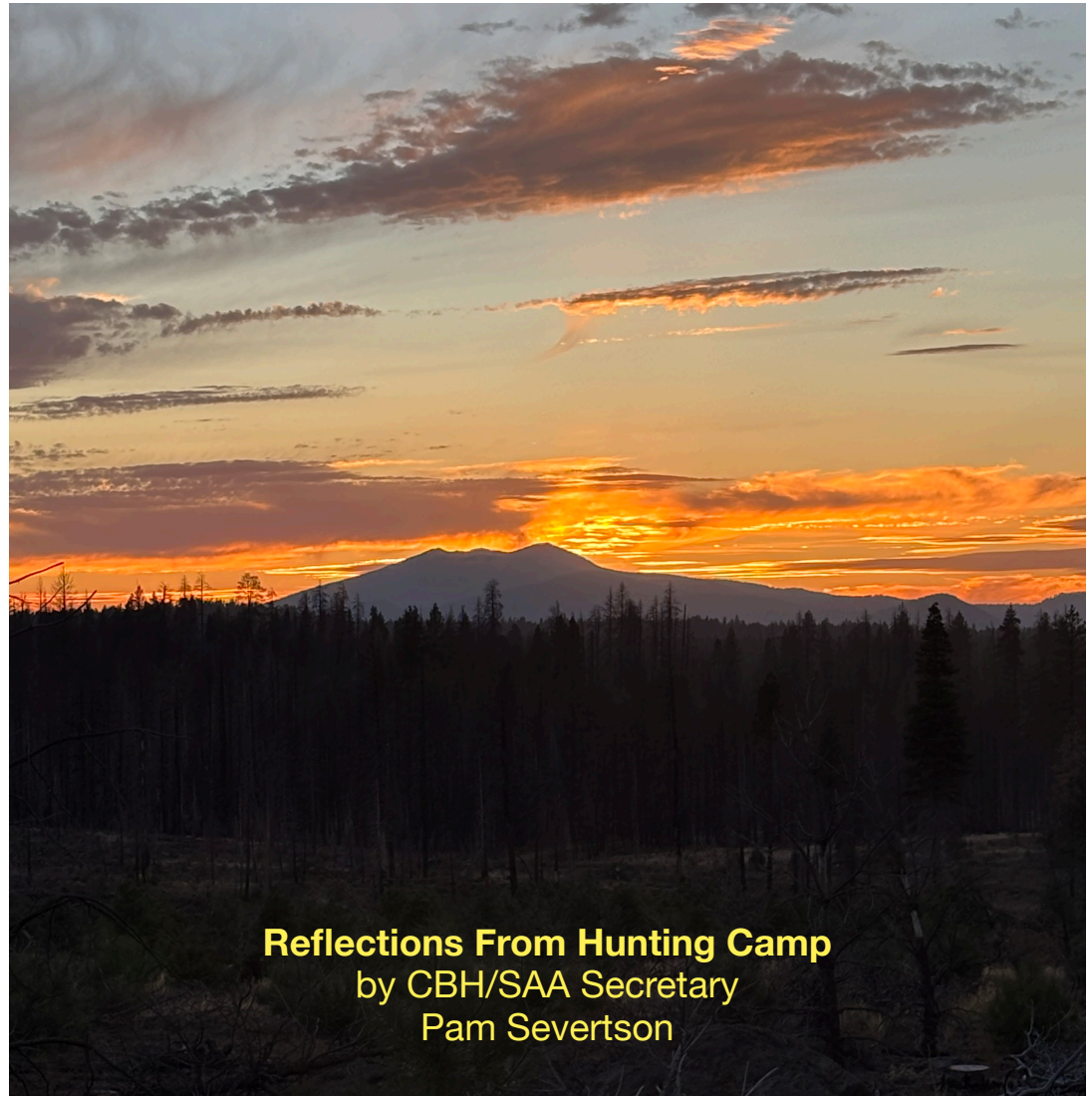

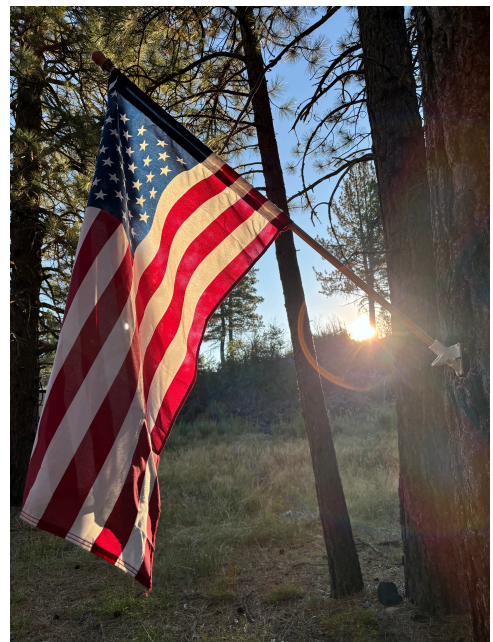

Legislative Report

Greetings CBH/SAA friends and family!

Following early activity in the State Legislature that saw several of our priority bills deferred until January 2026 and the Fish and Game Commission (FGC) approving this year's tag allocations, things have slowed down or at least become less urgent. Last month, Chriss and I attended the California Hunting and Conservation Coalition (CHCC) meeting and took away some interesting info and stories to share. Let's dive in!

- Our partners at California Rifle and Pistol Association (CRPA) continue to pursue legal action against California firearm legislation including the new **11% excise tax on firearms and ammo**. Please note, despite recent wins in court, some sellers outside of California are prematurely not charging the tax and you may be committing a crime. Don't break the law on the 11% excise tax! YOU are breaking the law when you accept shipping; not the seller when they ship to CA. Reach out to CRPA for more information and monitor progress of three cases currently presented to the Supreme Court.
- CDFW is already working on proposals for next year's hunting season. **CDFW regulatory proposals** will be discussed at the September 11 Wildlife Resource Committee (WRC) meeting including:
 - **Elk:** Owens Valley and central coast zone/regulatory changes
 - **Big Horn Sheep:** Add three new zones in Granite and North Bristol Mountains, Providence, Wood, and Hackberry Mountains, Castle Mountains and Piute Range
 - **Pronghorn:** Regulatory proposals are dependent on surveys currently in progress
 - **Deer:** No new regulations are expected in 2026 while CDFW focused on the Deer Plan
 - **Bear:** Add second bear tag and Northeast CA added to hunt zone. The proposal for a **2nd bear tag** warrants some additional detail. On July 30, the Humane Society, Project Coyote, Wildlife for All, and the Center for Biological Diversity submitted a letter to the FGC opposing a petition for purchase of a second bear tag. The letter attacked best available science arguing that Black bears are "an uncommon, rare species." Notably, CDFW's current methodology for determining bear population in CA (~60,000 bears) was recently peer reviewed and published in academia! This is expected to help combat anti-hunter rhetoric criticizing the bear population methodology in attempt to undermine the credibility of the Bear Plan and end bear hunting in California.
- Reminder: When you harvest a bear, you must take your harvest to CDFW for validation and scientific sampling.** Last year, CDFW was **30% short on bear teeth collected from hunter harvest. Please promote awareness!**
- CDFW is performing **wildlife surveys using Forward Looking Infrared (FLIR)** mounted on fixed wing planes to gather important population data. These surveys are performed at night resulting in less disturbance to the animals. Additionally, FLIR provides better data than visual surveys because it can detect animals in canopy cover. However, it cannot be used in rocky terrain because rocks have a heat signature. Check out these screenshots of video, **on page 6**, from an X3B test flight in July. Details are so clear, you can even see radio collars on some animals!!! Building upon CBH and CHCC efforts to advocate for more elk tags to help manage elk populations in conflict areas, CDFW added 44 SHARE elk hunts to the 2025 SHARE hunt draw. Because hunter applications for SHARE hunts were down this year, some individuals drew two elk tags, and **one lucky hunter drew three elk tags! INCONCEIVABLE!?! Encourage your friends to apply for these SHARE elk tags.**
- CDFW is preparing to host public information sessions regarding the **Deer Management Plan** update. CDFW previously held a scoping meeting with members of the CHCC on July 10. Keep an eye out for CDFW communications related to virtual and in person sessions. Dates TBD.
- CDFW is working on draft **Bobcat Management Plan** and staff indicated that it will be sent for peer review "soon." Following peer review, the draft plan will be reviewed by tribal governments, and public review is tentatively planned for fall 2025. As you may recall, when legislation removed our bobcat hunting privileges, it required CDFW to complete a Bobcat Management Plan and that stated that 2025 was the earliest that bobcat hunting could be reestablished. This is a LONG process.
- The **CALTIP Rewards Board** is a civilian committee that advises on reward structure for CALTIP (Californians Turn In Poachers and Polluters) callers that provide information leading to the arrest and prosecution of poachers and polluters. Currently, there are openings on the Board. Commitments include participation in 60-90 minute quarterly meetings. CDFW shared that hunters' participation in CALTIP recently helped take down a four-person poaching team that had poached sheep, abalone, and MANY other species. The hunting community received kudos and recognition for protecting wildlife. Note: CALTIP rewards come entirely from donations, no state funds are used. The CALTIP Rewards Committee, not CDFW, receives and administers these funds. Money not used for the payment of rewards goes toward furthering CALTIP's educational goals.

Reminder: Whether you have been involved in archery or hunting your whole life, or are new to this sport, you have something of value to add to the conversation, and I encourage you to reach out to me and the CBH Legislative Committee to share your knowledge and experience! We look forward to hearing from you soon!

Hunting season is in full swing, and I hope everyone's finding some success out there. I was fortunate enough to draw a Fort Hunter Liggett Tule Elk archery tag and made the most of it, taking a solid 6x7 bull. My son Travis, along with friends Frank and Jack, were there to help, and we also had a local guide, Tim Taylor, on the team.

Conditions weren't exactly in our favor—areas we'd scouted were closed for the season, and the big bulls we wanted stayed just out of reach on the other side of the fence. Still, on day 6 of the 9-day hunt, I was able to connect with a bull. That's hunting for you—equal parts frustration and excitement.



Here's the cool part: I shot him at 35 yards, he ran 35 yards, and dropped—right in the middle of a dirt road. Talk about luck! We drove the truck right up, loaded him whole, and headed off to cut him up. Now I've got about 300 pounds of elk in the freezer, and let me tell you—it's tasting pretty good.

As for the Record Book, progress is being made. Jerry and Randy are scrubbing names and cleaning up past errors, while I'm working with David Bacon to get the Small Game records squared away. With any

luck, we'll have a publishing date to announce soon.

Exciting news from the Big Game Club! I recently met with my Big Game Committee to discuss some new opportunities for our fair chase rules. Following along Pope & Young guidelines we are now going to all animals to be turned into the CBH Big Game Club records program using Lighted nocks and Sight lights!

**Statement/Advisory from California
Department of Fish and Wildlife**

Don't eat the meat!

There have been a number of cases of persons finding "Blue" meat & fat deposits in wild pig carcasses. This has resulted from the use of rodenticides in the state. Diphacinone is one used to control numerous species of rodents.

Monterey County trapper, Dan Burton Urban Trapping & Wildlife Control, found blue tissue while inspecting a pig carcass.

"Hunters should be aware that the meat of game animals, such as wild pig, deer, bear, & geese might be contaminated if the animal has been exposed to rodenticides," said CDFW Pesticide Investigations Coordinator Dr. Ryan Bourbour.

Please avoid eating any of the contaminated meat, as the pesticide is an anticoagulant. Also avoid contact with contaminated tissue.

Submit a Tip

CALTIP

If you witness a poaching or polluting incident or any fish and wildlife violation, or have information about such a violation, immediately dial the toll free [CALTIP](https://www.caltip.org) number **1 888 334-CALTIP (888 334-2258)**, 24 hours a day, seven days a week.

Or you may submit anonymous tips to CDFW using **tip411**. **tip411** an internet based tool from CitizenObserver.com that enables the public to text message an anonymous tip to wildlife officers and lets the officers respond back creating an anonymous two-way conversation. Anyone with a cell phone may send an anonymous tip to CDFW by texting "**CALTIP**", followed by a space and the message, to **847411** (tip411).

Or download the free **CALTIP** smartphone App which operates similarly to tip411 by creating an anonymous two-way conversation with wildlife officers to report wildlife and pollution violations. The CALTIP App can be downloaded for free via the Google Play Store and iTunes App Store.

Be prepared to give the fullest possible account of the incident including the name, address, age and description of the suspect, vehicle description, direction of travel, license number, type of violation and when and where it occurred. *You do not have to give your name.*

Shooters competing for awards will be grouped ("flighted") by age and bow style, with assigned targets. Prefer shooting alongside family and friends - register in the Guest Class (member and non-member categories/pricing available) and select your own target group – enjoy the tournament just for fun (no awards)!

Custom belt buckles from Molly's Custom Silver awarded to Tournament Champions in each bow style and gender (Combined Adult classed and up only). Example: Top male and female shooters in BHFS across all Adult, Senior, Silver Senior, and Master Senior classes combined will be named "Tournament Champion" for this style. Minimum of 3 shooters in a bow style are required to qualify for Tournament Champion title and belt buckle award.

NO RANGEFINDERS ON THE RANGE (including Guest class shooters)!

Longbow wood, Longbow aluminum/carbon, and Recurve-off the shelf styles shoot youth distances/stakes out to 50 yards max.

TOURNAMENT RULES

(Refer to CBH By-laws and Standing Rules at <https://cbhsaa.org> Calendar/Resources > CBH By-Laws)

SECTION A - Tournament Shooting Styles

Shooting Divisions and Styles.

Divisions: Master Senior, Silver Senior, Senior, Adult, Young Adult, Youth, Cub & Pro.

Styles in Adult, Senior, Silver Senior & Master Senior: Barebow, Bowhunter Freestyle, Freestyle, Freestyle Limited, Freestyle Limited Recurve, Traditional, Longbow aluminum/carbon, Longbow wood Recurve off the shelf & Barebow Recurve. Modern Bowhunter class is recognized for Adult class only.

Styles in Young Adult, Youth & Cub: Barebow, Barebow Recurve, Bowhunter Freestyle, Freestyle & Freestyle Limited Recurve, Longbow aluminum/carbon, Longbow wood and Recurve off the shelf & Traditional.

Style in Professional: Freestyle. Professional Divisions include: Adult, Senior, Silver Senior & Master Senior.

In CBH/SAA State Shoots, the following rules will apply; Longbow-wood and Longbow any arrow. Longbow archers shoot the youth distance out to 50 yards. In CBH/SAA State Shoots, CBH/SAA will recognize the Recurve-off the shelf; maximum distance for this class shall be 50 yards.

SECTION F:CBH/SAA STATE 3-D (UNMARKED) CHAMPIONSHIP TOURNAMENT

(excerpts relevant to shooters)

GENERAL WORKING MECHANICS

- 1) This tournament will consist of a minimum of 42 life-sized animal targets at unmarked distances.
- 2) This tournament shall be a one-(1) arrow tournament.
- 3) Participants must be a NFAA/CBH/SAA member or a CBH/SAA Associate Member and a resident of the state of California or declared residency or have a reciprocal agreement with NFAA on file, at the time of registration to participate for awards.
- 6) In the case of a non-piggybacked tournament, the archers will be assigned a target to shoot with their competition. This will happen in the case of a 1-day tournament or a 2-day tournament.

8) SCORING:

- a) Scoring shall be: Inner Kill Ring= 10 points, Outside Vital Ring= 8 points, Balance of Animal= 5 points.
- b) Scoring on buck/doe combinations shall be as noted above for an arrow in the buck. A hit on the does shall be scored as 0 points.
- c) An arrow must remain in the animal to be scored.
- d) Skip-ins will not be scored. (e.g., 0 points)
- e) An arrow must touch the line to score in the higher scoring area.
- f) No mulligans or doe tags are permitted.
- g) Ties will be decided by a sudden death shoot-off.

9). DIVISIONS AND AWARDS:

- a) Shooting Divisions and Styles shall follow CBH/SAA Standing Rules Article I - Tournaments, Section A - Tournament Shooting Styles. (See Above)
- b) Awards will be First through Third Place in each division.
- d) A single guest division shall be set up for non-members of CBH/SAA. Shooters in this division shall not be eligible for awards.

12) PROTESTS: Protests will cost \$50.00. A protest can be filed, only by a registered archer of said tournament, or the parent/guardian if juvenile is going to protest, at any time during the tournament or within 30 minutes of conclusion of the shooting day. The 2nd V.P and/or designated Tournament Chairman will rule on the protest. If the protest is upheld, the fee will be refunded.
