Greetings CBH/SAA friends and family!

I hope you are all enjoying a wonderful Memorial Day weekend and unofficial start to summer. Unfortunately, family events kept me from attending the State Broadhead in Lodi this year, but the Legislative Team is well represented by Chriss Bowles, Joe Wylie, and special Saturday evening guest speaker Bill Gaines! We appreciate the opportunity to speak directly to CBH members and educate folks on current events affecting archery, conservation, and hunting. Thank you for participating!

Shourtly after the State Broadhead Shoot, on Tuesday, May 28, Bill Gaines, Chriss Bowles, Maya Archers, and I will be at the **2024 California Legislative Outdoor Sporting Caucus Trap Shoot** at the Yolo Sportsmen's Club in Davis. Thanks especially to Maya Archers, CBH/SAA will once again host the ever-popular archery range. It's one of the main highlights of this annual Shoot and provides us an opportunity to speak directly with our representatives in the State Legislature and their staff while sharing our passion for outdoor sports and conservation. CBH/SAA is a proud sponsor of this event!

The following day, the CBH/SAA Legislative Team will participate in the quarterly **California Hunting and Conservation Coalition (CHCC) meeting** to discuss items affecting hunting and conservation throughout the state and collaborate on priorities and strategies for our combined efforts. At the top of the list for discussion is the **Draft Bear Management Plan**, which is currently available for public review and comment. As noted on the California Department of Fish and Wildlife (CDFW) website, the two main goals of the Draft Black Bear Conservation Plan are 1) To conserve black bear populations that are abundant, disease-resilient, genetically diverse statewide and regionally, and conserve and enhance their habitats; and 2) To provide

opportunities for black bear hunting, viewing, and public education; minimize human-black bear conflict; consider animal welfare in black bear conservation; and be inclusive of all Californians in black bear conservation decisions. Once the plan is adopted, CBH/SAA and our partners in the CHCC will evaluate opportunities to petition the FGC for regulation updates related to bear hunting based on current science (e.g., hunting with hounds, second bear tags, spring bear hunt, etc.). I encourage you to review the plan at <https://wildlife.ca.gov/Conservation/Mammals/Black-Bear> and let us know what you think CBH/SAA and our partners should prioritize!

The deadline for California's 2024 Big Game Drawing is coming up on June 2, but the CBH/SAA Legislative team is already planning for the 2025 hunting season. On May 16, CBH/SAA participated in the **Wildlife Resource Conservation (WRC) Meeting**. We advocated for an increase "archery only" elk tags in the early archery seasons, in conflict areas where firearms may not be appropriate, and in areas to help prevent the interbreeding of imported and endemic elk herds

We also expressed our ongoing desire to participate in and support town hall meetings and other CDFW outreach efforts to sign up landowners in the SHARE program. Finally, we requested that CDFW reexamine regulations allowing archers with a Carry Concealed Weapon (CCW) permit to carry for all big game except deer. The deer exclusion does not make sense and prevents CCW holders from access to this protection tool (e.g., predator/mountain lion attacks noted in recent news and dangers related to illegal grow operations). CCW holders adhere to a rigorous permit process and are low/no risk of illegally taking deer with a firearm, which would jeopardize their CCW. - This month, the CBH/SAA Legislative Team also supported hunting and conservation actions by:
- Signing the wildlife coalition letter of support for **SB 1163 Wildlife Vehicle Collisions/Wildlife Salvage Permits** – legislation which would facilitate the collection of data on the location of vehicle-wildlife collisions and authorize the salvage of edible big game killed on our roadways. To pass SB 1163 out of Senate Appropriations Committee, there was an agreement to amend the bill to add language which requires a special appropriation by the Legislature to implement the bill's proposed pilot program. We knew that the 2024/2025 fiscal year would be an extremely tough budget year, and passing legislation which would implement a new program (i.e., add a new expense) would be difficult. The author, Senator Brian Dahle sits on the Senate Budget Committee, and on the Senate Budget Committee subcommittee which has oversight over CDFW's budget. As such, he is positioned to try to earmark new funding for the effort in the 2024/2025 State Budget deliberations. Having the Senator positioned as such increases our chances of securing funding, but in no way guarantees it. Stay tuned for updates!
- Signing the coalition letter of opposition to **Habitat Conservation Fund (HCF) General Fund Transfer/Sunset Trailer Bill**. As part of the May Revision of the 2024/25 State Budget proposal, the Newsom Administration is proposing to revert \$45 million of previously appropriated General Fund dollars that are in the HCF, and proposed trailer bill language to sunset the HCF this year. When the HCF (created by Prop 117 in 1990) was about to expire after 30 years (in 2019), the Legislature and the Administration negotiated a ten-year extension: that's \$300 million over the ten years between 2020 and 2030 for wildlife habitat. The very next year the Administration tried to "undo" this action and proposed trailer bill language to sunset the program. The Legislature soundly rejected that proposal but unfortunately, they're back with an early sunset this year *and* proposing to sweep \$45 million already appropriated.

- Supporting federal legislation [S. 4222](#) that would **restore hunting access to Castle Mountains National Monument** by transferring the land to the adjacent Mojave Preserve. This Bill has broad support including the CHCC and several "green groups" such as the National Parks Conservation Association, Conservation Lands Foundation, Calwild, and more.

I am sad to report that on May 7, CDFW announced two positive tests for **Chronic Wasting Disease (CWD)** in deer in the Yosemite and Bishop areas. We hope this day was a LONG way off. Please support the science and management of our deer considering this significant threat by 1) following California and other state regulations governing the movement of deer, elk and their parts; and 2) have your harvested deer or elk sampled and tested for CWD by bring your deer or elk either to a CDFW sampling station, CDFW office, or participating taxidermist or meat processor. The CDFW CWD What you need to know infographic is included in this newsletter for more information.

Finally, the Legislative team continues to track the progress of the Catalina Island Conservancy's (CIC) application to CDFW to **eradicate all mule deer on Catalina Island**. There are no significant updates to report this month. CBH will continue outreach to influential members of the legislature, CDFW and FGC to try to gain traction on our request for additional scientific studies to ensure any decision made by the CDFW is based on hard science. You can also reach out to Assemblymember Josh Lowenthal (D) and Senator Benjamin Allen (D), who represent Catalina in the State Legislature and ask them to get involved and urge the governor to direct the CDFW to deny this permit.

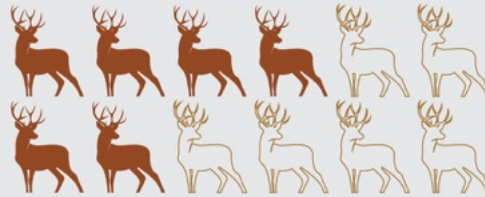
Chronic Wasting Disease (CWD): What you need to know

WHAT IS CWD?

CWD is a **fatal neurological disease** of cervids (i.e., deer, elk, moose and reindeer).



HOW DOES IT SPREAD?



CWD spreads to cervids through contact with infected animals, tissues and environments.



HOW CAN WE HELP PREVENT THE SPREAD OF CWD?

Testing deer samples helps us know if CWD is present and allows us to better respond and manage the disease.

WHICH U.S. STATES HAVE DETECTED CWD?



■ States with detected cases of CWD

(Non-positive CWD states are WA, OR, NV, AZ, IN, SC, GA, ME, NH, VT, MA, CT, RI, NJ, AK and HI.)



Hunters can bring their harvested deer or elk to a California Department of Fish and Wildlife (CDFW) sampling station or regional office to be sampled for CWD. Alternatively, the head can be brought to a meat processor or taxidermist participating in CDFW's CWD Sampling Program. CDFW will collect paired lymph nodes, dime to quarter-sized tissues, located behind the jaw along the spine.



OUT-OF-STATE HUNTING & HARVEST IMPORT



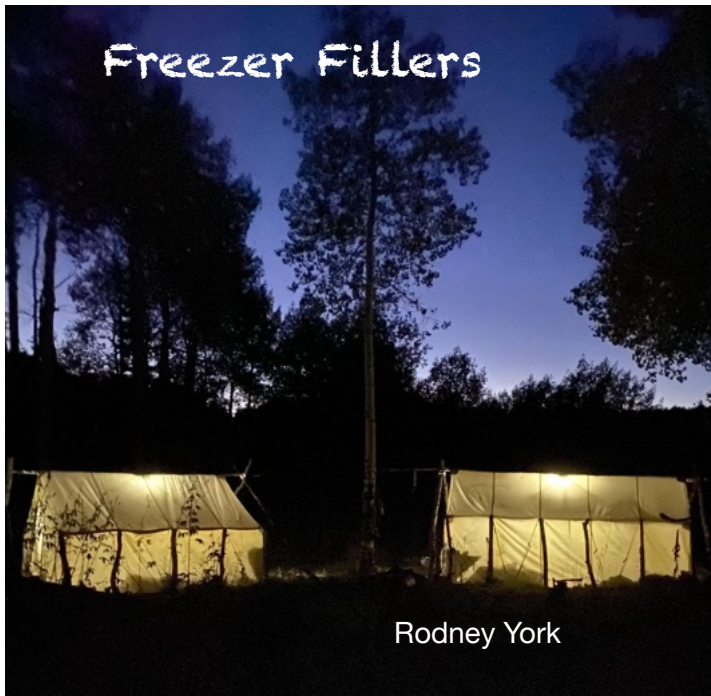
The California Code of Regulations, Title 14, Section 712 governs the importation of hunter-harvested deer and elk (cervid) into California. Only some parts of a harvested deer or elk can be imported, and no portions of the brain or spinal cord may be imported. Visit wildlife.ca.gov/CWD to learn more.

CBHSAA The year 1940 saw the adoption of our first official publication, *Ye Sylvan Archer*, published by John Davis of Corvallis, Oregon. N.F.A.A. dues were 50 cents per year and another 50 cents was collected for the subscription.

The final big event of this all-important year was election of permanent officers. A.J. Michelson of Flint, Michigan, was elected President; Paris B. Stockdale of Columbus, Ohio, Vice President; T.C. Davidson, Springfield, New Jersey, Eastern Rep.; Fred Bear, Detroit, Michigan, Midwest Rep.; Harold Macquarrie, Western Rep.; and Karl Palmatier was appointed Tournament Chairman.

This portion of information was taken from the California Bowmen Hunters (C.B.H.) and State Archery Association (S.A.A.) The First Fifty Years book that was published by Walker Publications Inc. (c) Jan. 1993 CBH-SAA

1941 - saw the adoption of the stump and arrow emblem. Earl Stanley Gardner, author of the *Perry Mason* Series, had written several articles on the art of stump hunting and had pointed out that a man who had went out for fun and didn't take the sport too seriously was the man who always had the most fun. The design was one of several done by Dick Schroeder, nationally known artist and archer. The stump emblem was unanimously adopted by the Executive Committee.

1942 - brought publication of our first handbook, and the adoption of the 20 pin award. The 20 pin was created and donated by the Northern California Field Archers.

1943 - brought adoption of the Flint Indoor Round and the first Indoor Mail Tournament. Also, John Davis, editor of *Ye Sylvan Archer*, entered the military. As a result, *Archery Magazine*, edited by Roy Hoff, became our new publication.

1944 - The Art Young Small Game Award was adopted. The award was designed and donated by Austin Brosseau of Saginaw, Michigan.

1945 - Dr. Kenagy of Rupert, Idaho, designed and donated the silver and gold arrows award for taking additional game.

1946 - First field tournament was held in Allegan, Michigan, with 476 archer participants. It was the biggest and most successful tournament ever held. Karl Palmatier was our tournament chairman. It was a single division tournament; one mark was permitted. Awards were medals designed by West Wescott, N.F.A.A. Vice President. The design was taken from a 600-year-old Roman coin - lion with an arrow in its mouth.

1947 - Our second national tournament, held at Salt Lake City, displayed for the first time our silver bowl perpetual trophies. The men's bowl is a copy of the Sons of Liberty Bowl made by Paul Revere in 1768. (15 Sons of Liberty met at William Marston's Green Dragon Tavern of Boston.)

* Diana Bowl (ladies trophy) was donated by the Artillers. This is an ancient word meaning archery tackle manufacturer, and this organization was the forerunner of AMO, the present Archery Manufacturers Organization.

* Boys Bowl, donated by Utah State Archery Association.

* Girls Championship Bowl, donated by Washington Bowhunters Association.

The Compton Medal of Honor Award was created. This is the highest award which can be bestowed by the N.F.A.A. and serves to perpetuate the memory of Will "Chief" Compton.

1950 - tournament held at East Tawas, Michigan, with a freestyle division added. The 1950s can be described as the golden years of field archery. Membership grew, club activities flourished, tournament attendance pyramided. Controversy developed because of the growing popularity of freestyle shooting instinct of archers felt that they were being delegated to a secondary role.

1958 - Pope and young Big Game Trophy competition was created by the NFAA with Vice President Glenn ST. Charles as chairman. It remained an NFAA program until 1963 when it became a separate entity

The national tournament held at Grayling Michigan attracted an all-time attendance of 1402 participants.

1959 - Will be remembered as the year we started to purchase our headquarters building at Redlands.

1961 - was our darkest hour with the association near bankruptcy. A lack of physical responsibility had overextended our financial capabilities.
