

Look for Robert or any other CBH representatives at your shoot soon.

I will be working on a couple of youth events and I really get a kick out of doing these. I want to start by thanking the Oranco Bowmen and the Cherry Valley Bowhunters for their participation. We usually get a large crew for The Mike Raahauge's Youth Safari Day. Steve Baker and Oranco provided a crew for the Compton Hunt and Fish Club Youth Enhancement Program Outdoor Adventure Day. Both events are for kids and involved sharing the experience of archery and shooting. We always

get great participation and share our love for archery with literally thousands of kids who often don't have much chance to get outdoors. I like to believe we are helping not only the local shops and clubs but also archery in the entire state of California.

On May 15th, I attended the California Fish and Game Commission's Wildlife Resource Committee (WRC) meeting, which was eventful. The WRC, as you may know, is a California Fish and Game Commission subcommittee chaired by two of the five commissioners. Erika Zavaleta is the Commission President, and Darius Anderson is a commissioner.

The committee is pretty much the sounding board and the entry point for any petitions or regulation changes going to the full commission for consideration. With Bears and Coyotes on the agenda, this one promised to be one for the ages. I was not disappointed... I arrived with Bill Gaines and just a tad early. I had the chance to speak with Mario Klip, PhD, who is in charge of gathering and presenting the proposed big game regulation changes.

Mario informed me that two bear tags and a new northeastern zone were being presented, but nothing more at this time. Based on the expected audience, I understood his trepidation and began wondering how he planned on getting out of the building alive at the end of the day. All that being said, his presentation went surprisingly smooth and he remained unscathed.

There are plans for two additional sheep zones next year, along with some additional tags. Keep in mind that sheep hunting out in the desert is some of the most challenging you will ever do, especially with a bow. Antelope tags will remain unchanged due to declining populations. The department seems to think the declining herd densities are largely due to habitat loss, and I am inclined to agree.

Deer and Elk will remain largely unchanged, dependent on any new Chronic Wasting Disease (CWD) eruptions. By this point in the meeting, we had grown to about 75 people in the room and approximately 500 attendees on Zoom. After the usual crying and wailing about the warm fuzzy bears, how everyone should have one for a pet, and how the best way to slow one down is with a "well placed pinecone" the committee chairs agreed to move forward with the proposed regulation framework. We will continue to work on some archery bear season date and length changes in order to move archery and rifle together into

one long season for everyone. This doesn't seem to have much traction at this point, but we're going down fighting.

During a break I had the pleasure of talking briefly with Darius Anderson as he wanted me to know about his new bow. Darius is a well-to-do and well-placed political appointee with excellent connections. He is the owner of Wing and Barrel Ranch in Sonoma and is an avid outdoorsman. He is also a Democrat and a personal friend of Governor Gavin Newsom. He told me he is practicing at the ranch and planning a Montana elk hunt at Newsome's Father-in-Law's ranch. He is also planning to install a small archery range at his hunt club. Darius is a great friend to all of us in the outdoor conservation community and has been very helpful in getting the full commission to see our side of the various wildlife issues.

SOOOOOO....as I always say...every Democrat is not your enemy! As a sidebar, I would like to thank Rudy Sandoval and the entire West Coast Archery Team for setting him up with gear and helping with his plans. Great job, guys!!

All that being said, the coyote issue was on the afternoon's agenda, and it would not go quietly. The chair started with elected officials and then went to general comments. For the record, the coyote issue was simply in the fact-finding phase, and there was plenty to go around. I counted seven county sheriffs and four county commissioners giving testimony, then on to us in the room.

Keep in mind, as I have said before, there has never been any discussion of outlawing coyote take. It has simply been a discussion of limiting it along with regular species management. The testimony went from 2 p.m. to 6:45 in the evening and by the time it was over there were eight people left in the room. Bill Gaines and I were two of the group. The two committee chairs were also there, along with the two top staffers.

## Legislative Report

Greetings CBH/SAA friends and family!

It's been a couple of months, and we have LOTS of updates for you from the State Legislature and Fish and Game Commission (FGC). Let's dive in!

First, this past Friday, May 23, was the deadline for fiscal committees to hear and pass to the Floor legislation introduced in their house. As the first major hurdle for bills in the 2025 Session, several bills were held for this year, while others continued their legislative journey by moving to the Floor. With the June 6 deadline for legislation to pass out of its house of origin only about a week away, activity in Sacramento is at its peak. Here are some key updates:

- AB 1038 Bears: Hunting: Use of dogs** – Co-sponsored by the California Houndsmen for Conservation and the California Deer Association, this bill introduces legislation that would require the Fish and Game Commission (FGC) to establish seasons during which a person would be authorized to allow dogs to pursue a bear if the person does not injure or kill the bear or allow the bear to be injured or killed while engaging in the activity. Additionally, following adoption of the updated Bear Management Plan by the California Department of Fish and Wildlife (CDFW), the bill would authorize the FGC to establish a bear hunting season during which a person, pursuant to a bear tag, would be authorized to allow dogs to pursue a bear in any area determined by the FGC. AB 1038 was heard in the Assembly Water, Parks and Wildlife Committee on April 29. Going into the hearing, animal-rights opposition was expecting yet another easy victory on the extremely uneven playing field of the California State Capitol. Yet, following intense lobbying by Gaines & Associates, the California Houndsmen for Conservation, the California Deer Association, and our partners in the CHCC, the result was far from an easy victory. After receiving testimony from the support and opposition to AB 1038, and a series of questions to both sides from the dais, the vote roll was called. Seven "aye" votes were needed for AB 1038 to pass out of the 13-member Assembly Water, Parks and Wildlife Committee made up of 10 Democrats and 3 Republicans. With most expecting AB 1038 to suffer a quick and overwhelming defeat, the bill quickly racked up six "aye" votes against only three "no" votes. With AB 1038 needing just one more vote to pass, the committee took a five-hour nerve-wracking recess. The lobbying team in support of the bill quickly hit the Capitol Halls once again to visit the four offices that had not yet voted - seeking that single needed "aye" vote.

Following several hours of lobbying, the committee reconvened and went through the roll of those who had not voted. Failing to get that one final illusive "aye" vote, AB 1038 failed to pass on a six "aye"/four "no" vote count, with three members not voting. Continued -But AB 1038 is not dead yet. Assembly Member Hadwick quickly asked the committee for "reconsideration" of the bill - a motion that, if carried, allows a measure that failed to be heard again in committee. On a unanimous vote, the committee agreed to allow the bill to be heard again. Due to legislative deadlines, the bill cannot be heard again in committee until January 2026, during the second year of the 2025/2026 Legislative Session. AB 1038 is now a "two-year" bill which cannot be reconsidered in the Assembly Water, Parks and Wildlife Committee until January 2026. Continued on next page

- **AB 1169 Wildlife Grants: Shared Habitat Alliance for Recreational Enhancement Program (SHARE) -**  
Existing law provides that it is the intent of the SHARE program to encourage private landowners to voluntarily make their land available to the public for wildlife-dependent recreational activities (e.g. hunting). The law requires a cap on financial compensation CDFW may offer to a private landowner of \$30 per acre, or \$50 per public participant per day. This bill would remove the required cap on financial compensation offered to private landowners pursuant to the SHARE program and would authorize the CDFW to reimburse a nonprofit organization, a private landowner, or other entity for its services related to the implementation of the program. As amended May 23, 2025, AB 1169 would address this concern by increasing the required cap on financial compensation offered to private landowners pursuant to the SHARE program to \$52 per acre, or \$87 per public participant per day, and would require those figures to be adjusted annually for inflation. AB 1169 was heard in the Assembly Appropriations Committee on May 23rd, amended, and passed out to the Assembly Floor on a unanimous vote. AB 1169 must be voted on and passed off the Assembly Floor by June 6 to meet legislative deadline.

- **SB 427 Habitat Conservation Fund (HCF) -** This bill would require the State Controller to continue to annually transfer \$30M from the General Fund to the HCF indefinitely. CBH and our partners in the CHCC successfully defeated an attempt to sunset the HCF early and this bill would protect these conservation dollars in perpetuity. Failing to pass out of the Senate Appropriations Committee and to the Senate Floor by the May 23rd legislative deadline, SB 427 is now a "two-year" bill and cannot receive any further consideration until January 2026.
- **SB 818 Mountain Lions: Pilot Program: Permitted Houndspersons –** This bill would require the CDFW to, by January 1, 2027, establish a pilot program known as "Tree and Free" in the County of El Dorado in order to collect data on the efficacy of authorizing permitted private houndspersons to proactively haze mountain lions deemed to be a potential threat to public safety, livestock, or other domestic animal by the CDFW, animal damage control officer, or local enforcement agency. **President's Message from page 4-** One person was running the Zoom, and one poor slob from the California Cattlemen's Association rounded out the attendee lineup. Needless to say, it was a long day. Closing comments from both committee chairs were very clear. There is no discussion, nor will there be any discussion, of ending the lethal take of coyotes. Coyotes are classified as non-game mammals in the Title 14 Fish and Game code and will remain that way as long as the commission does not make changes to the code. The commission is still in the informational stage of this thing; more to follow as it becomes available.

After the tally, it looks like over 220 people testified on this issue over the almost five hours. The vast majority testified in opposition to any changes to coyote take. Huge thanks to everyone who chimed in!! The silliness can be slowed and stopped if we all work together.

In closing, I want to touch briefly on the consequences and overreaction of the ignorant and unwashed. I think I was fairly clear in my social media post about the circumstances surrounding the serious injury at the West Virginia Total Archery Challenge (TAC) event.

I don't think I need to rehash the whole thing except to say that everything we do has consequences, and some are unintended and very dumb. In this case, a young archer was struck in the head by an arrow, causing a serious injury with a long recovery.

After my social media post, I received a phone call from a friend who is big in Boy Scouts and very big in their shooting sports education. Tom is a super guy, and he and I have worked together on several big events for the Boy Scouts. He simply said that he heard about the incident at the TAC event and asked, "WHAT HAPPENED???" I gave him what few details I had, and he proceeded to fill in the rest. Turns out the shoot was on a big Boy Scout ranch that they rented in West Virginia. This ranch is well known and brings kids from around the country. After the incident, the TAC shoot was immediately shut down, and all Boy Scout leaders across the country were ordered to stand down ALL shooting sports events at ALL Boy Scout ranches, facilities, and events until further notice. Going into the summer, I can only imagine scout leaders, parents, and scouts' frustration. As you can see, it only takes one dumb accident to start the ball of bad decisions rolling. Is this an overreaction? Well, of course it is. Archery is one of the safest sports going. It ranks right up there with golf. This is coming from a guy who has watched two friends die of heart attacks on the golf course.... But I digress. We have a very safe sport and an excellent track record. Work with every new person you see to help them understand the safety and the reasons for why we do what we do. Let's avoid the unintended consequences here in California.

### 63<sup>RD</sup> ANNUAL CALIFORNIA STATE BROADHEAD TOURNAMENT REPORT

Well, the annual state broadhead tournament, hosted by Oranco Bowmen in Chino, California, is in the books. I must say it was a resounding success. With 125 shooters from all over the state attending, perfect weather conditions, and a pretty challenging course to shoot both days, everyone had a great time competing and visiting with friends.

I would like to thank my committee for helping get this tournament organized and ran like clockwork: Chriss Bowles, Tina Monkarsh, Jack Hankins, Brad Grap, Randy Long, Travis Scott, Ken Wagner, Jerry Maytum, and Rodney York.

The bill would require the program to be operative for 5 years from the date of commencement and, once concluded, would require the CDFW to, no later than January 1, 2033, provide a report to the Legislature and the FGC on the efficacy the program and feasibility on expanding the program to other areas, as specified. Following several amendments, the bill was heard in Senate Natural Resources and Water Committee on April 22 but failed to pass on a party-line vote. The committee then granted the bill “reconsideration” via another party-line vote – allowing the bill to be heard again in committee. The committee then used a party-line vote for the third time to gut out the language Senator Alvarado-Gil had worked with the Brooks family and Gaines & Associates to place in the bill and replace it with their own hostile amendments. The amendments forced into the bill fully deleted the core of the bill which was to promote public safety, replacing it with language which promotes only actions county residents are already doing to protect livestock. SB 818 is dead.

### • **AB 724 Fur-Bearing and Nongame Mammals:**

**Trapping Licenses** - As introduced AB 724 is a “spot bill”, which would make a non-substantive change to current law which requires a person who traps fur-bearing mammals or nongame mammals to procure a trapping license from the California Department of Fish and Wildlife (CDFW), and pay a specified fee. CBH and Gaines & Associates continues to closely watch this legislation for amendments which capture its true intent. Our concern is that once amended, the bill may impact hunting of coyotes and the state’s ability to manage skyrocketing coyote populations. Further, adverse changes to regulations pertaining to the hunting of coyotes are currently being pressed by animal-rights interests in the FGC theater (more on this later). AB 724 can certainly be viewed as a “back-up” plan to change the law should their efforts to change the regulations via the FGC fail. AB 724 is now a “two-year” bill which cannot be considered until January 2026.

### • **AB 764 Birds and Mammals: Nongame Birds -**

Existing law allows for taking and possession of invasive nongame birds such as the English sparrow and the starling without a hunting license or depredation permit if taken by a landowner or lessee, or an agent thereof in possession of written authority from the landowner or lessee. AB 764 would allow **mute swans** to be taken or possessed under the same circumstances as other listed nongame birds. AB 764 is sponsored by the

- California Waterfowl Association. Introduced to North America from Europe during the mid-1800’s to early 1900’s, mute swans are considered a highly invasive resource competitor to native waterfowl in North America. Largely non-migratory, they do not socially aggregate with other native waterfowl species during the winter and are highly aggressive towards native waterfowl during the breeding season. Mute swans prefer California’s highly limited permanent and semi-permanent wetland habitats which are of critical importance to many sensitive species as well as for breeding waterbirds. Mute swans within California also occur in large numbers in sensitive tidal habitats in the Sacramento-San Joaquin Delta, Suisun Marsh, and greater San Francisco Bay. Current (2024) estimates are that mute swan populations have increased to 6,912. AB 764 would provide CDFW with greater flexibility to control invasive mute swan populations and, in doing so, help protect native waterfowl and other wetland-dependent species and reduce impacts to sensitive wetland habitat. AB 764 passed out of the Assembly Water, Parks and Wildlife Committee via unanimous vote on March 25. Maintaining its momentum, AB 764 was heard in the Assembly Appropriations Committee on April 9, passing out and to the Assembly Floor via a unanimous vote. On April 24, AB 764 was brought up on the Assembly Floor, passing out and to the Senate on yet another unanimous vote. Now in the Senate, AB 764 has been referred to the Senate Natural Resources and Water Committee but has yet to be set for hearing.

Next, here are some of the highlights from the April FGC meeting and May Wildlife Resource Committee (WRC) meetings:

### • **Waterfowl Regulations:**

- Increase duck and goose season length in most zones from 98 to 103 days;
- Increase the pintail daily bag limit from 1 to 3 birds per day in all zones;
- Brant season length decreased from 27 to 16 days;
- Swap the Veteran’s Hunt Weekend with the Youth Hunt Weekend in most zones;
- No Falconry-Only season in most zones due to increased length of general season.

### • **Nelson Big Horn Sheep:** 7 additional tags allocated

- **Big Game Hunting and Chronic Wasting Disease (CWD):**
  - Deer - New G40 Late Season Hunt: November 22 through 30; Quota: 25 tags; Hunt Zone: That portion of Madera County that lies within D7.
  - Defines CWD Management Zone to be adaptive including 1) any deer hunt zone where CWD-positive animal has been detected or is within 5 miles of a detection, excluding Zone A; 2) Within Zone A, any county where a CWD-positive animal has been detected or is within 5 miles of a detection. CDFW will maintain a website with current CMZs (CWD Management Zone) and designations to notify hunters of requirements: [www.Wildlife.ca.gov/CWD](http://www.Wildlife.ca.gov/CWD)
- **Nelson Big Horn Sheep:** 7 additional tags allocated
- **Pronghorn Antelope:** 68 tag reduction during the 2024 and 2025 hunt seasons (e.g., additional 21 tag reduction from 2024 allocation). Helicopter surveys conducted by CDFW in February 2025 indicate a continued decline in population. Habitat management is critical to sustaining and recovering pronghorn herds.
- **Elk:**
  - 30 “archery only” tag added (20 bull and 10 antlerless). **For the past year, CBH work closely with Gaines & Associates and Rocky Mountain Elk Foundation (RMEF) to secure maximum elk hunting opportunity including this notable increase in “Archery Only” elk tags!**
  - 17 general tags added (13 bull and 4 antlerless);
  - CDFW is proposing a “collective hunting approach” in Northwestern and Mendocino conflict zones including General, SHARE and Landowner tags totaling 321 tags (108 bull, 210 antlerless, 3 either sex).
- **Coyotes: Oh! The DRAMA!** So, let’s back up a bit. The January 15 agenda of the WRC stated that the Committee would undertake “Discussion and potential recommendations for change to the take of nongame mammals regulations.” What occurred was a targeted and specific attack on coyote hunting and trapping that was not clear from the agenda phrasing. Following discussion, a recommendation emerged that the FGC amend C.C.R. § 472 be to remove coyotes as a non-game mammal, essentially curtailing public safety agencies’ ability to manage coyote populations to ensure public safety and the ability of agricultural interests to proactively prevent depredations – all without input from key stakeholders in the hunting and agriculture community. How did this happen?!

The WRC is co-chaired by Commissioners Zavaleta and Anderson. The agenda topic was opened with both Commissioners Zavaleta and Anderson present, and it was made abundantly clear by the initial discussion that Commissioner Anderson was opposed to the proposal. However, when Commissioner Anderson had to leave for another meeting, Commissioner Zavaleta voted to make the recommendation unilaterally. At that time, representatives of HCC in attendance publicly commented that they believed it inappropriate for the recommendation to be made by a single co-chair, given that the co-chair not in attendance appeared to be in strong opposition. Further they requested that, given that there was no urgency on this issue, the topic should be carried over to the May 2025 meeting of the WRC for further vetting with both co-chairs present and all interested and impacted stakeholders in attendance. CBH was signatory to a letter from the CHCC requesting that the FGC reject the proposal that C.C.R. § 472 be amended to remove coyotes. Ultimately, the issue was referred back to the WRC. Prior to the May WRC meeting, FGC Executive Director issued the following public statement: *“The California Fish and Game Commission is aware of concerns regarding an agenda item before the Commission’s Wildlife Resources Committee (WRC) on May 15, 2025, related to coyotes. The goal of this agenda item is to ensure greater understanding of the existing laws, regulations and policies governing coyote management, and the needs of the various communities, from cities to rural communities and individual homeowners to ranchers. WRC will define what problem(s) exists within existing regulations, and will identify and discuss potential next steps. To be clear, the take of nongame species — of which coyote is just one — has been a WRC discussion topic for two years. WRC is not proposing new regulations related to coyote depredation. WRC is also not proposing to reclassify coyotes as a game species. WRC is seeking to engage stakeholders and the public in constructive information-sharing and creative problem-solving.”* Needless to say, the May WRC meeting drew significant interest, with ~80 people attending in person including Chriss Bowles (CBH) and Bill Gaines, and over 500 online (including me). The FGC staff presented background information on coyote regulations ([here](#)) and outlined the perceived problems or lack of clarity in the current regulations. Specifically, staff indicated that there is “unlimited

indiscriminate take of coyotes” resulting from 1) Section 4152: Depredation allows for take of nongame mammals “found to be injuring” growing crops or property and suggested that this language needs to be more clear and specific; and 2) Tenet 4 of the North American Model of Conservation states that wildlife should only be killed for a legitimate purpose and that Title 14, Section 472 permits all coyote killing, with or without legitimate purpose. The ask and stated goal of the WC meeting was then to “define the problem” and leverage future meetings to identify solutions. What ensued was an exhausting **five hours of discussion on the topic** - including our testimony, and that of another ~120 other elected officials, law enforcement agencies, organizations, and individuals on both the sides of the issue. Elected officials and law enforcement were provided the first opportunity to speak and unanimously repeated that there IS NO PROBLEM, current regulations are working, and coyotes are abundant! I also appreciated CDFW Deputy Director Chad Dibble weighing in to note that 1) calls to CDFW regarding negative human/coyote interactions are high and continue to rise particularly in urban areas, 2) 300K sheep, cows, and goat are killed by coyotes each year, 3) the Fish and Game Code definition of “take” includes a LOT of activities and that co-existence and hazing meets that definition. Are stakeholders asking CDFW to issue permits for these activities also? It’s obvious that CDFW does not have the time or resources to support the proposed changes to regulations. Mix in the usual anti-hunting and trapping rhetoric, anecdotal stories, and in the end, Commission co-chairs Anderson and Zavaleta agreed to hold the topic in WRC for further discussion and NOT send it up to the full FGC for consideration at this time. **This issue is not dead.** The topic remains with the WRC for now and is subject to further discussion and possible action in the future.

Finally, stay tuned for our flyer and registration for the **State Unmarked 3D Championship!** This event will be held at **Cherry Valley Bowhunters** in Cherry Valley, CA on **November 2, 2025**. Cherry Valley Bowhunters maintains an outstanding range and we look forward to sharing it with you all at this event. Part of the registration fees and the annual Legislative Raffle held during the event will benefit the CBH Legislative Defense Fund. See you this fall!

Now, here’s a bit of my volunteer history. Back when Pete Budding was CBHSAA President, I served as an officer of the NorCal Region. Ted Fenner—the Northern Legislative Representative and California’s IBEP Chairman (just getting started under NFAA in the late ‘60s)—wanted to step down, because he was no longer teaching any classes. I kept asking Pete to appoint one of the Big Game Club members as IBEP Chairman so Bowhunter Ed classes would resume in California. Nothing happened, so I finally told Pete I’d take the job myself. In 1980, at the CBH annual meeting, President Pete appointed me as IBEP California Chairman. There was a need, and I stepped up. I didn’t need another responsibility—Joan and I were already raising six children in our blended family, much like raising three sets of twins. The three boys played Little League every year, and I raked countless ballfields while Joan attended Jobs Daughters’ meetings with all three daughters. Joan loved sewing and baking; besides our family’s needs, she made clothes and specialty cakes for friends. I was active as a volunteer officer on many committees, and Joan helped teach classes as an IBEP Instructor.

So please—don’t tell me or CBHSAA that you’re “too busy” to protect our outdoor recreation for future generations who want to enjoy nature and the outdoors with their families.

From the moment I accepted the Chairman’s appointment, I began organizing and teaching classes. I studied and learned how to organize instructors statewide. Over the next 12 years, we taught countless classes. Joan and I even attended National IBEP Directors & State Chairman meetings, learning more about the program each year.

Over the years, CBH has presented Joan and me with many awards and honors, plus Fish & Game Hunter Education recognitions. Because I love archery and the outdoors, I didn’t feel like I earned the recognition because it never felt like work, but I’m grateful to be recognised.

Thank you, CBHSAA, for allowing me to give myself to archery and bowhunting’s future for the past 70 years. I enjoy every day our Lord Jesus gives me.

The photo I’ve included (on page 24) is from the 2014 Annual banquet. I believe it was one of the last presentations my friend Pete Budding ever made at the banquet. While he was reading through the resume of honors and accomplishments of the person he was awarding, I was shocked when he announced my name to receive the CBHSAA Medal of Honor award. I thought I’d already received every honor possible. I walked forward with Joan, hand in hand, as she’s earned as much of that award as I have. The award was established in 1968; only Lynn Gardner and I have ever received it. I thank all the CBH Directors, Officers, including not just the board members, but all members, including every lady in attendance, because our future needs each of you enjoying the flight of your arrow, just as I do mine.

Have you thought about trading some of your valuable time for helping your archery community? Volunteering isn’t just nice—it’s essential.
